## **Appearances:**

Julie Underwood, City Manager, City of Mercer Island Light Rail Station/I-90 Update:

An Tootill introduced City Manager, Julie Underwood, to the Arts Council. Ms. Underwood offered a brief update on who she is and where she came from prior to recently becoming Mercer Island's City Manager.

The purpose for attending tonight's meeting is to give an update on where the city is with regard to Light Rail. Manager Underwood stated that this is the City Council's top goal and is number one on their work plan. She reported that on June 3, the I-90 Center Roadway Express Lanes are scheduled to be closed permanently so that Sound Transit can begin construction of the East Link light rail project. As part of the upcoming changes, WSDOT plans to restrict the Island Crest Way entrance to westbound I-90 to HOVs only, also starting June 3.

Meanwhile, As soon as next week, Mercer Island drivers will begin to see temporary traffic improvement measures near I-90 in various locations. These are overseen by Sound Transit to help control the flow of vehicles once light rail construction begins.

- Most notable will be the addition of temporary traffic signals along North Mercer Way at the intersections of 76th Avenue SE and 77th Avenue SE
- Three additional WSDOT traffic cameras will be installed to help adjust traffic flows
- More left-turn queueing space will be striped onto Island Crest Way at North Mercer Way
- A bus-only bypass will be striped at the 76th Avenue SE westbound on-ramp
- WSDOT will also do some preparation work for a possible future alternating, 2-lane metered entrance at the West Mercer Way on-ramp (i.e. removing today's HOV bypass)

Manager Underwood stated that the city has sued WSDOT and Sound Transit, but they aren't getting what they wanted. The city does not have unlimited resources, and it may be time to settle. Hopefully, a solution can be mediated that Mercer Island can live with. She said

temporary short term parking is being addressed by the city right now, but long term parking is still being discussed and negotiated.

Arts Council members expressed their displeasure with the Sepa Amendment to the (Sound Transit) East Link Extension announcing the 80<sup>th</sup> Street configuration option for a bus turn around. Julie suggested that a letter from the Arts Council to the City Council expressing their preference is to use the 77<sup>th</sup> Street option vs 80<sup>th</sup> Street and their reasoning behind it. She said that the Sound Transit preference is for the 80<sup>th</sup> option.

# **Approval of Minutes:**

Joy Langley made a spelling correction to the April 2017 Regular Arts Council meeting minutes. Under Community Relations Chair report, page 1, correct the spelling for King County Council Members Dave Upthegrove and Rod Dembowski. Joy Langley made a motion to accept minutes as amended. The motion was seconded and passed unanimously.

The district Reflections team has indicated an interest in displaying student entries or award winners in the gallery. She felt it would be nice to have some community recognition. Amy and Erin will talk about the details, and if it seems viable, consider openings in 2018 since the gallery is booked through the end of 2017.

# **Outdoor Gallery**

Angelina Odievich

Angelina presented an image map showing the location of current sculptures and open spots in the gallery. Kai stated that Ingrid Lahti is willing and ready to install, but first Shawn Johnson will need to be contacted to see if she is okay to move her piece back to the walking path. Ingrid's sculpture can then be placed in that spot. Shawn's contract is almost up, so she can be given a choice between removing it or having us relocate her sculpture. If moved, it will need to be bolted in. Angelina will contact Shawn Johnson to get the ball rolling.

#### General:

Angelina Odievich gave a brief update on what she has learned about the MICA posters in Mercerdale Park. Her contact at MICA said that the fire lane depicted is only one option to a city requirement for a fire lane. It is pretty much up in the air and not even close to being finalized. Additionally, the mosquito pond they referenced is an underground cistern with grass growing on top of it, so not an issue.

Joy Langley reported that the Cultural Access WA bill passed and should be on the ballot in August.

Joy reported that MIPA will be going with a natural theme for the playground at the south end ball fields. The ground breaking is planned for August, so she should be able to bring the design to the next meeting and know if there is room for Arts Council sponsorship.

Joy and Erin will continue work on a draft letter stating the Arts Council's view on the proposed downtown bus turn-around as discussed at previously. They will bring it to the next meeting for review.

Kai reported on upcoming improvements to the Arts Council web presence. The left link has moved from being a sub-link under Parks & Recreation to being a stand-alone button link at the top left on the Parks & Recreation home page. Hopefully, this will make it easier to find the Arts Council and their programs on the website.

Kai reported that a pre art plan for the West Mercer Mural was submitted to WSDOT for their review, and it sounds like it shouldn't be an issue with it. A Call for Artists will be going out later this month. An and Kai will be working on assembling a selection committee in accordance with the bylaws.
