

RECEPTION

The City Council hosted a community reception honoring Representative Judy Clibborn on the eve of her retirement from public service.

CALL TO ORDER & ROLL CALL

Mayor Debbie Bertlin called the meeting to order at 6:30 pm in the Council Chambers of City Hall, 9611 SE 36th Street, Mercer Island, Washington.

Mayor Debbie Bertlin, Deputy Mayor Salim Nice, and Councilmembers Bruce Bassett, Wendy Weiker, and Benson Wong were present. Councilmember David Wisenteiner was absent. Position #4 was vacant.

STUDY SESSION

AB 5504: Legislative Priorities Review with 41st Legislative District Delegation

Mayor Bertlin welcomed Representative Tana Senn and Senator Lisa Wellman from the 41st Legislative District Delegation. She noted that Representative-Elect My-Linh Thai was unable to attend, and that retiring Representative Judy Clibborn elected not to attend.

Representative Senn and Senator Wellman spoke to the Council about the upcoming legislative session and noted the issues they would focus on, including: mental health, affordable housing, homelessness, special education, school safety, early learning, condominium liability reform, allowing state patrol to destroy confiscated weapons, mental health counseling in schools, home visits for every newborn born in the state, the environment, climate change, property tax adjustments for seniors and the disabled, revenue readjustment, and women's health.

Mayor Bertlin reviewed the City's legislative priorities for 2019:

- 1. Improving I-90 Access
- 2. Providing Local Funding Options
- 3. Preserving and Protecting Regional Parks
- 4. Protecting Our Health
- 5. Protecting Our Seniors, Veterans, and Disabled Residents
- 6. Preserving and Protecting the Environment

Mayor Bertlin noted that in relation to Priority 3, the City would like the \$2 million for Parcel 12 returned to the City to be incorporated into Aubrey Davis Park. Senator Wellman encouraged the City to submit the 2019 Senate Democratic Caucus Member Requested Local Community Project Information Form to request the funding.

APPEARANCES (FIRST ROUND)

Ira Appelman, 9039 East Shorewood Drive, stated that (1) Tully's is a good site for MICA, but is against vibrancy; (2) given that the Island voted against Proposition 1, Council should reject its 1% property tax (plus new construction) as a priority, and (3) he does not agree with celebrating Judy Clibborn's career.

Nancy Hewitt-Spaeth, 8320 SE 34th Street, thanked the Council for their support of MICA.

REGULAR BUSINESS

AB 5499: Review Two Finalists for Proposed Commuter Parking & Mixed-Use Project RFQ

City Manager Julie Underwood provided background information regarding the proposed project, its funding, and the RFQ process. She introduced the two final development teams for the Mercer Island Commuter Parking & Town Center Mixed-Use Project RFQ: Shelter Holdings / Weinstein A+U and Mainstreet Property Group, LLC. Both groups presented their responses to the RFQ. Mayor Bertlin reminded the Council and the community that no decision would be made this evening.

Mayor Bertlin noted that Council questions of the development teams would occur after the second round of Appearances.

- Which firm is better suited?
- Which project is better suited for funding for MICA?
- Would you be willing to finance MICA?
- How many parking spots and what are the criteria?
- How would shared parking work?
- What's the unknown that makes your firm nervous?
- Is the design flexible?
- What assurances does the City have that the project will get done? Will there be a performance bond?

- What is the long-term vision for the project?
- What is the impact on Gretta Hackett sculpture garden?
- How do you envision bringing more energy to that part of the Town Center.

In conclusion, City Manager Underwood requested that Council submit additional questions to her by Friday, November 29, to be forwarded to both teams for response.
