#### SUMMARY

#### Background

The City has been working with Sound Transit for a number years to identify options for new commuter parking in the vicinity of the future East Link Light Rail station. During this time, the City had moved far along in an agreement to develop new parking at the Town Center Walgreen's site but that deal ultimately fell apart between the landowner and developer. The City has also analyzed the viability of developing parking at a number of other Town Center locations. To date, those sites have not proven feasible. The City has also sought Mercer Island resident only parking in the existing Sound Transit Park and Ride lot but Sound Transit has rejected that approach citing legal and policy constraints.

In the course of the parking development discussions, Sound Transit also proposed creating a bus and light rail integration ("Bus Integration") on Mercer Island. Under the proposed Bus Integration, after East Link Light Rail operations begin, many I-90 bus routes would turn around on Mercer Island instead of continuing to Seattle and turning around there. This would allow bus service to be integrated with East Link, with passengers transferring between bus, and Light Rail on the Island rather than in Seattle.

Sound Transit provided Council with a Bus Integration and parking solutions status report at the August 4 Council meeting. At that time Council expressed concerns regarding community impacts with two proposed bus integration alternatives containing roundabout options. Sound Transit will be presenting a new Bus Integration alternative, as well as proposed parking solutions at the December 1 Study Session (Exhibit 1).

#### **Bus Integration Study**

Sound Transit is using the same Bus Integration study to analyze the new Bus Integration proposal and the resulting impacts to the community.

According to the Study, the number of buses traveling onto the Island is currently 350 per day. If the Bus Intercept is not implemented, this would drop to 200 buses per day (many bus routes are being eliminated once East Link begins operations). If the Bus Integration were implemented, the Study indicates that 340 buses would travel onto the Island each day.

Four scenarios for routing buses on the Island were developed and evaluated as part of the original Study. A fifth scenario will be presented and is shown as Exhibit 1. The previous scenarios presented a variety of concerns including infringing on the Sculpture Park property, the taking of private homes to accommodate bus turnarounds, impacts to the Town Center, and increased traffic congestion. The new 80th Avenue SE scenario consists of a transit facility on the existing 80th Avenue SE bridge structure, which is separate from general purpose traffic. Buses would access the transit center via the I-90 Ramps, by crossing 80th Avenue SE. The majority of buses would remain within this facility as they operate on the Island, thereby minimizing transit circulation on adjacent Mercer Island Town Center streets. The Council has not yet taken a position on any specific scenario.

#### **Council and Public Briefings**

Sound Transit provided public briefings on the proposed Bus Integration at Council Study Sessions on January 21, June 16, and again on August 4 of this year. Sound Transit also held an open house at the Mercer Island Community and Event Center on July 10 at which it presented the Bus Integration Study to the public for feedback, and a recent open house on November 19 at which it presented the new Bus Integration scenario and proposed Mercer Island Community and Event Center (MICEC) commuter parking options.

Council previously discussed the Bus Integration concept at its January 24 Planning Session. Council expressed significant concern about the concept and its impacts on the community. The Council concluded that unless Sound Transit provides dedicated parking for Mercer Island residents, the City would not even consider supporting the Bus Integration.

#### Parking Proposal

After a number of other parking options failed to prove viable, Sound Transit is currently analyzing the feasibility of developing new commuter parking at the Mercer Island Community and Event Center. Sound Transit will be presenting its initial review of this option at the December 1 Study Session.

As was discussed at the August 4 Council presentation, Sound Transit has contracted with a consultant to analyze building this additional parking (at Sound Transit expense). Under this concept, the new parking would be available for all transit users in the near term while the South Bellevue Park and Ride lot is closed for construction. The additional parking would then convert to City control (allowing for Island resident only parking, etc.).


#### **Next Steps**





#### **Overview**

The intent of this study is to identify preferred parking expansion alternatives at the existing Mercer Island Community & Event Center (MICEC), and to inform Sound Transit as they prepare to administer a design and construction effort for this project.

Sound Transit and Huitt-Zollars provided eight parking expansion concepts to the City of Mercer Island on September 24, 2014 and requested guidance on preferred alternatives. The City and Sound Transit met on October 2 and on October 22 to identify the preferred alternatives. This study represents the two preferred alternatives that have been modeled on the following guidance principles:

- Provide separate and distinct entrances for Transit parking and MICEC parking
- Provide uninterrupted vehicle drop off at the front of the MICEC
- Minimize disruption to the MICEC during construction and once the parking facility is operational

The two preferred parking alternatives are summarized in the table below:

This study is supported further by a Technical Summary Memorandum and Design-Build Delivery Schedule.

### Vicinity Map





#### Alternative 1 Narrative (Structured Parking)

The new three level open Parking Structure in Alternative 1 will be located at the existing hill at the northwest corner of the site. The location will have minimum disruption to the existing surface parking lot and the MICEC. Access to the new Parking Structure will be from a new driveway that connects the lower existing parking lot at the south side to a higher grade of the new Parking Structure. Entrance to the new driveway is placed as far as possible from the existing drop off and accessible parking stalls to minimize impact to the existing parking for the MICEC. The van accessible parking spaces, which often require higher vertical clearance, are located outside the Parking Structure to keep the 10 ft floor to floor height for all levels in the new structure. The top of the parking surface will be at elevation 156 ft, which is approximately 4 ft below the top of the current existing hill. The top of the staircase and elevator towers will be at elevation 166 ft. Because the Parking Structure is multi-level, it will make the smallest footprint on the site, leaving a wider open space between the Parking Structure and the existing MICEC. New pedestrian walkway is provided to connect the new Parking Structure to SE 24<sup>th</sup> Street. We propose to use similar exterior materials used on the existing MICEC building for the new Parking Structure as shown on the attached exterior elevations drawings. Reference the Structural Narrative for additional comments about the impact of the Parking Structure to the existing condition. Number of parking stalls for Alternative 1 is approximately 229. There will be 6 existing parking stalls demolished for the new driveway, and 5 existing parking stalls converted to 4 accessible parking stalls. The total combined parking spaces between the new Parking Structure and existing MICEC parking is 442.





#### Alternative 2 Narrative (Surface Parking)

Alternative 2 is a surface parking layout that generally maximizes parking stalls in the area of the existing hill. This alternative provides separate and distinct entrances for Transit parking and MICEC parking, including separate entrances from SE 24<sup>th</sup> Street. The existing parking lot will be separated into two lots, the west lot will be designated for Transit parking and the east lot will be designated for MICEC parking. The Transit parking area will be made up of the existing west lot circulating into the new west aisle parking area. The MICEC parking area will be made up of the existing east lot circulating into the new east aisles parking area. Parking separation is achieved by placement of removable bollards in the existing parking lot and in the new parking lot. Bollards may be removed to provide full circulation between parking lots. Access locations to the new parking lot are positioned to not interrupt the existing drop off area. Minor reconfiguration of the existing parking lot will be needed to provide flow through vehicle circulation for both Transit parking and MICEC parking.

The new parking configuration allows for two way traffic aisles and 90 degree parking on each side with the exception of few parallel parking stalls. Grades will generally not exceed 5% slope in areas of parking. A drive ramp (approximately 12%) is provided between the west parking aisle and the vehicle access to accommodate the elevation difference.


A pedestrian walkway will be provided from the new parking lot and connect to SE 24<sup>th</sup> Street. The existing path that leads to the p-patch will be relocated around the parking lot. A p-patch load area is included in the new parking lot to provide opportunities for the loading and unloading of materials to serve the p-patch. A combination of cut retaining wall and catch grading (2H: 1V) will likely be needed at the west side of the parking lot. Landscape screening may be used to screen the parking lot from the adjacent residences to the west. Catch grading appears to be feasible along the north and east side of the new parking lot.

Alternative 2 will yield approximately 203 Transit parking stalls and 224 MICEC parking stalls. The total combined parking spaces between the new surface parking and existing MICEC parking is 427 (including motorcycle/scooter parking).

The Huitt-Zollars team also looked at providing some compact width stalls to increase the parking stall count. This Alternative 2 (Compact) will yield approximately 207 Transit parking stalls and 228 MICEC parking stalls. The total combined parking spaces between the new surface parking and existing MICEC parking is 435 (including motorcycle/scooter parking). The Alternative 2 (Compact) layout is included as the last page of the Alternative 2 Drawings.



NEW CATCH BASIN X137' PROPOSED GRADE - NEW STORM WATER PIPE









### **Technical Summary Memorandum**

#### Survey, Easements and Right-of-Way

- Existing grade contours shown are based on 100% CD drawings from the MICEC project with the exception of the 162' and 164' contours at the top of the hill. It was indicated during discussion with the City of Mercer Island that this mound (approximately 4') at the top of the hill was shaved down at the request of adjacent neighbors. Parking layouts will likely need to be modified once actual topographic information is obtained.
- 2. Property Description:

"THE SOUTH 768.32 FEET OF THE EAST 524 FEET OF GOVEERNMENT LOT 1, SECTION 1, TOWNSHIP 24 N, RANGE 4 E, W.M.; EXCEPT THE SOUTH 30 FEET THEREOF (SE 24TH ST); EXCEPT THE EAST 30 FEET THEREOF (VACATED 84THAVE SE)."

The property is bounded by SE 24th St on the south, by vacated 84th Ave SE on the east, by Luther Burbank Park on the north, and by Block 18, Plat of Mercer Park, and Plat of Mercer Beach Park on the west.

There appears to be no issues to calculate and field locate the property lines. According to survey records, there are enough monuments and data to locate the boundary. (Note: This assumption is made without a current title report or field inspection.)

3. Easements:

According to Warranty Deed (Rec. No. 20030717001793) there appear to be two easements affecting the property:

- Rec. No. 4655713 for Sewer Line on the westerly portion of the property (no description available on-line) Note: Mercer Island GIS shows a sewer line in the south half of the property along the westerly property line (from SE 24th St); there is also an approximately 100 feet sewer stub at the northerly portion along the westerly line (coming for the north).
- b. Rec. No. 6348106 for Air Vent Line with all Connections, Manholes and Appurtenances at the westerly portion within a strip of 10 feet in width. Note: exact location not identified (no description available on-line).

Note: Full easement descriptions and other easements not listed above might be contained in a Title Report. Further investigation of the Title Report and other record documents may identify constraints that could impact the parking alternatives.

Also the GIS image shows sewer, storm and water lines and structures at the easterly and northerly portion; and a path leading from the existing parking lot to the northerly property line and to the Luther Burbank Park.

#### Stormwater Quality and Quantity

1. Existing Drainage Conditions

The proposed parking area, in both alternatives, currently drains to an 8-inch on-site storm drain system. This system drains to the east, where it discharges into a 12-inch CMI storm drain flowing north along 84<sup>th</sup> Avenue SE. This system eventually discharges to a small stream that flows into Lake Washington near Calkins Point. This stream is identified as "potential fish use" in the Inventoried Watercourse And/or Streams on Mercer Island.

- 2. Assumptions
  - a. Jurisdiction is City of Mercer Island
  - b. Code Requirements: City has adopted DOE Stormwater Manual for Western Washington: flow control and basic water guality treatment
  - c. Site drains directly to Lake Washington via open ditches and buried storm drain pipes
    - i. Flow control assumed to be needed
  - d. Site area to be developed not feasible for infiltration per City LID feasibility mapping; and not feasible for dispersion based on site conditions (LID does not appear to be feasible).
- 3. Conceptual Storm Water Solution:

Flow control and water quality will be provided by a combined underground wet vault/ flow control vault. This solution appears most compatible with available land and site topography. Preliminary sizing presented below is based on modeling using the Western Washington Hydrology Model, Version 4, with site areas estimated from the attached drawings for Alternative 1 and 2. The sizing below is based on flow duration control modeling. If it is determined that peak matching flow control modeling is acceptable then the size of the flow control facility will likely be reduced.

Table 1 summarizes conceptual vault sizing for the alternatives.

#### Architectural and Landscaping

#### Alternative 1 - Architectural and Landscaping

- 1. Assumptions
  - a. New structure's height shall be generally below the existing grades as to not block views from the houses to the West. If elevator and/or stair tower is included in the project, then there may be partial view impacts that are at an elevation above the existing grade.
  - b. An Elevator is shown in the drawings and described in the narratives. Elevators are common elements for parking garages but do not appear to be required by code for this project. An elevator could be an optional item which needs further discussion.
  - c. A shading study has not been completed for the parking garage. If elevator and/or stair tower are included in this project then there may be potential for changes to existing shade patterns during certain times of year and day.
  - d. New parking will be north of the site while the existing parking for the MICEC will remain on the south side.
  - e. The existing hill area may be used for the structure.
  - f. Use contour lines shown in the 100% Construction Document set of the MICEC.
  - g. May not disturb the existing p-patch to the north.
  - h. Pedestrian path can be constructed along the west of the existing parking lot connecting the new structured parking to NE 24th St.
  - i. NE 24th St can accommodate additional traffic brought by the new parking structure.
  - j. Minimize impact to west neighbors and MICEC
  - k. Dry pipe sprinkler system
- 2. Code Requirements
  - a. Current Mercer Island Municipal Code.
  - b. Current International Building Code as adopted by City of Mercer Island.
  - c. Current International Fire Code as adopted by City of Mercer Island.
  - d. Current Uniform Plumbing Code as adopted by City of Mercer Island.
  - e. Current Washington Cities Electrical Code as adopted by City of Mercer Island.
- 3. Constructability Issues

- a. Unforeseeable underground condition during excavation.
- b. Noise, vibration, and potential soil settlement impact to the houses on the west from soil excavation.
- c. Sidewalk connection to SE 24<sup>th</sup> Street may be challenging due to limited space between the existing parking and the adjacent property line.
- 4. Conceptual Architectural and Landscaping Solution
  - a. Structure will be located in the existing hill area at the northwest corner of the site where there is enough space to accommodate the required number of parking spaces.
  - b. Minimize disruption to the existing south parking lot.
  - c. Locate access to the new Parking Structure as far as possible from the MICEC to improve clear distinction between two different uses.
  - d. Work with existing grade to maintain a low non-intrusive structure to the neighboring houses on the west, while at the same time minimizing costly excavation and high retaining wall.
  - e. Maximize open space between the existing MICEC Building and the new Parking Structure.
  - f. Single Threaded Helix with One Level Bay parking design provides repetitive, easy to understand for drivers and better visibility across the structure which then improve safety/security.
  - g. 90 degree parking stall with 2-way driveway provides the most efficient parking layout.
  - Staircases and elevator are located on the level part for ease of use and construction, and at corners where these spaces are non-usable as parking spaces, hence improve efficiency.
  - i. The new structure shares similar contextual design with the existing Community Center.
  - j. Provide potential landscape screening

#### Alternative 2 - Architectural and Landscaping

- 1. Assumptions
  - a. Same assumptions as listed in Alternative 1 except this will be a surface parking instead of a parking structure.

- b. Sound Transit commuters will be generally on the West side of the site, and parking for the MICEC will be generally on the East side.
- c. Some impact to the existing MICEC parking lot will be allowed.
- d. A sidewalk can be constructed along the west side of the parking lot by the west property line
- 2. Code Requirements
  - a. Current Mercer Island Municipal Code
  - b. Current Washington Cities Electrical Code as adopted by City of Mercer Island.
- 3. Constructability Issues
  - a. Unforeseeable underground condition during excavation.
  - b. Noise and vibration impact to the houses on the west from soil excavation.
  - c. Retaining wall on the west side (cut) and south side (fill).
  - d. Sidewalk connection to SE 24<sup>th</sup> Street may be challenging due to limited space between the existing parking and the adjacent property line.
- 4. Conceptual Architectural and Landscaping Solution
  - a. Generally maximizes surface parking at the existing hill.
  - b. Completely separate and distinct entrance from NE 24th St for the new Sound Transit Parking. Sound Transit parking entrance at the west and MICEC parking at the east.
  - c. Ability to combine the Sound Transit parking with the MICEC parking into one lot in the future. Also may combine parking areas in the interim with use of removable bollards.
  - d. Preserve most of the existing accessible parking stalls and drop-off area at the MICEC.
  - e. Allow enough space on the west property line to minimize high retaining wall.
  - f. Use wall in combination with 2:1 catch slopes.
  - g. Parking stalls are oriented 90 degree with 2-way driveway for efficiency.
  - h. Provide landscaping in planter areas between parking rows and potential screening around perimeter of parking lot.
  - i. Provide measures to reduce the impacts of headlight glare.

#### Structural

#### Alternative 1 – Structural

1. Assumptions

Based on information provided by the City, the top of existing grade at the northwest corner of the property is located at approximately elevation 160. From there the grade slopes down to the south and east. According to available geotechnical information, the top 25 feet of soil consists largely of fill with competent soil located below elevation 135. The maximum allowable temporary slope is 1.5:1 and the maximum permanent slope is 2:1. It is assumed permanent easements outside of the MICEC property will not be permitted. Therefore, soldier pile walls with permanent tie backs extending outside property lines are not feasible. In addition, soil nail walls are not recommended due to their ineffectiveness in the loose fill material.

2. Code Requirements

Structural Design of the parking structure and retaining walls will be governed by the current City of Mercer Island Municipal Code and the International Building Code as adopted by the City.

3. Conceptual Structural Solution and Constructability

Alternative 1 is a three-level parking structure with some exterior surface parking stalls. The parking structure could be constructed with either precast elements and/or cast-inplace concrete, with slabs and beams supported on columns. It is 280 feet long along the north-south axis and 115 feet wide. Vehicles enter the south end of the ramp at elevation 136. The floor to floor height of the ramp is 10 feet and the upper level elevation is 156. The top elevation is slightly lower than the approximate existing ground elevation of 160 to minimize visual impact to residences behind the west property line. Since the majority of the parking ramp is below existing grade retaining walls are required along both the west and a portion of the north side of the structure. Existing ground along the south and east sides of the structure can be permanently removed to minimize or eliminate retaining walls.

Cost savings can be achieved by limiting the height of the retaining walls. While it is preferable to locate the structure away from the MICEC on the east, this needs to be

balanced by maintaining sufficient distance from the west property line to minimize retaining wall height. Alternative 1 places the west side of the ramp 30 feet from the property line. The first 5 feet from the line is level while the remaining 25 feet to the parking structure wall slopes down at a 2:1 slope. The slope intersects the ramp structure at approximately elevation 148 which is near the lowest level on the west side of the ramp (elevation 146). As a result only a short retaining wall is required. Lowering the finished ground line along the west side of the structure exposes approximately 8 feet of the parking structure. However, landscaping can help mitigate the visual impact of the exposed surface. For safety, a barrier or rail along the upper perimeter of the parking structure will be required.

The base elevation for the west side of the ramp is 146, approximately 10 feet above competent soil. Since the overlying fill lacks bearing capacity spread footing foundations would need to be located below elevation 135. This would require substantial excavation and tall temporary shoring walls. Instead, drilled shafts foundations extending below elevation 135 can be used to support the parking structure. The shafts would be 3 or 4 feet in diameter and space approximately 10 feet on center. A short temporary wall located 4 feet from the edge of the parking structure would be required to construct the shafts. A cantilevered soldier pile wall is feasible for the temporary wall. To minimize wall height a temporary 1.5:1 slope from the property line could be used.

Portions of the ramp structure will consist of slab on grade. Since the soil above elevation 135 consists largely of fill, slabs above this level may require ground improvements or over excavation to support the slab. Possible ground improvements could include stone columns, preloading, or deep soil mixing. Over excavation would require substantial temporary retaining walls along the west and north sides of the parking structure.

#### Alternative 2 - Structural

1. Assumptions

Based on information provided by the City, the top of existing grade at the northwest corner of the property is located at approximately elevation 160. From there the grade slopes down to the south and east. According to available geotechnical information, the top 25 feet of soil consists largely of fill with competent soil located below elevation 135.

The maximum allowable temporary slope is 1.5:1 and the maximum permanent slope is 2:1. It is assumed permanent easements outside of the MICEC property will not be permitted. Therefore, soldier pile walls with permanent tie backs extending outside property lines are not feasible. In addition, soil nail walls are not recommended due to their ineffectiveness in the loose fill material.

2. Code Requirements

Structural Design of the parking structure and retaining walls will be governed by the current City of Mercer Island Municipal Code and the International Building Code as adopted by the City.

3. Conceptual Structural Solution & Constructability

Alternative 2 is a 2-tiered surface parking lot. It is located approximately 40 feet from the west property line and 15 feet from the north property line. The three main parking rows are aligned north-south, although the southern portion of the parking lot follows the curve along the northern edge of the existing surface parking. Parking elevations vary from approximately 123 on the southeast corner to 143 at the northwest corner.

As noted above the top existing grade elevation at the northwest portion of the property is approximately 160. Since the west edge of the parking lot varies in elevation from 140 to 135 a retaining wall will likely be required. To minimize wall height the finished ground line from the west property lines can be graded at a 2:1 slope. The first 5 feet from the property line will remain level to minimize disturbance to the existing property owners. The remaining 30 feet slopes down to the edge of parking walkway. At a 2:1 slope the grade drops approximately 15 feet which places the catch point at about elevation 145. This is close to the parking surface elevation. However, a cut wall will likely be required to provide a drainage ditch and prevent runoff onto the parking ramp. Since the wall is relatively short a cantilevered soldier pile wall is feasible. Alternatively, an MSE wall may be suitable.

Since the soil above elevation 135 is primarily fill, parking surface elevations above this level may require some over excavation and replacement with structural fill. Note that over excavation may require temporary retaining walls along the west and north sides of the surface lot.

#### Geotechnical

#### Alternative 1 - Geotechnical

- 1. Assumptions
  - Design and construction considerations will be developed based on adequate geotechnical site explorations and laboratory tests to characterize existing soil and groundwater conditions.
  - b. The construction area will be adequately set back from the property boundary lines to minimize impacts and disturbances to adjacent properties.
  - c. Temporary open cuts at 1.5H:1V slope for excavations less than 20 feet deep will be possible in the existing fill stockpile area where the parking structure will be located.
  - d. Temporary support of vertical excavations and permanent retaining walls exceeding about 10 feet are not expected.
- 2. Code Requirement

We understand that the design of the parking structure will be based on the International Building Code (IBC 2012) with statewide and City of Mercer Island amendments as applicable.

- 3. Constructability Issues
  - a. The existing uncontrolled fill stockpile will be considered for the construction of the parking structure.
  - b. Removal and disposal of the surplus excavated soil will need to be considered.
  - c. The site soils are generally silty and would likely not be suitable for reuse as structural fill during wet weather construction.
  - d. Groundwater is not expected to be a significant issue during construction.
  - e. Required setback and slopes for the temporary open cut excavations should be assessed based on the results of geotechnical site explorations and laboratory testing.
- 4. Conceptual Geotechnical Solutions
  - a. Seismic design should include adequate considerations of the possible earthquake-induced geotechnical hazards applicable to the site.

- b. Adequate subgrade for pavement or slab-on-grade support will likely be available at or below elevation 135 feet, and over excavation and backfill with structural fill or other ground improvement will likely be necessary at higher elevations.
- c. Use of shallow footings to support column loads will likely be possible where the floor slab is planned at elevation 136 feet. Short drilled piers or auger-cast piles, and stone columns or other ground improvements may be used where the floor slab is planned at elevation 146 feet.
- d. Design and construction of retaining walls and permanent slopes should include static and seismic stability considerations based on the results of geotechnical site explorations and laboratory testing.
- e. If infiltration of surface runoff is planned, a site-specific assessment of the infiltration potential should be conducted.

#### Alternative 2 - Geotechnical

- 1. Assumptions
  - a. Design and construction considerations will be developed based on adequate geotechnical site exploration and laboratory tests to characterize existing soil and groundwater conditions.
  - b. The construction area will be adequately set back from the property boundary lines to minimize impacts and disturbances to adjacent properties.
  - c. Temporary open cuts at 1.5H: 1V slope for excavations less than 20 feet deep will be possible in the existing fill stockpile area where the surface parking will be located.
  - d. Temporary support of vertical excavations and permanent retaining walls exceeding about 10 feet are not expected.
- 2. Code Requirement

We understand that the design and construction of the surface parking will be based on the City of Mercer Island Code.

- 3. Constructability Issues
  - a. The existing uncontrolled fill stockpile will considered for the construction of the surface parking.
  - b. Removal and disposal of the surplus excavated soil will need to be considered.

- c. The site soils are generally silty and would likely not be suitable for reuse as structural fill during wet weather construction.
- d. Groundwater is not expected to be a significant issue during construction.
- e. Required setback and cut slopes for construction of the surface parking should be assessed based on the results of geotechnical site explorations and laboratory testing.
- 4. Conceptual Geotechnical Solutions
  - a. Seismic design should include adequate considerations of the possible earthquake-induced geotechnical hazards applicable to the site.
  - b. Adequate subgrade for the parking pavement support will likely be available at or below elevation 135 feet, and over excavation and backfill with structural fill or other ground improvement will likely be necessary at higher elevations.
  - c. Design and construction of retaining walls and permanent slopes should include static and seismic stability considerations based on the results of geotechnical site exploration and laboratory testing.
  - d. If infiltration of surface runoff is planned, a site-specific assessment of the infiltration potential should be conducted. Use of permeable pavement may be considered if feasible.

#### Wet Utilities

- 1. Existing Conditions
  - a. Water City of Mercer Island GIS Portal identifies an existing water main located in SE 24<sup>th</sup> Street and 84<sup>th</sup> Avenue SE. On-site fire hydrants are located at the main vehicle access at SE 24<sup>th</sup> Street, the vehicle drop off, and at the north east corner off the MICEC building.
  - Sewer City of Mercer Island GIS Portal identifies an existing sewer manhole and sewer main located adjacent to the west property line.

#### Alternative 1 – Wet Utilities

- 1. Assumptions
  - a. Water and Sewer utilities are available
- 2. Code Requirements
  - a. City of Mercer Island
- 3. Constructability
  - a. There may be trenching impacts for the water main extension
  - b. Depth of existing sewer main located adjacent to the west property line will need to be verified to determine if sewer connection can be made.
- 4. Conceptual Water and Sewer Solution
  - Provide sewer service for floor drains inside the parking garage and elevator pit. Sewer service to connect to existing sewer main located adjacent to west property line.
  - b. Provide a water main extension for new fire hydrant located near the parking garage.
  - c. Provide a domestic water service to serve the garage from existing water main. Domestic service to serve parking garage hose bibs.
  - d. Provide irrigation service connection to serve potential landscape screening.
     Irrigation service may potentially be connected to existing on-site irrigation system. Irrigation to provide appropriate cross-connection control.

#### Alternative 2– Wet Utilities

- 1. Assumptions
  - a. No sewer service is required
- 2. Code Requirements
  - a. City of Mercer Island
- 3. Constructability
  - a. There may be trenching impacts for the water main extension
- 4. Conceptual Water Solution
  - a. Provide a water main extension for new fire hydrants as required by Fire Marshall.
  - b. Provide irrigation service connection to serve planter islands and potential landscape screening around perimeter. Irrigation service may potentially be connected to existing on-site irrigation system. Irrigation to provide appropriate cross-connection control.

### **Electrical and Lighting**

1. Power Supply:

A site survey was conducted to determine the best and most economical means to provide power supply to the site. Electric power for the proposed project can be derived with two options. The first option is to connect directly to the existing utility power pole located at the south side of SE 24<sup>th</sup> Street. Underground primary cable will extend the utility power from the utility pole to a pad-mounted transformer located adjacent to the new electrical panel completed with utility metering. The second option is to connect the power through the existing MICEC electrical distribution system. The existing MICEC electrical service contains a 225 amperes rated spare breaker which can be utilized to serve the proposed parking addition.

2. Lighting:

The lighting system will be designed to continue the aesthetic appearance of the MICEC lighting element. The lighting level will be sufficient for pedestrian and vehicular safety. The site lighting will comply with the IESNA design standard for "Parking and Drive Aisles." Lighting fixtures will contain cut off shielding to limit the spread of emitted light to adjacent areas.

### Alternative 1 – Electrical and Lighting

- 1. Electrical Design Element:
  - a. Ceiling mounted LED type lighting fixture to illuminate parking structure.
  - b. Control system to integrate day lighting sensors and occupancy sensors to reduce energy cost.
  - c. 12 foot tall pole LED lights with full cut-off distribution pattern to illuminate exterior drive ways.
  - d. Fire alarm system with horn/strobe and connection to the elevator recall system.
  - e. Spare raceway for camera and Code Blue Station.
- 2. Estimated Electrical Load Requirement:
  - a. Lighting...16 KVA
  - b. Elevator...15 KVA

Total..... 31 KVA (37 amperes at 277/480 volt)

This option requires a complete electrical service panel and distribution system to support the elevator and parking structure lighting electrical load. A 100 ampere, 480/277 volt electrical service with spare capacity for future load additions (i.e. electrical car chargers) is recommended.

### Alternative 2 – Electrical and Lighting

- 1. Electrical Design Element:
  - a. 12 foot tall pole mounted lights with full cut-off LED type.
  - b. Spare conduit for camera and Code Blue Station.
- 2. Estimated Electrical Load Requirement:
  - a. (30) 12 foot tall pole mounted lights at 80 watt each (2400 watt, 5 ampere at 480 volt).

The proposed lighting addition can be connected to the existing MICEC exterior lighting circuit. Additional conductors can be installed through existing underground raceway and pull boxes for connection to the MICEC Exterior lighting control panel.

### **Delivery Schedule**

Using an acquisition strategy for design-build procurement for the project, the schedule identifies a start date for developing RFQ and RFP documents on 10/17/2014 (assuming this study is part of the procurement document development) which results in project acceptance on 1/26/2017. The development of these procurement documents would be a joint effort of Sound Transit and possible consultant.

The design-build procurement schedule is based on Huitt-Zollars' understanding of Sound Transit's design-build procurement process as used on S440, S445, MOW and E360, but simplified without inclusion of a Draft RFP release for industry review and reduced time periods for SOQ evaluations, interviews, one-on-one meetings, ATC reviews and such. We recommend that this procurement schedule be vetted through Sound Transit Contracts and others within DECM. We realize that this is an aggressive delivery schedule given the constraint of a first quarter 2017 delivery date for the project.

Note that parking garages for design-build procedure are allowed by RCW 39.10.300, so no Project Review Committee (PRC) application needs to be made and has not been included in the schedule. If the project is thought to only be provided by a surface parking solution, PRC approval would be required if a design-build procurement strategy is used. Should Sound Transit and Mercer Island decide that a surface parking solution without any garage is preferred, we would recommend that Sound Transit pursue a conventional design-build procurement approach.

Councilmembers Debbie Bertlin, Jane Brahm, Mike Cero, Tana Senn, Benson Wong, Deputy Mayor Dan Grausz, and Mayor Bruce Bassett were present.

#### APPEARANCES

- Joe Burcar, with the Department of Ecology, stated that Barbara Nightengale retired and that he would be taking over the City's Shoreline Master Program review. He noted that he is in attendance to provide support of the draft ordinance.
- Meg Lippert, 4052 94th Ave SE, thanked the Council for sending the letter to the KCLS Board of Trustees regarding putting the MI Library Remodel Project on hold. She hopes that the Board of Trustees will validate and accept the recommendations in the letter. She asked citizens to attend the KCLS Board of Trustees meeting on Wednesday, November 19 at the KCLS Service Center in Issaquah.
- Ira Appelman, 4436 Ferncroft Road, spoke about his suggestion at the last meeting that the governing bodies in Mercer Island establish a much closer relationship with the Mercer Island Library to support their policy considerations. He would like the City Council to pay much closer attention to ensuring public support for the library. He spoke about the celebrations of the 800<sup>th</sup> anniversary of the Magna Carta's sealing. He stated that during the Revolutionary War, the Magna Carta was cited as supporting "no taxation without representation." He stated that KCLS Board is appointed, not elected and once-appointed is unaccountable. KCLS imposes taxes without the approval of anyone. He further spoke about the Federal Way Council getting involved in the proposed move of the KCLS Federal Way library in 2006.

#### **REGULAR BUSINESS**

#### AB 5019 Revision to Shoreline Master Program Update (1st Reading)

Development Services Director Scott Greenberg presented an ordinance for first reading which amends the previously adopted code changes for the Shoreline Master Plan Update. He explained that over the course of seven months, City staff and Department of Ecology staff have discussed DOE's required changes to the previously adopted code changes and have come to agreement on all, but one issue (limiting dock width in the first 30 feet from Ordinary High Water Mark to 4 feet, with 5 feet allowed for community docks and single family docks, where ADA access is required). He presented a new approach to the issue using a menu of incentives to allow five-foot dock width.

The Council talked through each of the issues regarding the existing overwater structures, dock width, ADA compliance, and the proposed incentive table.

#### AB 5021 2015-2016 Preliminary Budget Review: Finalize Budget Changes and Adopt Tax and Fee Ordinances and Resolutions

Finance Director Chip Corder provided information to the Council in order to finalize changes to the 2015-2016 Preliminary Budget, as well as tax and fee ordinances and resolutions to be adopted.

Mayor Bassett opened the public hearing at 8:17 pm. There being no comments, the Mayor closed the hearing.

Director Corder reviewed changes to the General Fund & YFS Fund, Water Fund, Street Fund, and Capital Improvement Fund.

The Council discussed and agreed to adjust development and construction permit fees beginning 1/1/2015.

It was moved by Cero; seconded by Brahm to: Pass Resolution No. 1491, which adjusts development and construction permit fees effective January 1, 2015 and thereafter. Passed 6-1

The Council discussed and agreed to increase General Fund support of YFS fund from \$300K to \$350K (will be funded by property tax "new construction," which is greater than originally projected; also reduces 2016 projected deficit from -\$260K to -\$160K in the YFS fund)

Director Corder presented the costs for the action plan items from the recent Water Advisory Event. He proposed increasing the water utility revenues by an additional \$250K to \$550K to address the action plan items.

Utility Board Chair Ben Levy spoke to the Council about the Utility Board's review of the Water Advisory Event report from Confluence. He noted that the Utility Board spent time listening to Confluence's recommendations and unanimously endorsed the additional \$550K increase in water utility revenues to address the action plan items at their November 13, 2014 meeting.

Director Corder explained the impact of the proposed rate increases to the average single-family bi-monthly bill. The Council discussed and agreed to increase the water utility revenues by an additional \$250K to \$550K to address the action plan items.

It was moved by Brahm; seconded by Bertlin to:

Pass Resolution No. 1492 (alternate version), which establishes classifications of water users and a schedule of charges for water usage, a schedule of rates for fire service, a schedule of special service charges, meter and service installation charges, and connection charges effective January 1, 2015 and thereafter.

Passed 5-2 FOR: 5 (Wong, Bassett, Bertlin, Brahm, Senn) AGAINST: 2 (Cero, Grausz)

It was moved by Bertlin; seconded by Senn to:

Pass Resolution No. 1493, which establishes rates and connection charges for sewerage disposal services supplied by the City of Mercer Island effective January 1, 2015 and thereafter. Passed 7-0 FOR: 7 (Wong, Bassett, Bertlin, Brahm, Cero, Grausz, Senn)

It was moved by Bertlin; seconded by Brahm to:

Pass Resolution No. 1494, which establishes the bi-monthly service charge for storm and surface water services supplied by the City of Mercer Island effective January 1, 2015 and thereafter. Passed 7-0

FOR: 7 (Wong, Bassett, Bertlin, Brahm, Cero, Grausz, Senn)

It was moved by Bertlin; seconded by Wong to:

Pass Resolution No. 1495, which establishes the bi-monthly utility fee for the emergency medical and ambulance services supplied by the City of Mercer Island effective January 1, 2015 and thereafter. Passed 7-0

FOR: 7 (Wong, Bassett, Bertlin, Brahm, Cero, Grausz, Senn)

Director Corder presented using banked capacity for one or more of the following funding needs: YFS Fund deficit in 2016 (-\$160K), LEOFF I Long Term Care costs (funded thru 2028), Street Fund (\$150K per vear). Capital Improvement Fund (\$200-\$300K per year), MICEC technology & equipment (\$40K per year), Town Center improvements and/or economic development. He stated that Staff's recommendation is to use \$80K to eliminate YFS Fund deficit in 2016 and use \$65K to fund LEOFF I Long Term Care costs. The Council discussed and agreed to take the City's remaining banked capacity (\$144,960 - revised estimate), but wait until the 2015 Planning Session to determine its use.

It was moved by Bertlin; seconded by Brahm to: Adopt alternate Ordinance No. 14-13, which appropriates funds and fixes the amount of property taxes to be levied for the year 2015. Passed 6-1 FOR: 6 (Wong, Bassett, Bertlin, Brahm, Grausz, Senn) AGAINST: 1 (Cero)

It was moved by Brahm; seconded by Grausz to: Adopt alternate Ordinance No. 14-14, which identifies the dollar amount and percentage increases of the regular property tax levy and the levy lid lift for the year 2015. Passed 6-1 FOR: 6 (Wong, Bassett, Bertlin, Brahm, Grausz, Senn) AGAINST: 1 (Cero)

Director Corder asked for the Council's confirmation on staff's recommendation to move SE 40th Street Corridor (East of ICW) project from funded to unfunded status in 2018 (\$759K) to help balance Street Fund in 2015-2020. And he teed up the Mayor and Deputy Mayor's proposal to set aside \$150K (placeholder) per year for transit funding. Director Corder recommended that the Council make \$900K in project cuts or delays in the six-year plan if they added \$150K per year for transit funding in 2015-2020. Following discussion, the Council decided to move forward with both changes to the Street Fund, but no additional project cuts or delays were identified to try to balance the Street Fund beyond 2017.

Director Corder presented a change to the Capital Improvement Fund to create a dedicated Emergency Operations Center space at City Hall. Staff presented two options: (1) convert a 1,090 sf space for \$138K; or (2) convert and create 1,900 sf space for \$242K and identified \$129K in funding that could be re-directed to this project (\$38K in REET dedicated to Police Car Port, \$35K in Document Management project savings, \$26K in Financial System project savings, and \$30K in Luther Burbank Admin Building project savings). The Council agreed to move forward with Option 1 and the proposed funding sources.

Director Corder reviewed the alternate cuts and delays to reducing Open Space Vegetation Management by \$50K/year in 2015-2016 in the Capital Improvement Fund:

- Pushing \$32K in City Hall Repairs (exterior painting) from 2017 to 2018
- Pushing \$30K in North Fire Station Repairs (carpet) from 2017 to 2018
- Reducing North Fire Station Repairs (washers & dryers) by \$10K in 2017
- Funding \$25K of playground equipment in Mercerdale Park in 2018 with private contributions

The Council discussed the proposed cuts and delays and decided to restore \$25K/year to Open Space Vegetation Management in 2015-2016, thereby reducing the annual cut to \$25K per year. Director Corder also alerted the Council to the fact that the Capital Improvement Fund is projected to go significantly negative in 2017 unless: 1) additional project cuts or delays are made, or 2) the \$352K balance in the Capital Reserve Fund is transferred into the Capital Improvement Fund, assuming that staff doesn't need to use any portion of the \$352K balance for the Fire Station 92 Construction project. Staff will return to the Council with how the cuts will impact the Open Space Vegetation Management program.

#### **Councilmember Absences**

There were no absences.

#### **Planning Schedule**

City Manager Treat spoke about the upcoming open house on new commuter parking options at the Community Center from 5-7 pm and the KCLS Board of Trustees meeting at the Issaquah Service Center at 5:00 pm, both of which are on November 19.

#### **Board Appointments**

There were no appointments.

#### **Councilmember Reports**

Councilmember Wong spoke about the 18<sup>th</sup> Annual King County Mental Health and Substance Abuse Legislative Forum and the quarterly meeting of the Regional Transit-Oriented Advisory Council.

Councilmember Senn spoke about the Yes on 594 election night party and the tribute to the Sandy Hook students at Pioneer Park.

Deputy Mayor Grausz spoke about SCA items for discussion as part of the City's legislative agenda. He also noted that the School District has decided to participate in a community solar project and have agreed to replace the roof on which the solar panels will be located.

Councilmember Brahm spoke about the Solarize meeting with School District and the Arts Council meeting. She noted there is a new holiday art show at the MICEC gallery and that 25% of the sales goes to City.

Councilmember Cero noted that the Eastside Transportation Partnership legislative agenda is still being revised. Mayor Bassett spoke about a meeting with King County Metro regarding the Mercer Island bus routes that were eliminated.

#### SUMMARY

King County's regional Automated Fingerprint Identification System (AFIS) program is in the process of establishing an Interlocal Agreement (ILA) with each agency in the County that provides law enforcement services (see Exhibit 1). No ILA currently exists to address the use and maintenance of this equipment. The ILA memorializes and clarifies expectations, responsibilities, and practices that have been in place for many years at agencies to include Mercer Island. The ILA addresses use and maintenance of electronic fingerprint equipment provided to the agencies by the AFIS Program.

By way of a King County property tax levy, the AFIS program funds these Livescans and Mobile ID devices located throughout the county. This equipment is the means by which fingerprints are transmitted from the field to the AFIS computer resulting in the positive identification of individuals.

**Livescan** is an electronic fingerprinting station that submits fingerprints and palm prints to the King County AFIS computer. The prints are matched against other fingerprint records as well as "latent" prints collected at crime scenes. Along with fingerprints, related arrest information is forwarded to the Washington State Patrol and FBI for entry into state and national criminal history records. Livescans have been in operation at jails and police departments in the county since the late 1990's. Mercer Island Police personnel also use the device to fingerprint citizens applying for various permits or licenses. Throughout 2015 and 2016, the AFIS program will replace the Livescans that are in current operation with updated versions.

**Mobile ID** is a wireless, handheld device used by the officer/detective in the field to submit an individual's prints when identity is in question. This remote search against the AFIS computer provides an "ID" response in less than two minutes and it gives the officer information when determining whether to take a

person into custody. The device is also used to identify injured and/or deceased individuals. The Mobile ID infrastructure and devices were successfully piloted in King County for the past three years. The AFIS program has purchased 250 additional devices for distribution throughout the county this fall.

The ILA also contains a Mobile ID policy that the police agency would be agreeing to implement. This policy was reviewed by police agencies and public interest representatives.

The ILA is the same for each city and/or entity within King County. It was vetted with a sampling of jurisdictions within King County and reflects those agencies' input. If approved, the ILA would be in effect from year to year unless modified or terminated in accordance with the terms outlined in the agreement.

#### FINANCIAL IMPACT

The current AFIS levy, which is a six-year levy and was passed by voters in 2013, funds this equipment. If the AFIS program receives continued support into the future, it intends to continue to purchase, maintain, and replace equipment as needed. The devices, which are provided by King County AFIS at no charge to the Mercer Island Police Department, cost \$1,150 per mobile device and \$15,000 for the Livescan machine. The only impact to the City are soft costs, such as minimal IT staff time to assist AFIS program staff in setting up the software, hardware, and network connections; time for officers to receive training and report any issues; and any on-site change that may be needed to prepare for installing a new Livescan station.

#### INTERLOCAL AGREEMENT BETWEEN KING COUNTY AND THE CITY OF MERCER ISLAND

for use of

#### ELECTRONIC FINGERPRINT CAPTURE EQUIPMENT

THIS AGREEMENT is entered into between King County ("County") and the city of Mercer Island ("Agency"). The County and the Agency may be referred to individually as a "Party" or collectively as "Parties."

WHEREAS, the Automated Fingerprint Identification System (AFIS) has proven to be an effective crime-fighting tool in furtherance of the health, welfare, benefit and safety of the residents within King County; and

WHEREAS, since January 1, 2013, the County has continued to provide effective AFIS services to public law enforcement agencies within King County, through a voter approved six (6) year levy, as authorized by King County Ordinance No. 17381; and

WHEREAS, the Agency wishes to use AFIS services through Electronic Fingerprint Capture Equipment ("FP Equipment") including the necessary software and computer equipment, and system maintenance services;

NOW, THEREFORE, for and in consideration of the promises and covenants contained in this Agreement, the Parties hereto agree as follows:

#### I. PURPOSE

The purpose of this Interlocal Agreement is to establish the terms under which FP Equipment, which the County approves for placement in the Agency, will be used and maintained. This applies to FP Equipment previously approved for placement in the Agency and FP Equipment approved for placement in the Agency during the term of this agreement. The goals of this Agreement are to:

- Protect the public by assisting law enforcement in identifying potentially wanted or dangerous subjects before they are released from custody.
- Protect law enforcement officers by providing information important to officer safety prior to the release of detained individuals.
- Provide efficiency and accuracy in criminal record reporting to the Washington State Patrol ("WSP") and the Federal Bureau of Investigation ("FBI").
- Improve the quantity and quality of fingerprints available for search in the King County Regional AFIS Database.

FP Equipment is defined as:

- Livescan: stationary electronic fingerprint capture equipment used to obtain full sets of fingerprints for purposes of searching and storing in AFIS;
- Mobile ID: mobile electronic fingerprint capture equipment used to obtain prints from two fingers for purposes of searching AFIS to determine an individual's identity. These prints are not stored in AFIS.

#### II. CONTRACT ADMINISTRATION

A. This Agreement shall be administered by the King County Sheriff through the Regional AFIS Manager or other designee and the Agency Chief of Police or its designee. Each Party's governing body shall approve this Agreement. Each Party shall inform the other within thirty (30) days of this Agreement's execution of its respective contract administrator.

#### III. GENERAL TERMS AND CONDITIONS

- A. The County, in its sole discretion, will decide whether to place FP Equipment in the Agency.
- B. All FP Equipment purchased by the County and located at the Agency's site shall remain the property of the County.
- C. The County may require the Agency to return FP Equipment to the County at any time, for any reason.
- D. All FP Equipment that has been installed by the King County Regional AFIS Program will be available for use by any other law enforcement agency operating within King County, if feasible, and no charge for the use of those devices by other agencies will be levied by the Agency.
- E. All FP Equipment shall be used exclusively for biometric purposes only.
- F. Statistics, or any information, which is pertinent to the FP Equipment and AFIS Program and requested by the King County Regional AFIS Manager, will be compiled by the Agency and submitted as needed.
- G. The Agency shall cooperate with the FBI if contacted through a post-processing review of a Mobile ID match in its database.
- H. The County may remove any Agency employee's rights to use FP Equipment at any time, for any reason.
- I. The Agency shall ensure that no Agency employee, officer or agent sells, transfers, publishes, discloses, or otherwise makes available any FP Equipment, software, documentation or copies thereof to any third party without the express written authorization of the County.
- J. The Agency agrees to notify the County immediately of any FP Equipment access code of any person who leaves Agency employment so that the County may delete that person's access code in order to maintain the integrity of the AFIS.
- K. The Agency will comply with all FP Equipment requirements as detailed in attached Exhibit A. The Regional AFIS Manager may revise these requirements at any time. Any revised requirements will be provided to the Agency and automatically incorporated as a new Exhibit A to this agreement. No council approval will be required to amend the Exhibit A.
- L. The Agency will comply with the Regional AFIS Program Biometric Handheld Fingerprint Identification Policy. Copy attached as Exhibit B. The Regional AFIS Manager may revise this policy at any time. Any revised policy will be provided to the Agency and automatically incorporated as a new Exhibit B to this agreement. No council approval will be required to amend the Exhibit B.

#### IV. AGENCY LIAISONS AND TRAINING

- A. The Agency shall assign at least one (1) Liaison. The Agency may assign separate Liaisons for each type of FP Equipment.
- B. All Agency Liaisons are required to attend training in the proper use of and the administrative functions of the FP Equipment. Training shall be provided by the County designated Trainer.
- C. Agency Liaisons for Livescan are responsible to work with the County to schedule staff training, provide user access, perform queue maintenance, and conduct system troubleshooting and testing.
- D. Agency Liaisons for Mobile ID are responsible to work with the County to schedule Agency staff to install the Mobile ID software, schedule staff training, and conduct system troubleshooting and testing.
- E. All Agency FP Equipment Operators are required to attend County provided training in the proper use of the FP Equipment by the County designated Trainer.

#### V. INSTALLATION AND MAINTENANCE OF ELECTRONIC FINGERPRINT CAPTURE EQUIPMENT

A. Costs paid by County

The County shall pay for the one-time delivery and installation of the FP Equipment approved for placement in the Agency. The County shall be responsible for all maintenance costs on the FP Equipment, unless otherwise specified below.

B. Costs paid by Agency

The Agency shall pay the following costs related to FP Equipment:

- 1. Any cost for office space remodeling which may be necessary to accommodate the Agency's Livescan installation;
- 2. Any internal infrastructure which may be necessary to connect the Agency to the King County Network. This infrastructure may include a Local Area Network, wiring, or other equipment;
- 3. Services in connection with the relocation of the FP Equipment or the additional removal of items of equipment, attachments, features, or other devices, except as may be mutually agreed by written amendment to this Agreement;
- 4. Electrical work external to the Agency's FP Equipment;
- 5. Repair or replacement of damaged or lost FP Equipment from any cause whatsoever, while in the care, custody and/or control of the Agency;
- 6. Repair or replacement to FP Equipment due to the FP Equipment being modified, damaged, altered, moved or serviced by personnel other than County's Contractor or its authorized representative;
- 7. Purchase of consumable FP Equipment supplies, such as printer toner cartridges, cleaning supplies, and gloves;

- 8. Agency employee salary cost and any overtime pay which may be necessary to complete initial or ongoing use or training for FP Equipment;
- 9. Cost of integrating any Agency system to the FP Equipment.
- 10. Costs associated with moving FP Equipment.
- 11. Costs associated with preventative cleaning of FP Equipment.
- C. The County shall act as the point of contact for any questions or service calls from the Agency that need to be relayed to the FP Equipment Contractor. The County shall have a contact person available twenty-four (24) hours a day, seven (7) days a week.
- D. The Agency shall provide a means of gaining access to the FP Equipment twenty-four (24) hours a day, seven (7) days a week for the purpose of installation, service calls, regular maintenance and special maintenance, when agreed upon in advance between parties. The Agency shall permit the County and/or the FP Equipment Contractor prompt and free access to the FP Equipment, including the ability to access the Livescan remotely.
- E. The Agency will not make or permit any person other than the County or the FP Equipment Contractor to make any adjustment or repair to the FP Equipment. The Agency will not relocate, modify, change, or attempt to connect said FP Equipment without the prior written permission of the AFIS Regional Manager. The Agency will not attempt to service the FP Equipment, except for normal cleaning, and will not permit anyone other than the County or the FP Equipment Contractor to perform maintenance services in connection with the FP Equipment.
- F. The Agency shall promptly notify the County of any error, defect, or nonconformity in the FP Equipment.
- G. The Agency shall perform preventative cleaning of the FP Equipment in accordance with the written instructions and schedules provided by the County.
- H. Any local system or network changes that would affect the FP Equipment or King County network must be reviewed by King County prior to implementation.
- I. The Agency shall provide and maintain the network required to submit electronic fingerprint transmissions, in compliance with the FP Equipment Security Policy as described in Exhibit A.

#### VI. DURATION, TERMINATION AND AMENDMENT

- A. This Agreement shall become effective when it is signed by both Parties.
- B. This Agreement shall continue in full force and effect from year to year unless modified or terminated in accordance with the terms of this Agreement.
- C. This Agreement may be terminated or suspended by either Party without cause, in whole or in part, by providing the other Party's administrator, as described in Article 2, thirty (30) days advance written notice of the termination.
- D. If County or other expected or actual funding is withdrawn, reduced, or limited in any way the County may, upon written notification to the Agency's administrator, as described in Article 2, terminate or suspend this Agreement in whole or in part and such termination or suspension may take place immediately.

- E. This Agreement shall terminate without penalty in the event that, in the opinion of the County, AFIS levy proceeds are, for whatever reason, no longer available for purposes of this Agreement.
- F. Upon termination of this Agreement, the Agency shall cooperate in the return of all King County property to the County. Such a return would be coordinated by the Regional AFIS Manager.
- G. As described in Section III.M and N, any changes to Exhibit A or B may be made by the Regional AFIS Manager. All other amendments to this Agreement must be agreed to in writing by the parties.

#### VII. INDEMNIFICATION AND LIMITATION OF LIABILITY

- A. In no event will the County be liable for loss of data, loss of use, interruption of service, incompleteness of data and/or for any direct, special, indirect, incidental or consequential damages arising out of this Agreement or any performance or non-performance under this Agreement.
- B. The Agency shall indemnify, defend and hold harmless the County and its officers, agents, and employees, or any of them, from any and all claims, actions, suits, liability, loss, costs, expenses, and damages of any nature whatsoever, by reason of or arising out of or in any way relating to the installation, maintenance or use of the County's FP Equipment including any claimed violation of any person's civil rights. The foregoing indemnity is specifically and expressly intended to constitute a waiver of the Agency's immunity under Washington's Industrial Insurance act, RCW Title 51, as respects the County only, and only to the extent necessary to provide the County with a full and complete indemnity of claims made by the Agency's employees. The parties acknowledge that these provisions were specifically negotiated and agreed upon by them. In the event that any suit based upon such a claim, action, loss, or damage is brought against the County, the Agency shall defend the same at its sole cost and expense; provided, that, the County retains the right to participate in said suit at its own expense if any principle of governmental or public law is involved; and if final judgment be rendered against the County and its officers, agents, and employees, or any of them, or jointly against the County and the Agency and their respective officers, agents, and employees, or any of them, the Agency shall satisfy the same.
- C. The County assumes no responsibility for the payment of any compensation, fees, wages, benefits or taxes to or on behalf of the Agency, its employees, contractors or others by reason of this Agreement.
- D. The Agency shall protect, indemnify and save harmless the County, its officers, agents and employees from any and all claims, costs and losses whatsoever occurring or resulting from (1) the Agency's failure to pay any compensation, wage, fee, benefit or tax, and (2) the supplying to the Agency of work, services, materials or supplies by Agency employees or agents or other contractors or suppliers in connection with or in support of performance of this Agreement.
- E. The indemnification, protection, defense and save harmless obligations contained herein shall survive the expiration, abandonment or termination of this Agreement.

#### VIII. CHOICE OF LAW AND VENUE

This Agreement will be governed by the laws of the State of Washington, both as to interpretation and performance. Any action at law, suit in equity or other judicial proceeding for the enforcement of this Agreement may be instituted only in King County Superior Court.

#### **IX. DISPUTES**

The Parties shall use their best, good-faith efforts to cooperatively resolve disputes and problems that arise in connection with this Agreement. Both Parties will make a good faith effort to continue without

delay to carry out their respective responsibilities under this Agreement while attempting to resolve the dispute under this section.

#### X. NO THIRD PARTY BENEFICIARIES

There are no third party beneficiaries to this Agreement, and this Agreement shall not impart any rights enforceable by any person or entity that is not a party hereto.

#### XI. WARRANTY OF RIGHT TO ENTER INTO AGREEMENT

The Parties each warrant they have the authority to enter into this Agreement and that the persons signing this Agreement for each Party have the authority to bind that Party.

#### XII. ENTIRE AGREEMENT

No change or waiver of any provision of the Agreement shall be valid unless made in writing and executed in the same manner as this Agreement. Except as to modifications to Exhibits A & B, the governing body of each Party shall approve any amendment to this Agreement. This Agreement constitutes the entire agreement between the Parties with respect to the subject matter hereof and supersedes all previous agreements, written or oral, between the Parties with respect to the subject to the subject matter hereof.

#### EXHIBIT A

#### FINGERPRINT EQUIPMENT REQUIREMENTS

#### I. LIVESCAN SPECIFIC REQUIREMENTS

#### A. Environmental

The County shall provide an Uninterruptible Power Supply ("UPS") to be used with the Livescan equipment at no cost to the Agency.

The Agency shall provide the County with a minimum of two fixed IP addresses to be used only for the Livescan system and fingerprint card printer.

Cities must provide the proper environment for the Livescan, to include:

- 1. Consistent temperature ranging from 60 to 80 degrees Fahrenheit.
- 2. Consistent humidity ranging from 20% to 80% non-condensing.
- 3. Network connections no more than 3-4 feet from equipment.
- 4. Total of 4 power outlets within 3-4 feet of the Livescan system.

Note: It is recommended that Cities have a dedicated 120V, 15Amp, 60Hz power line for the Livescan to avoid circuit overload.

B. Local Interfaces

Livescans may be integrated with local records management systems provided that:

- 1. All development and installation costs are paid by the Agency
- 2. The integration specifications are provided for review and approval by the County prior to implementation
- 3. The integration is tested by the County prior to implementation
- C. Fingerprint, Palmprint and Arrest Record Transmission
  - 1. All Agency criminal misdemeanor, gross misdemeanor, and felony fingerprints and palmprints, on both adults and juveniles, will be electronically transmitted to the King County Regional AFIS database for search and registration.
  - 2. The King County Regional AFIS will transmit the Agency's fingerprint images, charge and demographic data, electronically to the Washington State Patrol for processing.
  - 3. The Agency will be solely responsible for the accuracy of all demographic and charge information on its fingerprint and palmprint submissions. The County will not edit any suburban Agency demographic or charge information prior to submitting to Washington State Patrol.

#### II. MOBILE IDENTIFICATION SPECIFIC REQUIREMENTS

The Agency must provide the proper environment for the Mobile ID software, to include:

- A. The Mobile Data Terminal or patrol vehicle mounted laptop running Windows 7 (32 or 64 bit) operating system.
- B. The patrol vehicle must be a physically secure location according to current Criminal Justice Information Services Security Policy.

#### **III. QUALITY CONTROL**

Maintaining the quality of the Regional AFIS database is important in order to continue our region's ability to identify criminals and solve crimes. The Agency shall submit electronically captured fingerprints and palmprints (where applicable) to the Regional AFIS database that are of the best possible quality. The County will provide training to Agency staff, either through the FP Equipment Contractor or the County. The Agency and County will work together to ensure that all users are trained to competency. The County will review the quality of electronically captured prints and inform Agency of operators not meeting standards. These operators may be required to repeat training, and must improve their overall quality, in order to maintain access to the FP Equipment.

#### IV. NETWORKING

The Agency will provide coordination of Agency IT staff, when needed, to ensure secure networking is in place.

The Agency shall report, in advance when possible, all network changes and/or outages which have the potential to disrupt FP Equipment connectivity. Reporting can be made via the King County Service Request Line (206-263-2777) or the AFIS IT mailbox (<u>AFISITHelp@kingcounty.gov</u>).

#### V. SECURITY

A. Roles and Responsibilities

Each participating Agency is responsible for establishing appropriate security control.

All member Cities shall provide security awareness briefing to all personnel who have access to King County FP Equipment.

B. Monitoring

All access attempts are logged and/or recorded and are subject to routine audit or review for detection of inappropriate or illegal activity.

Security-related incidents that impact County FP Equipment data or communications circuits shall be reported immediately upon discovery by the Agency to the King County Regional AFIS Program.

C. Physical Security

Cities must assume responsibility for and enforce the system's security standards with regard to all Cities and users it services. The Agency must have adequate physical security to protect against any unauthorized access to FP Equipment, or stored/printed data at all times.

#### D. Network Environment Security

Cities hosting the connection of FP Equipment shall ensure adequate security measures are taken to provide protection from all forms of unauthorized and unsolicited access to FP Equipment. These security measures will be in compliance with Federal Information Processing Standard (FIPS) 140-2.

Cities are required to provide, manage, and maintain a firewall that segments the FP Equipment from any foreign non-public safety networks.

Any exceptions to this or any other network security requirement must be approved by the Regional AFIS Manager under the guidance of King County by and through its Sheriff's Office Information Services Section and King County Information Technology.

If a security breach occurs and personal identifiable information or confidential data is released or compromised, the host Agency shall bear the responsibility and costs to notify affected individuals whose information was released or compromised. This will be completed in accordance with any applicable state or federal laws.

#### EXHIBIT B



#### BIOMETRIC HANDHELD FINGERPRINT IDENTIFICATION POLICY King County Regional Automated Fingerprint Identification System (AFIS)

#### PURPOSE

١.

To provide direction for the use of the biometric handheld fingerprint identification devices, more commonly known as a mobile identification device or Mobile ID. If an agency wishes to adopt its own or deviate from this policy, the agency must present its request to the Regional AFIS Manager.

#### II. PROGRAM

King County's regional AFIS program has initiated a Mobile ID project, involving the use of wireless remote fingerprint identification throughout the county. The project is designed to assist in identifying persons whose identities are in question. While the fingerprint verification process already exists in King County, Mobile ID moves this function to law enforcement first responders, resulting in a more timely identification process.

The system scans the fingerprints at the Mobile ID device and transmits wirelessly to the King County AFIS. If the fingerprints are in the AFIS database, a positive match returns the person's specific identifiers to the Mobile ID device or officer's mobile computer.

In the future, a simultaneous search may also be conducted to search Washington State Patrol's AFIS database and an FBI database known as the Repository for Individuals of Special Concern (RISC).

- A. Only officers trained by AFIS program staff and operating under the guidelines of the Mobile ID project may use the device.
- B. In the event that lack of usage by the assigned officer is a concern, the AFIS program will communicate with the agency and provide retraining and/or direct a reassignment of the device.
- C. Any use of the device not consistent with this policy and/or law enforcement purposes may result in reassignment or forfeiture of the device, and/or a deactivation of access to the AFIS database. Additionally, any violation of the Mobile ID policy/procedure, or of federal or state law, may subject the officer to internal discipline by his/her agency.

#### III. PROCEDURE

The use or retention of any Mobile ID-collected data shall conform to federal and state laws. It must also conform to individual agency policy as well as the AFIS program procedure as follows:

- A. An officer may use Mobile ID when there is probable cause to arrest a suspect.
- B. An officer may also use Mobile ID during a Terry Stop based upon reasonable suspicion. If a person provides a driver's license or other valid means of identification, or gives the officer a name that can be confirmed through a driver's license check, that form of identification should suffice without the use of Mobile ID. However, if there are articulable facts that give rise to reasonable suspicion regarding the accuracy of a person's identity, the officer may use Mobile ID to verify identity.
- C. Absent probable cause or reasonable suspicion of criminal activity, a person may consent to an officer's request to use Mobile ID. However, the consent must be voluntary as defined by current Washington case law; i.e., the person must be informed that he/she has a right to refuse the officer's request.
- D. Use of the device shall be documented in any report generated as a result of the contact. The officer must articulate the specific facts that support the basis for the use of Mobile ID and must state the voluntary compliance of the Mobile ID if used without arrest, probable cause, or reasonable suspicion.

#### SUMMARY

#### BACKGROUND

On November 19, 2014, the Mercer Island Planning Commission unanimously recommended approval of a Mercer Island City Code text amendment to allow youth stage theaters as accessory uses to places of worship. The staff report to the Planning Commission is attached as Exhibit 1. The Planning Commission's recommended Ordinance No. 15C-03 is attached as Exhibit 2.

The proposed amendment was initiated by City staff after Youth Theater Northwest (YTN) was required to vacate its former location to make way for the new Elementary School. YTN recently re-located to Emmanuel Episcopal Church (4400 86<sup>th</sup> Avenue SE).

#### PROPOSED CODE TEXT AMENDMENT

The following paragraph would be added to MICC 19.02.010(A) Single-Family – Uses Permitted in Zones R-8.4, R-9.6, R-12, and R-15:

12. Places of worship may have a stage theater program for youth (ages preschool through grade twelve) as an accessory use. Stage theater programs are defined as productions of live presentations involving the performances of actors or actresses, singers, dancers, musical groups, or artists. Stage theater programs also include related classes and instructional workshops. Adequate parking must be provided, as determined by the Code Official.

#### **CRITERIA FOR REVIEW**

There are no specific criteria listed in the Mercer Island City Code for a code amendment. However, in accordance with RCW 36.70A.040, the proposed amendments shall be consistent with the goals and policies set forth in the City's Comprehensive Plan. The following Comprehensive Plan policies are applicable to the proposed code amendments:

#### Land Use Policy 7.4

As a primarily single family residential community with a high percentage of developed land, the community cannot provide for all types of land uses. Certain activities will be considered incompatible with present uses. Incompatible uses include land fills, correctional facilities, zoos and airports. Compatible permitted uses such as education, recreation, open spaces, government social services and religious activities will be encouraged.

#### Land Use Policy 9.4

Social and recreation clubs, schools, and religious institutions are predominantly located in single family residential areas of the island. Development regulation should reflect the desire to retain viable and healthy social, recreational, educational, and religious organizations as community assets which are essential for the mental, physical and spiritual health of Mercer Island.

Places of worship often have facilities that could be used by youth stage theater programs for educational purposes and performances; such as sanctuaries, meeting halls, stages and classrooms. Allowing youth stage theater programs to be accessory uses to places of worship would provide more efficient use of underutilized space. Allowing youth stage theater programs as an accessory use to places of worship is considered a "compatible" use in Mercer Island's single family residential community and is to be encouraged (Land Use Policy 7.4). The proposed amendment would facilitate a healthy social, recreational and educational use and support viable religious organizations by allowing an additional use that could provide financial support for the religious organization.

The proposal is consistent with the Growth Management Act (RCW 36.70A) and the City's Comprehensive Plan as the proposal would promote the aforementioned policies.

#### CITY COUNCIL REVIEW PROCESS

Code text amendments are legislative decisions. As such, the City Council can receive additional public comments regarding the Planning Commission's recommendation, including introduction of new information.

#### I. SUMMARY

The City of Mercer Island is proposing an amendment to Title 19 of the Mercer Island City Code (MICC) that would allow youth stage theater programs as an accessory use to places of worship.

An application for the proposed code amendment was received on October 8, 2014 and was determined to be complete on October 8, 2014. See Exhibit 1. The application also includes a SEPA Environmental Checklist. See Exhibit 2.

A code amendment is a legislative action set forth in MICC 19.15.010(E). Applicable procedural requirements for a legislative action are contained within MICC 19.15.020, including the provision that the Planning Commission conduct an open record public hearing for all legislative actions. On November 19, 2014, the Planning Commission will hold an open record public hearing on this matter to obtain comments from the public, deliberate the proposed amendment and forward a recommendation to the City Council. The Planning Commission's resulting recommendation will be forwarded to the City Council for consideration and action. As the final decision making authority for legislative actions, the City Council will consider the matter in an open public meeting prior to taking final action. The City Council's first reading of the code amendment is tentatively scheduled for December 1, 2014, and a second reading on January 5, 2015, during which the Council is anticipated to take final action and render a decision on the proposed code amendment.

The City issued a Public Notice of Application and Open Record Hearing, and SEPA Determination of Non-Significance (DNS) Likely, which was published in the City's weekly permit bulletin on October 13, 2014. See Exhibit 3. The Notice was also published in the Mercer Island Reporter on October 15,

2014. The initial public comment period ran from October 13, 2014 through 5:00 P.M. on October 29, 2014. The City received no written comments concerning the proposed amendment

The SEPA Responsible Official determined that this proposal would not have a probable significant adverse impact on the environment, and a SEPA Determination of Non-Significance (DNS) was issued on November 3, 2014. See Exhibit 4. The DNS was emailed to SEPA agencies, published in the City's permit bulletin, and posted at City Hall on November 3, 2014. The appeal period on the DNS ends on November 17, 2014.

#### **II.** STAFF FINDINGS, ANALYSIS AND CRITERIA FOR REVIEW

The proposed amendment to MICC Title 19 that would allow youth stage theater programs as an accessory use to places of worship is shown on Exhibit 5. The proposed amendment is discussed below.

#### Staff findings:

WHEREAS, on November 3, 2014 the City of Mercer Island issued a SEPA Threshold Determination (DNS) for the development code text amendments which was published in the City's permit bulletin, posted at City Hall; and

WHEREAS, the Planning Commission held an open record public hearing on November 19, 2014, and recommended approval of the proposed development code text amendments, finding the application consistent with the Growth Management Act; and

WHEREAS, the City Council held a public meeting on December 1, 2014 to provide opportunities for formal public comment on these matters.

- Section 4: <u>Effective Date</u>. This Ordinance shall take effect and be in force 30 days after its passage and publication.

#### 2015 STATE LEGISLATIVE SESSION

The 2015 Washington State Legislative Regular Session will run from January 12. 2015 to April 27, 2015. The Legislature works within the framework of a two-year cycle. For instance, the entire 2015-2016 Session is considered the 64<sup>th</sup> Session of the Legislature and will contain at least two regular sessions. A "long" session will be held in 2015 (105 days) and a "short" session is scheduled in 2016 (60 days). There could also be any number of special sessions called by the Governor during each two-year cycle, none of which can last longer than 30 days.

#### **CITY LEGISLATIVE AREAS OF INTEREST**

Areas of interest that have been identified for Council consideration are from the following regional organizations and committees:

- 1. Association of Washington Cites (AWC)
- 2. Sound Cities Association (SCA)
- 3. A Regional Coalition for Housing (ARCH)
- 4. King County Mental Health and Substance Abuse Legislative Forum
- 5. PSRC Regional TOD Advisory Committee

6. City of Mercer Island 2014 State Legislative Priorities (Exhibit 3)

# **Cities' Action Agenda**



Strong Cities make a Great State

Washington's 281 cities and towns are where most residents live, work, learn, and play. Cities appreciate the serious funding challenges facing the state involving the need to adequately fund quality schools and maintain economically viable communities. Cities face many of these same challenges and pledge to partner with the Legislature and Governor to find ways to adequately fund both state and local priorities. For 2015, cities have identified the following priorities:

## **Shared Revenue**

Maintain the revenue sharing partnership between the state and cities, including restoration of diverted liquor taxes and removal of the cap on liquor profits. Sharing of these revenues is the product of a long standing partnership and without the promise of this revenue, cities would have



sought other local options and authorities. The needs of growing and economically challenged cities require more resources.

## **Transportation**

Adopt a comprehensive Transportation Package. The state is faced with insufficient funding for maintenance and preservation, and for new transportation projects that are important for economic well-being. City transportation needs are



equally critical. Cities require additional tools to maintain more than 38,000 miles of local streets and we need the state to continue important programs like the Transportation Improvement Board.

## Infrastructure

Cease raids on infrastructure funds and restore the state commitment to investment in public infrastructure. Our infrastructure is aging and cities can't keep up with increasing demands without the strong partnership with the state. To keep



Washington moving forward and to keep with demands and regulatory requirements, we need programs like the Public Works Assistance Account, the Centennial Clean Water Fund, and Model Toxics Control Account.

## **Revenue Authorities**

Explore new revenue options and more flexible use of existing revenue sources, including adjusting the limit on property tax increases to better reflect the costs of providing services. Like the state, cities have limited revenue options



to fund critical services and support economic activity. We must explore sustainable funding opportunities that keep up with costs allowing locals to meet their own service needs.

## Marijuana

Fund critical public safety and criminal justice needs by sharing a portion of the 75% excise tax on recreational marijuana. The state and local governments must partner effectively to respond to the history making legalization of



marijuana, including support for enforcement activities, prevention, and education efforts. We must also appropriately regulate medical marijuana while maintaining patient access.

## City of Mercer Island FINANCIAL STATUS REPORT Third Quarter 2014

## FOREWORD

The Financial Status Report provides a summary budget to actual comparison of revenues and expenditures for the General Fund (four times a year) and all other funds (twice a year) through the end of the most recently completed fiscal quarter. Revenue and expenditure comparisons are also made to the same period in the prior year. In addition, a comprehensive progress update on the City's Capital Improvement Program (CIP) is included twice a year in the second and fourth quarter reports. A separate fund balance analysis for every fund is included annually in the fourth quarter report as well. Finally, if needed, budget adjustments are identified in a separate section of this report, along with a budget amending ordinance.

This report is comprised of the following five sections:

- General Fund
- Utility Funds
- All Other Funds
- Capital Improvement Program
- Budget Adjustments

It should be noted that, where significant, revenues are recognized when earned, regardless of when cash is received, and expenditures are recognized when a liability has been incurred or when resources have been transferred to another fund. Also, in the case of the General Fund, the beginning fund balance, which corresponds to the Council approved "cash carryover" of net excess resources from the prior year, is separately identified.

## **GENERAL FUND**

**The General Fund ended the third quarter of 2014 in good shape, with total revenues slightly above (68.1 percent) the 67.0 percent revenue target and total expenditures modestly below (72.2 percent) the 75.0 percent budget threshold.** Total revenues are projected to be 0.5-1.0 percent ahead of budget at year-end primarily due to stronger than expected development activity on the Island. Total expenditures, including carryovers for purchases and services not completed by year-end, are projected to be 98.0-99.0 percent of budget at year-end. Of the total estimated revenue surplus and expenditure savings in 2014, \$441,000 is dedicated to funding one-time service package costs in 2015-2016.

### Revenues

Comparing total actual to total budgeted revenues (i.e. excluding Beginning Fund Balance and Transfer From Other Funds) through the third quarter of the year, **the General Fund is 68.1 percent of budget in 2014 versus 67.6 percent of budget in 2013**, which is slightly above the 67.0 percent revenue target. The 75.0 percent budget threshold no longer applies, because the City was compelled to institute an accounting change in 2013, with monthly property tax revenue recognized when received rather than accrued back to the prior month. Because property tax is mostly distributed to cities in April/May and October/November, the revised revenue targets for the first and third quarter financial status reports are 17.0 percent and 67.0 respectively. The following table compares actual to budgeted revenues as of September 30, 2013 and 2014.

## Comparing 2014 to 2013, total actual revenues are up about \$959,000, or 5.9 percent, through the third quarter of the year primarily due to the following revenues:

- \$288,000, or 15.0 percent, increase in licenses, permits & zoning fees
- \$196,000, or 6.7 percent, increase in utility taxes
- \$180,000, or 3.1 percent, increase in property tax
- \$136,000, or 6.1 percent, increase in sales tax
- \$74,000, or 37.8 percent, increase in intergovernmental revenues
- \$53,000, or 22.5 percent, increase in court fines

A more in-depth analysis is provided for the following revenues:

- Property tax is 56.1 percent of budget in 2014 compared to 55.6 percent of budget in 2013. Trailing the 75.0 percent budget threshold through the third quarter of the year is normal given that King County distributes property tax receipts to cities mostly in April/May and October/November. The \$180,000, or 3.1 percent, increase in 2014 revenue relative to the prior year can be attributed mostly to the following: 1) the 1.0 percent optional increase in the 2014 levy; and 2) "new construction" additions to the 2014 levy.
- Utility taxes are 71.0 percent of budget in 2014 compared to 72.0percent of budget in 2013. The table below compares utility tax revenues, which are broken down by type of utility, for 2012-2014 through the third quarter of the year.

#### 2012-2014 B&O Tax Revenue

Comparing 2014 to 2013, actual revenues are up almost \$196,000, or 6.7 percent, in 2014 primarily due to water, sewer, and storm water utility taxes, which are collectively up 43.9 percent. Beginning January 1, 2014, the utility tax rate applied to the City's water, sewer, and storm water utilities increased from 3.9 to 5.3 percent. The 9.8 percent decline in telephone utilities is consistent with the long-term trend of people switching from land line to cellular and/or VoIP (voice over internet protocol) phone plans. The latter is significantly cheaper than land line phone plans. Finally, the 5.0

percent drop in cellular utilities is directly related to the following: 1) a highly competitive business environment, which has resulted in less expensive monthly phone plans; 2) the availability of prepaid phone plans, which limit phone usage; 3) the popularity of texting over talking, which has reduced the use of voice minutes; and 4) the exclusion of data plans from utility taxes.

• Sales tax is 77.1 percent of budget in 2014 compared to 74.4 percent of budget in 2013. Relative to 2013, actual revenue is up about \$136,000, or 6.1 percent, in 2014. However, there are significant, one-time receipts from two non-classified businesses of \$19,000 in 2014, \$37,000 in 2013, and \$98,000 in 2012. Excluding these one-time receipts, actual revenue is up 7.1 percent in 2014. The following tables compare 2012-2014 sales tax revenue through the third quarter of the year for each business sector, including and excluding the significant one-time receipts.





The overall increase of 7.1 percent can be attributed primarily to the "construction," "retail & wholesale trade," and "all other" sectors, which are up 4.9 percent, 6.9 percent, and 14.2 percent respectively. Together, these three sectors comprise about 80.0 percent of the City's total sales tax receipts.

Licenses, permits, and zoning fees are 93.0 percent of budget in 2014 compared to 94.7 percent of budget in 2013. In addition, actual revenue is up about \$288,000, or 15.0 percent, in 2014 versus the same period in 2013. This revenue category consists of all fees related to development, business licenses, and a cable franchise. Across all building permit types (which include single family residential, multifamily residential, commercial, mixed use, and public) through the third quarter of the year, the total number of building permits issued is down 1.0 percent (320 permits in 2014 vs. 323 permits in 2013), and the total valuation is up 14.4 percent (\$52.23 million in 2014 vs. \$45.65 million in 2013). In terms of single family residential development, which serves as a leading economic indicator for the City, the total number of building permits is 2014 vs. 255 permits in 2013), and the total valuation is up 15.6 percent (\$45.47 million in 2014 vs. \$39.33 million in 2013). In other words, the high level of development activity in 2013 is continuing in 2014. The following two graphs show the total number of permits issued and the total valuation for single family residential development through the third quarter of 2011-2014.





Finally, cable franchise fees are up 3.5 percent in 2014 over the previous year (\$358,417 in 2014 vs. \$346,203 in 2013).

- Intergovernmental revenues are only 43.9 percent of budget in 2014 compared to 44.5 percent of budget in 2013. This is typical for this revenue category at this point in the year. The major revenue sources include the liquor excise tax and liquor profits that are shared by the state, vessel registration fees that are received from the state through King County, contract revenue for marine patrol services provided to the cities of Bellevue and Renton, and contract revenue from King County for Zone One emergency management coordination services (this is a two year contract from July 1, 2013 through June 30, 2015). The vessel registration fees and the marine patrol contract revenues, which comprise about one quarter of what is budgeted in this category, will not be received, or otherwise recognized, until December 2014. Comparing 2014 to 2013, actual revenue is up almost \$74,000, or 37.8 percent, mostly due to the Zone One emergency management contract, which began on July 1, 2013.
- Court fines are 77.3 percent of budget in 2014 compared to 63.1 percent of budget in 2013. Also, actual revenue is up almost \$53,000, or 22.5 percent, in 2014 compared to 2013. Court fines are directly tied to case filings, which are collectively up 64.3 percent in 2014 versus 2013. Broken down by city, Mercer Island's case filings, which account for 94 percent of the total, are up 68.5 percent, and Newcastle's case filings, which account for 6 percent of the total, are up 16.5 percent.

All other revenues are either within expected norms through the third quarter of the year or too insignificant to highlight.

## **Expenditures**

Comparing total actual to total budgeted expenditures through the third quarter of the year, **the General Fund is 72.2 percent of budget in 2014 compared to 73.0 percent of budget in 2013.** The 2.8 percent underage relative to the 75.0 percent budget threshold is primarily due to there being 19 bi-weekly payroll periods through September 30, 2014, which represents 73.1 percent of the 26 bi-weekly payroll periods in 2014. The following two tables compare actual to budgeted expenditures, first by category and then by department, as of September 30, 2013 and 2014.

#### GENERAL FUND: Expenditures by Department As of September 30, 2013 and 2014

In reviewing **expenditures by category**, the following are noteworthy:

- Salaries, which comprise about 53.0 percent of the 2014 General Fund budget, are 73.6 percent of budget in 2014 compared to 74.5 percent of budget in 2013. This modest underage relative to the 75.0 percent budget threshold is primarily due to there being 19 bi-weekly payroll periods through September 30, 2014, which was noted above.
- Benefits, which comprise about 20.0 percent of the 2014 General Fund budget, are 68.4 percent of budget in 2014 compared to 72.4 percent of budget in 2013. This significant underage relative to the 75.0 percent budget threshold is primarily due to the following: 1) medical and dental premiums through the Association of Washington Cities (AWC) did not increase in 2014 (a 10 percent medical increase and a 5 percent dental increase were budgeted in 2014); and 2) Police LEOFF I retirees, who were 65 or older, were moved to a new, more cost effective AWC plan (Medicare Advantage) in 2013.
- Contractual services, which comprise about 8.0 percent of the 2014 General Fund budget, are only 57.6 percent of budget in 2014 compared to 64.2 percent of budget in 2013. This expenditure category includes outside legal counsel, software support, development and engineering support, recreation instructors, repairs and maintenance, and other professional services. The underage relative to the 75.0 percent budget threshold is primarily due to the following: 1) unspent budget on the City's opposition to the proposed tolling of 1-90; 2) the commencement of the annual audit by the State Auditor's Office in October; and 3) the postponement of the EMS utility rate study to 2015.

• **Transfer of prior year's surplus** represents that portion of the General Fund's revenue surplus and expenditure savings from the prior year that has been approved by the Council to be distributed to other funds for various purposes in the current year. In 2013, the total available surplus in the General Fund was \$637,300 (\$223,455 revenue surplus + \$413,845 expenditure savings). Of this amount, \$446,000 was transferred out of the General Fund in 2014 for the following purposes: 1) to replenish the amount transferred out of the Contingency Fund to oppose the state's proposed tolling of I-90 (\$275,000); 2) to increase the Contingency Fund balance to its 2013 target level (\$71,000); and 3) to provide supplemental funding to the MICEC equipment and furnishings sinking fund (\$100,000) to cover the cost of planned replacements.

In reviewing **expenditures by department**, the following is noteworthy:

• The City Attorney's Office has spent 80.8 percent of its budget through the third quarter of 2014 due to unanticipated outside legal costs for land use petition act (LUPA) issues, shoreline master program (SMP) issues, public records request assistance, and a model toxic control act (MTCA) issue. Relative to a total budget of \$30,000, \$51,485 has been spent on outside legal services as of September 30, 2014.

All other expenditures are either within expected norms through the third quarter of the year or too insignificant to highlight.

## **REAL ESTATE EXCISE TAX**

Real estate excise tax (REET) is the 0.5 percent tax paid by the seller in property transactions, and its use is restricted by state law for specific capital purposes. REET 1 (the 1<sup>st</sup> quarter of 1.0 percent of the sales price) may be used for streets, parks, facilities, or utilities. REET 2 (the 2<sup>nd</sup> quarter of 1.0 percent of the sales price) may be used for the same capital purposes as REET 1, except for facilities, which are specifically prohibited. Neither REET 1 nor REET 2 may be used for equipment or technology.

In May 2011, the Governor signed HB 1953, which <u>temporarily</u> allows cities to use up to 35% of REET revenue (not to exceed \$1.0 million for either REET 1 or 2) for operations and maintenance purposes within the same categorical restrictions noted above. This temporary expansion of how REET can be used will sunset on December 31, 2016. Because of the City's many capital needs, the passage of HB 1953 has had no impact on how REET funds are currently used. It simply gives the City more flexibility.

Through the third quarter of the year, REET is 95.4 percent of budget in 2014 compared to 90.8 percent of budget in 2013, as shown in the table below.

**Relative to 2013**, actual revenue is up almost \$372,000, or 18.3 percent, through the third quarter of 2014. This substantial increase is primarily due to a 7.1 percent increase in the average sales price, which is now almost \$1.10 million, and to 7 homes sales that exceeded \$5.0 million each. Home sale statistics are displayed in the following table.

Based on actual receipts through October 2014, staff forecasts that REET will exceed the 2014 budget by \$472,000 (see following table), which will be split 50/50 between the Street Fund and the Capital Improvement Fund. This \$472,000 REET surplus has already been factored into the 2015-2016 Budget for the Street Fund and Capital Improvement Fund.

## **BUDGET ADJUSTMENTS**

In the interest of administrative ease, a budget amending ordinance is prepared and submitted to the Council quarterly, if needed, along with the Financial Status Report. Budget adjustments are divided into three groups: 1) those previously approved by the Council but not formally adopted via a budget amending ordinance; 2) new requests; and 3) carryover requests. The second category typically encompasses financial housekeeping items, minor requests, and unanticipated expenditures that the City had to incur and was unable to absorb within the authorized budget. The third category requires Council action only when unspent budget is being moved from the prior biennium to the current biennium. No Council action is needed when budget is moved within the biennium and within the same fund.

**Budget adjustments previously approved but not formally adopted** via a budget amending ordinance by the Council are summarized in the table below.

#### CITY OF MERCER ISLAND ORDINANCE NO. 14-16
