SUMMARY

Pursuant to RCW 35A.13 (which governs optional municipal code cities under the Council-Manager plan of government), the Mercer Island City Code and the City Council Rules of Procedure, newly elected and/or re-elected Councilmembers are sworn into office at the first Council meeting of the year. Additionally, the elections of Mayor and Deputy Mayor are conducted.

At Monday's Council Meeting, the City Clerk will officially call the meeting to order, administer the oaths of office to newly elected and re-elected Councilmembers and conduct the election for Mayor and Deputy Mayor.

OATH OF OFFICE

In November 2013, Dan Grausz (Position #2), Tana Senn (Position #4), and Benson Wong (Position #6) were elected by the citizens of Mercer Island to serve on the City Council. Each of these terms begins in 2013 and run for four years. The swearing-in ceremony is conducted by the City Clerk who will administer the oaths of office. Each Councilmember will be asked to repeat the following:

maintain the (Constitutions of the State of Washington and of the United States of America.

Formal signature from each Councilmember is required. The City Clerk will present the Certificates of Election as provided by the King County Director of Elections.

MAYORAL ELECTION

The Mayor is elected from among the Councilmembers for a two-year term. The Mayor presides at all Council meetings, votes as a Councilmember and does not have any veto power.

At the Council meeting, the City Clerk will entertain a motion for "nominations" for a Councilmember to serve as Mayor. As described in Section 6 of the City Council Rules of Procedure (Exhibit 1), if only one nomination is made, it is appropriate to make a motion and obtain a second to instruct the City Clerk to cast a unanimous ballot for that nomination. However, if more than one nomination is made, an open election is conducted by roll call vote to decide among those nominated who shall be elected. Approval is by majority vote of Councilmembers present.

Upon the election of the Mayor, the City Clerk shall administer the oath of office to the Mayor, who shall thereupon assume the role of Chair for the meeting. The City Clerk will then proceed with the election of Deputy Mayor.

SECTION 6. MAYOR AND DEPUTY MAYOR

6.1 The Presiding Officer at all meetings of the Council shall be the Mayor, and in the absence of the Mayor, the Deputy Mayor will act in that capacity. If both the Mayor and Deputy Mayor are absent, the Mayor will appoint another Council member as acting Mayor. If the Mayor fails to appoint an acting Mayor, the Council members present shall elect one of its members to serve as Presiding Officer until the return of the Mayor or Deputy Mayor.

6.2 The Presiding Officer shall:

- (1) Preserve order and decorum in the Council chambers;
- (2) Observe and enforce these Rules;
- (3) Recognize Council members in the order in which they request the floor. The Presiding Officer, as a Council Member, shall have only those rights, and shall be governed in all matters and issues by the same rules and restrictions as other Council members;
- (4) Appoint Council members to serve on City Council Committees, ad hoc committees and to serve as liaisons to advisory boards and commissions; Recommend appointment of citizens to serve on advisory boards and committees; and
- (5) Impose Council member sanctions for violation of these Rules consistent with Section 12 of these Rules.

6.3 Mayor and Deputy Mayor Elections

- (1) Any Council Member may nominate a candidate; no second is needed.
- (2) Nominations are closed by a motion, second and 2/3 vote of Council.
- (3) If only one (1) nomination is made, it is appropriate to make a motion and obtain a second to instruct the City Clerk to cast a unanimous ballot for that nomination. Approval is by majority vote of Council members present.
- (4) If more than one (1) nomination is made, an open election is conducted by roll call vote.
- (5) To be elected, the nominee needs a majority vote of the Council.
- (6) Elections will continue until a Mayor and Deputy Mayor are elected by a majority vote of the Council.
- (7) The City Clerk shall declare the nominee receiving the majority vote as the new Mayor. The new Mayor shall declare the nominee receiving the majority vote as the new Deputy Mayor. The Clerk shall swear the individuals into office.

RESOLUTION OF ACKNOWLEDGEMENT AND COMMENDATION FOR RICH CONRAD'S SERVICE TO THE CITIZENS OF MERCER ISLAND

WHEREAS, Rich Conrad first joined the staff of the City of Mercer Island in 1979, and served its citizens dutifully for 35 years;

WHEREAS, Rich was appointed City Manager in 1996, and held that role until his retirement in November 2013;

WHEREAS, Rich became known for his ability to see a project through to completion, his encyclopedic knowledge of local history and politics, and his broad technical knowledge;

WHEREAS, Rich brought a very personal and human form of leadership to City operations, by strongly supporting his staff and trusting his management team;

WHEREAS, Rich served as a coach and mentor for many generations of public service employees, took the time to eat his lunch with frontline employees, and frequently promoted capable staff from within;

WHEREAS, Rich is widely respected among his peers, and has served on the boards of numerous local, regional and statewide organizations, including president of the Washington City/County Management Association;

WHEREAS, during Rich's leadership, the community of Mercer Island experienced an era of growth, vision, and careful planning, including:

- A visionary planning process to revitalize Town Center
- Transfer of Luther Burbank Park from King County to the City
- Financial support for the continued operation of Mary Wayte Pool
- Construction of a new community center
- Starting a municipal court during the restructuring of the King County District Court system
- Developing a regional response to the reduction of jail services in the County
- Helping create a regional approach to E-911 communications and response
- Construction oversight of a new Park & Ride lot for commuters;

WHEREAS, the City of Mercer Island has also benefited from numerous improvements that Rich spearheaded, including:

- The formation of the nationally-recognized E-City Government Alliance, to share resources with 25 other member cities in areas such as personnel recruitment and construction permitting
- An agreement securing a 60-year water supply for the Island
- Oversight of the Shoreline Master Program update
- The growth of a strong relationship with the Mercer Island School District
- A solid partnership with the Mercer Island Chamber of Commerce

- Implementation of many measures to enhance and institutionalize environmental sustainability throughout City operations, such as:
 - Participation in the Evergreen Fleets clean vehicle initiative
 - Advocating for the use of low-impact development techniques
 - Installation of a solar array at the Mercer Island Community and Event Center
 - Installation of electric vehicle charging stations at City Hall, the Community Center, and PEAK Boys and Girls Club
 - Creation of a Green Revolving Fund to provide loans to energy-saving efficiency initiatives
 - Hiring of the City's first ever Sustainability Manager;

WHEREAS, Rich has introduced humor to the often-dry policy arena, and has even been known to crack a joke during tense Council meetings;

WHEREAS, Rich has displayed his dedication by attending close to 400 of those meetings, even when a good Seahawks game was on television;

WHEREAS, exhibiting tremendous patience, Rich coached several generations of mayors, and dozens of council members in how best to do their new jobs...even as they told him how to do his; and

WHEREAS, Rich will likely be seen a little more often down in Arizona perfecting his golf game; and a little less often in a suit and tie.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Mercer Island, on behalf of its citizens, that the City Council commends Rich Conrad for his 35 years of distinguished public service and extends its sincerest thanks and appreciation for his leadership and countless contributions to life on Mercer Island.

SUMMARY

The Mercer Island City Council reviewed the legal and constitutional context of regulating and licensing solicitors, and gave guidance to staff on a proposed ordinance. The Council held a study session on August 5, 2013, another meeting on October 7, 2013, and conducted a first reading of proposed Ordinance No. 14C-01 on December 2, 2013.

During the December 2 meeting, the Council directed staff to include the following revisions to the draft ordinance (the revisions are highlighted in yellow in Exhibit 1):

- Two additional specific inquiries for the licensing form: the name of the organization with which the solicitor is affiliated, and proof of the solicitor's affiliation with the organization;
- Clarification of the definition of solicitor;
- · City staff sets the reasonable license fee; and
- Set the license expiration at one-year from issuance, rather than at calendar year end.

Staff will provide public information to advise citizens of the implementation of the ordinance, as well as alert commercial solicitors of the licensing requirements. The City will continue to post information regarding safety tips in dealing with solicitor calls and will identify the State's database to help citizens determine whether a charity is registered with the Secretary of State. The information campaign also will highlight a citizen's choice to display a "No Trespassing" or "No Solicitor" sign if the citizen prefers that a solicitor not approach the citizen's home.

CITY OF MERCER ISLAND ORDINANCE NO. 14C-01

AN ORDINANCE OF THE CITY OF MERCER ISLAND, WASHINGTON REGULATING SOLICITORS AND REQUIRING LICENSES FOR SOLICITORS BY REPEALING AND REPLACING MERCER ISLAND CITY CODE CHAPTER 5.16

WHEREAS, Mercer Island citizens have raised concerns with regard to aggressive solicitors appearing in the City; and

WHEREAS, the City's previous ordinance regulating solicitors was problematic in that it contained provisions similar to those struck down by the federal district court in Western Washington in an injunction granted against the City of Medina; and

WHEREAS, the concerns about the previous ordinance related to constitutionally protected Free Speech; and

WHEREAS, the courts have long held that government may place reasonable "time, place, and manner" restrictions on protected speech, provided that the restrictions are content neutral, narrowly tailored to serve a significant governmental interest, and that they leave open other avenues for communication of the information; and

WHEREAS, on August 5, 2013, the Mercer Island City Council held a study session regarding the legal and constitutional issues related to regulation of solicitors, and

WHEREAS, on October 7, 2013, the Mercer Island City Council discussed the regulation of solicitors in an open public meeting, directing staff to bring back an ordinance on same; and

WHEREAS, first reading of proposed Ordinance No, 14C-01 occurred on December 2, 2013 and second reading of this ordinance occurred on January 6, 2014.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF MERCER ISLAND, WASHINGTON, DOES HEREBY ORDAIN AS FOLLOWS:

Section 1. Repeal and Replace MICC Chapter 5.16. MICC Chapter 5.16, Solicitors and Canvassers is hereby repealed and replaced with MICC Chapter 5.16, Regulation and Licensing of Solicitors as follows:

5.16.010 Definitions.

"Solicitor" means any person who sells, offers for or exposes for sale, or who trades, deals or traffics in any goods or services in the city by going from house to house or from place to place or by indiscriminately approaching individuals. A solicitor is also someone who seeks to obtain gifts or contributions of money, clothing, or other valuable items for the support or benefit of private causes, or any charitable or nonprofit organization, association, or corporation, by going from house to house or from place to place or by indiscriminately approaching individuals.

5.16.020 Soliciting restrictions.

- A. No solicitor shall engage or attempt to engage in the business of soliciting at any home, residence, apartment complex or business that prominently displays a "No Peddlers" or "No Solicitors" sign or any other similar sign that communicates the occupants' desire not to be contacted by solicitors.
- B. No solicitor shall engage in the business of soliciting between the hours of 7:00 p.m. and 10:00 a.m.

5.16.030 License required-Exemptions.

- A. It is unlawful for any person to act as a solicitor unless that person first secures a license in the manner provided in this chapter.
- B. The following are exempt from the licensing and application requirements under this chapter, but must comply with MICC 5.16.020:
 - 1. Newspaper carriers;
- 2. Charitable, religious or nonprofit organizations or corporations which have received tax exempt status under 26 USC Section 501(c)(3);
- 3. Peddlers of fruits, vegetables, berries, eggs or any farm produce edibles raised, gathered, produced or manufactured by such person;
- 4. A person who, after having been specifically requested by another to do so, calls upon that other person for the purpose of displaying goods, literature or giving information about any article, thing, product or service;
 - 5. A person engaged in political or religious speech or solicitation; and
- 6. All persons under the age of eighteen (18) unless employed by another person or organization.

5.16.040 License fees.

The license fees for solicitors shall be established by city staff.

5.16.050 License application – Information required.

- A. Any person desiring to secure a solicitor's license shall apply by filing a written application to the city clerk. The application form shall include:
 - 1. The name, address and telephone number of the applicant;
- 2. In the event the name or address of the applicant has changed within the last two years, each name and address over the last two-year period;
 - 3. The nature or character of the goods, wares, merchandise, or services to be offered by each applicant;

- 4. The name of the organization with which the solicitor is affiliated (if any);
- 5. Proof showing the affiliation with said organization; and
- 6. Other information as reasonably required by city officials.
- B. The city clerk shall deny the applicant the license if the applicant has:
 - 1. Committed any act which would be grounds for suspension or revocation of a license;
- 2. Been previously denied a license under the provisions of this chapter; provided, however, that any applicant denied a license under the provisions of this chapter may reapply if and when the reasons for denial no longer exist; and
 - 3. Made any false or misleading statements in the application.
- C. The city clerk is authorized to promulgate rules regarding the manner and method of payment, including a prohibition or regulation of payment by check, and the form of the application.

5.16.060 Duration of License.

All licenses issued pursuant to this chapter shall expire one year from issuance.

5.16.070 Carrying of license required.

Any solicitor subject to the licensing requirements of this chapter shall carry his or her license at all times and shall display the license upon request by any law enforcement officer or any person solicited.

5.16.080 Revocation of license.

The city may revoke a license upon finding that the solicitor or the solicitor's firm or organization is in violation of any city licensing ordinances.

5.16.090 Appeal procedure.

- A. Whenever the city clerk determines that there is cause for denying any license application or revoking any license issued pursuant to this chapter, the city clerk shall notify the person holding the license by mail with return receipt requested or by personal service on the licensee. If notice is provided by mail, the licensee is deemed notified three days after mailing. The notice shall specify the grounds for the denial or revocation of a license.
- B. The applicant or licensee may appeal the decision of the city clerk to deny or revoke a license by filing a written notice of appeal to the city manager within five business days of the city clerk's decision. The city's hearing examiner shall hear the appeal.
- C. Upon timely receipt of the notice of appeal, the city clerk shall set a date for hearing the appeal, which shall occur within thirty business days of receipt of the appeal, unless otherwise

agreed to by the parties. The city clerk shall provide notice of the date of the hearing to the applicant or licensee at least five business days prior to the hearing date.

- D. The hearing shall be de novo. The hearing examiner may affirm, reverse or modify the city clerk's decision.
- E. The decision of the hearing examiner shall be final. Any person desiring to appeal must file an appropriate action in superior court within 14 days of the hearing examiner's decision.

5.16.100 Violations.

- A. A violation of any provision of this chapter constitutes a Class I civil infraction pursuant to Chapter 7.80 RCW. Each day of any violation is a separate civil infraction.
- B. Issuance and disposition of infractions for violations of this chapter are in accordance with Chapter 7.80 RCW as amended, and any applicable court rules.
- **Section 3.** Severability. If any section, sentence, clause or phrase of this Ordinance shall be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this Ordinance.
- **Section 4. Ratification.** Any act consistent with the authority and prior to the effective date of this Ordinance is hereby ratified and affirmed.
- **Section 5.** Effective Date. This Ordinance shall take effect and be in force on 30 days after its passage and publication.

SUMMARY

On November 18, 2013, the City Council awarded the Fire Station 92 contract to Corp Inc. Construction and asked staff to return in January 2014 with cost-savings measures that could be considered to reduce the almost \$400,000 shortfall created by unfavorable bid results.

BASIC COST-SAVING MEASURES

Staff, Miller Hull, and the project manager began the process of identifying ways to reduce the construction cost. The initial list was roughly thirty items for potential cost savings. A "first cut" was made by staff based on several criteria. Suggestions were eliminated that would:

- Impact the operational effectiveness of the new building.
- Result in repair or replacement costs earlier than planned in the life of the building.
- Require re-design with a cost that likely would outweigh the savings achieved.
- Reduce the sustainability value of the building.
- Slow down construction significantly.

Exhibit 1 details the proposed set of cost-savings measures that staff believes would result in sustainable and realistic savings. These items total roughly \$70,000. Changes being evaluated in mechanical/plumbing systems are not included in this figure. They will be discussed separately in the next section.

PROPOSED MEASURES STILL BEING EVALUATED

At the time of contract award, it was known that the area of mechanical/plumbing was bid at \$177,000 higher than was expected (please note that this amount includes site utility costs as well as internal building systems). Given that this seemed the most promising area for extracting savings, there has been a careful focus on mechanical systems.

As a starting point, Corp Inc. shared detailed information about the bid for mechanical/plumbing immediately after the contract for the project was finalized on December 18. Since then, a series of discussions about cost-saving options have been held, mostly recently a meeting with the contractor and his mechanical/plumbing subcontractor on January 2. Staff will have at least partial results from this work available to share with the Council this evening.

Staff hopes to ultimately identify total savings in the range of \$100,000 from all aspects of construction. That would require identifying another \$30,000 in savings from mechanical/plumbing.

PROCEEDING CAUTIOUSLY

The project team is mindful of the unintended consequences that could result from tackling major changes in mechanical systems. For instance, Miller Hull believes that converting to a less sophisticated HVAC system could save as much as \$30,000. However, the change would require re-design that could take up to a month, and the impact on the construction schedule could be significant. Also, the cost of re-design would need to be negotiated between the City and Miller Hull.

The re-design process for the HVAC system would not be simple because once Miller Hull has completed its work, the mechanical/plumbing subcontractor would need to develop a new cost estimate for the system and complete new construction drawings that would require review and approval by both Miller Hull and the City's Development Services Group.

FINAL ANALYSIS OF POOR BID RESULTS

Miller Hull has consulted with a number of industry professionals and general contractors, including several who bid on Fire Station 92, and learned that the bid climate is changing rapidly as the construction market heats up in Western Washington.

C&N Consultants, the design team cost estimators, monitors market volatility and tries to approximate market uncertainly by building allowances into their estimates that account for escalation. It is clear that in the case of Fire Station 92, the predicted escalation fell far short of the actual market escalation. This was particularly true of trades like plumbing and HVAC, which are busier now than they have been since 2008. Miller Hull believes that because of the amount of overlap between the building plumbing and hydronic systems, it is difficult to pinpoint individual components that may have disproportionately led to the increase in the project cost.

LOOKING AHEAD

Following the initial round of cost-savings, the project team will continue working to identify other opportunities to bring the construction budget down during the project. Results will be shared with Council during project updates throughout construction.

Staff's proposed funding of the \$394,305 construction budget shortfall is summarized in the table below.

Balance to be funded by construction contingency and/or 2013 REET surplus	\$108,981
Less proposed cost savings measures (target)	- 100,000
Less additional savings on Fire Rescue Truck	- 31,344
Less excess levy lid lift proceeds in 2013	- 154,000
F.S. 92 construction budget shortfall	\$394,305

Staff recommends committing \$108,981 in surplus real estate excise tax (REET) and/or General Fund revenues from 2013 to fund the remaining balance, which is less than the \$240,305 appropriated by Council on November 18, 2013. When the project is complete in early 2015, staff will determine how much, if any, of the \$310,190 construction contingency remains. Any project savings up to \$108,981 will be redirected to other CIP funding needs in 2015. Any project savings in excess of \$108,981 will be transferred to the fire apparatus replacement sinking fund as directed by the Council in Ordinance No. 12-04 (fire station and fire apparatus ballot measure), which was adopted on August 6, 2012 (AB 4757).

RECOMMENDATION

Maintenance Director and Finance Director

MOVE TO: Direct staff to seek at least \$100,000 in construction cost savings during the project, with the balance of the budget shortfall being funded by surplus real estate excise tax and/or General

Dear Amy,

Per the Council's direction at the 11/18/13 City Council meeting, the design team has spent the past month working with City staff, the General Contractor, our subconsultants, and our cost estimator to evaluate a number of potential cost saving measures for the above referenced project. A summary of that study, along with a list of recommended potential cost saving modifications, is presented here for your consideration.

Key Dates

The timeline associated with identifying and estimating cost saving items is outlined below:

11/18/13	City Council directs City staff and the design team to research options for reducing total project cost and to report back with findings at the first Council Meeting of 2014.
11/19/13 - 12/13/13	Miller Hull and subconsultants develop a long list of potential cost saving measures based on design phase cost estimate and preliminary analysis of bid results.
12/13/13	Miller Hull receives updated Schedule of Values from Contractor and distributes the list of cost saving measures, along with our team's estimates of anticipated cost savings to the Contractor for review and verification.
12/18/13	Preliminary cost information is provided by Contractor for review. Potential cost saving items along with estimated cost savings were reviewed with the City.

Process Summary

Immediately following the 11/18/13 City Council meeting, we notified our subconsultant team of the Council direction and asked each discipline to propose opportunities for potential scope modifications along with an assessment of any impacts that those modifications would have on the design, program requirements, future flexibility and long-term operations & maintenance of the project. For each of these items, a rough order of magnitude of anticipated cost savings was also developed.

Simultaneously, the City and Contractor were completing the various procedural tasks associated with awarding the contract. Once this was completed, the Contractor provided the team with their Schedule of Values upon which their bid was based. This Schedule of Values was then compared with the design phase estimate and used as a basis for refining the rough order of magnitude costs associated with each of the potential cost savings items.

During this process, the Contractor was able to evaluate each item with relevant subcontractors and determine whether there would be any impact on other trades or the project schedule should the team elect to proceed with that modification. The Contractor then developed preliminary estimates for many of the items initially proposed. Some items initially considered were determined to not be in the best interest of the project due to: limited or no reduction in construction cost; adverse impacts on operation, maintenance, and future flexibility; and delays in procurement and/or installation of critical path items. Those items were dropped from further consideration.



Cost Saving Opportunities

The list of items below represents those items expected to result in tangible cost savings to the project without significant adverse impacts to the design, long term value, future flexibility, constructability, and/or long-term operations & maintenance of the facility. These items are collectively estimated to result in a construction cost savings to the project of +/- \$100,000.

Civil/Utilities/Landscape

Estimated: +/- \$50,000

- 1. Delete undergrounding of overhead power along SE 68th Street.
- 2. Simplify pedestrian paving and replace textured concrete with regular concrete.
- 3. Reduce narrow modular pavers area. Delete all in-grade pavers, except those at the building entry.
- 4. Change storm piping from ductile iron to HDPE or PVC.

Architectural Estimated: +/- \$18,000

- 5. Change roofing material from EPDM to comparable single-ply membrane.
- 6. Delete skylight at stair and associated steel framing components, insulated curbs, cricketing, structurally glazed skylight, sheet metal, sprinkler piping, and interior finishes.
- 7. Delete rooftop mechanical enclosure gate 301A and associated tube steel framing and hardware.
- 8. Substitute sandblasted glass for the translucent frit coating on interior glazing.
- 9. Modify wood grille in Apparatus Bay to allow for face fastening.
- 10. Revise or delete steel plate surround and magnetic surface at maintenance bench alcove.
- 11. Delete felt installation and Mercer Island Fire Department insignia. Delete felt back support at bench in Reception/ Blood Pressure area.

Structural

12. See item No. 6 above.

Mechanical/ Plumbing

Estimated: +/- \$30,000

13. <u>Sustainable Item</u>: Provide ductless HVAC units in lieu of in-slab hydronic heating and cooling. Relatively comparable energy performance can be achieved; however, significant redesign will be required. Estimated time for redesign is one month, which may impact construction schedule and increase potential for change orders.

Electrical Estimated: +/- \$2,000

14. <u>Sustainable Item</u>: Revise lighting controls: Approve Wattstopper DLM to bid against specified nLight system to achieve more favorable pricing without compromising performance.

Along with the items listed above, Miller Hull proposed an additional fifteen options for an estimated savings of between \$20,000-\$25,000. These items were carefully reviewed by the City staff and subsequently removed from consideration due to one more of the factors listed above.

While most of these items are not expected to affect construction sequencing, more complex items like revising the mechanical system could impact the project schedule and reduce the potential cost saving amount due to extended contractor overhead, complications in redesign, and potential change orders. More information on the schedule impacts will be available when the Contractor's Critical Path Management project schedule is submitted for review by the City and design team.

Next Steps

Once a decision is made to proceed with incorporating these items, the design team will fully document and issue them as a change to the contract documents and the Contractor will then be able to provide final pricing. Until that time, the anticipated costs savings are estimates only and are subject to change. While the team has worked diligently to provide reasonable estimates of the cost savings associated with each of these items, it is possible that the final savings realized may be somewhat greater or lower than the range noted above.

We are excited to see the project moving into the construction phase, and we remain committed to assisting the City and the Fire Department in being mindful of other cost reduction opportunities throughout the construction phase of the project.

SUMMARY

The Mercer Island City Council has indicated an interest in adopting 2014 Legislative Priorities for the City of Mercer Island. The Legislative Priorities will be a guide for 2014 work with area legislators. The Draft 2014 Legislative Priorities reflect the Association of Washington Cities (AWC) 2014 Legislative Priorities and other potential legislative items of interest to the City. (Exhibit 1)

2014 STATE LEGISLATIVE SESSION

The 2014 Washington State Legislative Regular Session will run from January 13 to March 13, 2014. The Legislature works within the framework of a two-year cycle. For instance, the entire 2013-2014 Session is considered the 63rd Session of the Legislature and will contain at least two regular sessions. A "long" session was held in 2013 (105 days) and a "short" session is scheduled in 2014 (60 days). There could also be any number of special sessions called by the Governor during each two-year cycle, none of which can last longer than 30 days.

CITY LEGISLATIVE AREAS OF INTEREST

The City has identified four areas of interest for Council consideration:

- 1. Association of Washington Cites (AWC) 2014 Legislative Priorities
- 2. Climate Change through Local Action Legislative Priorities
- 3. Sister City Relationship Legislative Priorities, and
- 4. Public Records Act (PRA) Legislative Priorities

The following provides more detailed information regarding the draft City of Mercer Island Legislative Priorities:

1. Association of Washington Cities (AWC) 2014 Legislative Priorities

AWC's Board of Directors adopted the following focused set of four priorities for the upcoming 2014

session. They reflect a concern that the state is retreating from sharing revenue with cities. During the 2014 legislative session, AWC will ask the Legislature and Governor to reshape the state/city partnership in the following four ways (taken directly from AWC priorities):

"Restore local liquor revenue sharing to the historic revenue sharing formulas
 We need this so we can better fund public safety and other local impacts of liquor consumption. The
 enhanced public safety funding promised in the 2011 liquor privatization initiative hasn't been kept –
 in fact funding has been cut by legislative action and diverted to other uses.

Share new marijuana revenue

The new recreational marijuana industry is subject to up to a 75% state excise tax, but none of this potential revenue is directed to locals to address public safety needs and other local impacts. Cities and counties must enforce marijuana laws and need shared revenue to do this.

- Fund transportation needs now, including providing new local transportation options

 Transportation is critical for our economic health. So, we must have the resources at both the state
 and local levels to maintain and improve our vital transportation systems. Needs vary by region and
 so too must the array of options.
- Halt and refrain from raiding infrastructure funds like the Public Works Trust Fund and Model Toxics Control Accounts and build them back to health
 Our infrastructure is aging and we can't keep up with demands and regulatory requirements. Great cities don't just happen – we need planned and sustained investments in order for Washington to thrive."

2. Climate Change Through Local Action Legislative Priorities

• Leadership Alliance Against Coal

In October 2013, the Council authorized the Mayor to sign three letters expressing concern about the review of proposals to export coal from Northwest ports. The Leadership Alliance Against Coal represents leaders from across the Pacific Northwest, including elected officials from cities, counties, tribal governments and the state legislature, who believe that a single, comprehensive analysis of the impacts of all three proposed Northwest coal terminals is warranted in a combined EIS. The Alliance looks forward to contributing to the State's analysis of the impacts of coal trains and coal exports on the transportation infrastructure, environment, health, economy, and cultural heritage in Washington State.

• Climate Legislative and Executive Workgroup (CLEW)

In late October, Mayor Bruce Bassett began outreach to other Lake Washington mayors to garner support for decisive outcomes from Governor Inslee's climate planning process. The Governor's bipartisan Climate Legislative and Executive Workgroup (CLEW), was scheduled to make recommendations in late December 2013 on actions to meet state climate commitments. As a result of coalition-building efforts by Mayor Bassett and Kirkland Mayor Joan McBride, and with extensive support from King County Executive Dow Constantine's office, a total of 9 regional leaders signed a December 5th letter endorsing an approach to greenhouse gas reduction that is bold, comprehensive, and that uses a market-based solution (i.e. cap-and-trade or carbon tax). This effort is part of the City's expanding commitment to use a variety of tools to address the impacts of climate change through local action and programs on the Island and regionally through influence in policy arenas.

3. Sister City Relationship Legislative Priorities

 Support Sound Cities Association's Policy Position on International Diplomacy Funds Account Legislation

At the December 2, 2013 Council Meeting, the City Council authorized Councilmember Jane Brahm to indicate the City of Mercer Island's support for Sound Cities Association's policy position on international diplomacy funds account legislation. The policy position is as follows:

The Sound Cities Association supports legislation that would allow cities to open and maintain a bank account for which it may accept or request nonpublic gifts, grants, and donations from citizens and other private sources for use in defraying the costs of appropriate hosting of foreign dignitaries, including appropriate gift-giving and reciprocal gift-giving, and international trade hosting, international relations and international missions activities.

Currently, city monies cannot be used for international relations purposes because such use is interpreted as a gift of public funds. State law provides an exception to this prohibition for several state offices, including the Governor and the Lieutenant Governor. Legislation is being proposed that would provide a similar exemption to cities. Changes to State law would allow cities to host foreign dignitaries as part of the sister city relationships numerous Washington municipalities have developed.

4. Public Records Act (PRA) Legislative Priorities

City-Maintained Email Address Lists

Over the past year, the City of Mercer Island has received public records requests for lists of email addresses that the City maintains for various uses, such as the weekly newsletter or special interest updates (i.e. the City's Efforts to Oppose Tolling of I-90 updates). Many constituents, whose email addresses are on the list, have expressed frustration and object to their email address being released as part of the records request because of privacy concerns. Under current PRA regulations, there is no exemption allowing the City to withhold the email address list or portions thereof. The City of Mercer Island would like to continue discussions with State Legislators and other PRA experts regarding supporting the drafting of a bill that would exempt city-maintained email address lists from disclosure under the Public Records Act.

Staff is requesting that Council provide comments and direction on the Draft 2014 Legislative Priorities.

RECOMMENDATION

Assistant City Manager

Review the proposed draft 2014 Legislative Priorities (Exhibit 1) and provide comments to staff for final adoption at the January 21, 2014 Council meeting.

- Ensure fiscal sustainability and flexibility

- Foster and invest in infrastructure and economic development
 Fund transportation needs now, including providing new local transportation options.
 Halt and refrain from raiding infrastructure funds like the Public Works Trust Fund and Model Toxics Control Accounts and build them back to health.

CLIMATE CHANGE THROUGH LOCAL ACTION LEGISLATIVE PRIORITIES:

- Support Leadership Alliance Against Coal
 Support the Alliance in contributing to the State's analysis of the impacts of coal trains
 and coal exports on the transportation infrastructure, environment, health, economy,
 and cultural heritage in Washington State.
- Support Efforts of Climate Legislative and Executive Workgroup (CLEW)
 Support CLEW efforts through regional influence in policy arenas such as endorsing an approach to greenhouse gas reduction that is bold, comprehensive, and that uses a market-based solution (i.e. cap-and-trade or carbon tax).

SISTER CITY RELATIONSHIP LEGISLATIVE PRIORITIES:

 Support Sound Cities Association's Policy Position on International Diplomacy Funds Account Legislation

Join the Sound Cities Association in supporting legislation that would allow cities to open and maintain a bank account for which it may accept or request nonpublic gifts, grants, and donations from citizens and other private sources for use in defraying the costs of appropriate hosting of foreign dignitaries, including appropriate gift-giving and reciprocal gift-giving, and international trade hosting, international relations and international missions activities.
