## PARKING PERMIT REQUIREMENTS

- Only a North Mercer Restricted Parking District (RPD) resident can apply for a temporary contractor permit. A North Mercer RPD permit must already have been issued, or application made, prior to applying for a temporary contractor permit.
- Proof of North Mercer RPD residency must be provided by the permit applicant.
- All fees are non-refundable.
- Only 2 temporary contractor parking permits per residence can be active at one time.
- Permits will be issued at City Hall upon approval of application.
- The temporary contractor parking permit must be conspicuously displayed from the rear-view mirror of the vehicle.
- The address of the North Mercer RPD residence will be displayed on the temporary contractor parking permit.
- Temporary Contractor Parking Permits expire on the date marked on the permit.
- Contractors must have a Mercer Island business license to operate within city limits.

Service vehicles may park during restricted hours in the North Mercer RPD without a permit for up to two consecutive days. A service vehicle is a vehicle not owned by a North Mercer RPD resident, with conspicuous identification of the service it provides permanently affixed to the vehicle, that is used for the purpose of providing short-term repair, construction, landscaping services, delivery, utility, refuse, health commodities, life-support or emergency service for a residence within the restricted district for less than two consecutive days. Personal vehicles used by domestic employees, such as housekeepers or childcare providers, are not considered service vehicles and must park on private property or use a residence guest vehicle parking permit. If a service vehicle will use on-street parking for more than two consecutive parking-restricted days, the owner or occupant of the residence receiving the service must either provide off-street parking, provide a residence guest permit, or obtain a temporary contractor parking permit from the city.

The undersigned hereby applies for (a) guest parking permit(s) in accordance with the foregoing information and pursuant to MICC 10.74, as amended. The undersigned hereby certifies that all information provided herein is true and correct. The undersigned acknowledges that any attempt to make any unauthorized use of any parking permit may result in immediate revocation of all parking permits issued pursuant to MICC 10.74 and a civil fine of up to \$250. Applicant acknowledges that she/he parks at her/his own risk and the City will not be responsible for any loss or damage associated with permit parking.
