REGULAR BUSINESS

Agenda Item #1: Community Facility Regulations

Evan Maxim, CPD Director, gave a presentation on the Community Facility Regulations.

The Commission requested additional information on:

- Cost of an application and preparation of materials for an applicant
- How are underlying development standards address in current zoning? Is there an additional process that could be used to address this?
- Is there a way to have a design code that is enforceable on itself?
- Explore limits on intensity

The Commission discussed the different options presented.

The Commission discussed the problem statement.

The Commission continued to discuss the problem statement.

The Commission would like to make sure that the problem statement includes these concerns:

- Regulations do not address impacts to adjacent neighborhoods and need to be more predictable
- There needs to be a meaningful public process
- Replace "grow" with "thoughtfully evolve"
- Current methods for enforcement may be inadequate
- The intensity in use
- Community input on the process
- Number of things that can result in impacts on neighborhoods including intensity, light, traffic

Agenda Item #2: Wireless Communication Facility / Small Cell Code Amendment

Robin Proebsting, Senior Planner, gave a presentation introducing the Wireless Communication Facility / Small Cell code amendment.

The Commission discussed the scope of the proposed code amendment. They discussed noise, design and location of small cells.

Gregory Bush, Wireless Policy Group on behalf of AT&T answered questions regarding small cells.

The Commission indicated that they would like to proceed with the scope to include:

- Add definitions of new terms
- Review existing standards for potential conflicts with FCC rules
- Review interim design standards
- Modify design standards
- And potentially explore location preference criteria

Evan Maxim, CPD Director, updated the Commission on the November 19, 2019 City Council meeting regarding the code amendment to bring the City into compliance regarding Parcel 12 and the Tully's site.
