# <u>Agenda Item #2</u>: ZTR16-003 Zoning Code Text Amendment related to Comprehensive Plan amendment procedures

Scott Greenberg, Development Services Director presented the proposed code text amendment to the Commission. He explained that the proposed process would split the Comprehensive Plan amendment process into two phases: a preliminary docket and a final docket. Notification of the annual amendment cycle would be disseminated by September 1 and the deadline for proposing amendment requests would be October 1. The Planning Commission would review the preliminary docket of all amendment requests and make a recommendation to City Council on a final docket of amendments to be considered the following calendar year. The City Council would consider the Planning Commission's recommendation at the same time as consideration of the City's budget, to better align planning resource needs with the City's budget.

During discussion of the proposed amendment, the Planning Commission provided comments to be incorporated in the next draft of the amendment.
