Project Title: Roadside Shoulder Improvements West Mercer Way Phase 3

Engineers Estimated Cost (range): \$420,00-\$490,000

Sealed bids will be received, not sent, electronically by the City until **2:00 PM on January 13th, 2022**. Due to the COVID-19 pandemic and the temporary closure of the City Hall building, bidders shall submit their bids in PDF format to the Public Works email address at: publicworks@mercerisland.gov. There will be no public bid opening for this project; bid results will be posted on the City's web page at: <https://www.mercerisland.gov/rfps>.

Work to be performed under this contract includes furnishing all labor, equipment, and materials necessary for the construction of roadway improvements on West Mercer Way from SE 65th Street to SE 70th Street. Work consists of temporary traffic control, pavement removal, hydrant removals and installations, water service relocations, storm drainage pipes and catch basin installations, grading, hot mix asphalt shoulder widening, utility adjustments, and pavement markings.

A single contract is to be awarded to the responsible bidder submitting the lowest responsive bid. The City reserves the right to reject any and all bids and to waive minor irregularities.

Plans, specifications, addenda, and bidders list are available on-line through Builders Exchange of Washington, Inc. at <http://www.bxwa.com>. Click on "Posted Projects", "Public Works", "City of Mercer Island", "Projects Bidding". Builders Exchange manages the official bidders list. Bidders are encouraged to register in order to receive automatic email notification of future addenda and to be placed on the official bidders list.

Plans and specifications are also available at the City of Mercer Island website <http://www.mercerisland.gov/RFPS>. Addenda may not be available or updated on this website. A bid deposit in the amount of five percent (5%) of the bid total price must accompany each bid.

INSTRUCTIONS TO BIDDERS

1. ELIGIBILITY TO BID:

It is the intent of the City to award a contract to the low responsible bidder. Before award, the bidder must meet the following bidder responsibility criteria to be considered a responsible bidder. To be eligible to bid, each Bidder must:

- A. At the time of bid submittal, have a current certificate of registration as a contractor in compliance with chapter 18.27 RCW; and
- B. Have a current Washington Unified Business Identifier (UBI) number; and
- C. If applicable:
 - i. Have Industrial Insurance (workers' compensation) coverage for the bidder's employees working in Washington, as required in Title 51 RCW; and
 - ii. Have a Washington Employment Security Department number, as required in Title 50 RCW; and
 - iii. Have a Washington Department of Revenue state excise tax registration number, as required in Title 82 RCW; and
- D. Not be disqualified from bidding on any public works contract under RCW 39.06.010 or 39.12.065(3); and
- E. Within the three-year period immediately preceding the date of the bid solicitation, not have been determined by a final and binding citation and notice of assessment issued by the department of labor and industries or through a civil judgment entered by a court of limited or general jurisdiction to have willfully violated, as defined in RCW 49.48.082, any provision of chapter 49.46, 49.48 or 49.52 RCW.

A contract shall only be awarded to a Bidder that demonstrates to the City's satisfaction that the Bidder is qualified to perform the Work and is, therefore, a responsible bidder.

2. SUBCONTRACTOR RESPONSIBILITY CRITERIA:

The Bidder must verify responsibility criteria for each first-tier subcontractor, and each subcontractor of any tier that hires other subcontractors must verify responsibility criteria for each of its subcontractors. Upon request of the City the Bidder shall promptly provide documentation to the City demonstrating that the subcontractor(s) meets the subcontractor responsibility criteria below. The requirements of this section apply to all subcontractors regardless of tier.

At the time of subcontract execution, the Bidder shall verify that each of its first-tier subcontractors meets the following bidder responsibility criteria:

- A. Have a current certificate of registration in compliance with chapter 18.27 RCW; and
- B. Have a current Washington Unified Business Identifier (UBI) number; and
- C. If applicable:

- i. Have Industrial Insurance (workers' compensation) coverage for the subcontractor's employees working in Washington, as required in Title 51 RCW; and
 - ii. Have a Washington Employment Security Department number, as required in Title 50 RCW; and
 - iii. Have a Washington Department of Revenue state excise tax registration number as required in Title 82 RCW; and
 - iv. Have an electrical contractor license, if required by Chapter 19.28 RCW; and
 - v. Have an elevator contractor license, if required by Chapter 70.87 RCW; and
- D. Not be disqualified from bidding on any public works contract under RCW 39.06.010 or 39.12.065 (3); and

3. EXAMINATION OF PLANS, SPECIFICATIONS AND SITE:

Each bidder is instructed to examine the Plans, Specifications, Addenda, the site of the proposed improvements, and conduct any other examination and investigation which the bidder may desire to make as to the accuracy of the nature of the work and the difficulties to be encountered. The Bidder shall be responsible for all costs associated with these additional examinations including all restoration work and damages which may be a result of such investigation. Bidders shall consider Federal, State, and local laws and regulations that may affect cost, progress, or performance of the work.

4. ADDITIONAL INFORMATION:

All questions about the meaning or intent of the Contract Documents are to be directed to George Fletcher, CIP Project Manager, in writing by email at george.fletcher@mercerisland.gov.

Interpretations or clarifications considered necessary by the City in response to such questions will be issued by Addenda mailed or delivered to all parties recorded by the Engineer or City as having received the Contract Documents. Questions received less than ten (10) days prior to the date for opening of Bids may not be answered. Only questions answered by formal written Addenda will be binding. Oral and other interpretations or clarifications will be without legal effect.

5. WAGES:

This Contract is subject to Chapters 39.12 and 49.28 RCW, amendments thereto and regulations issued thereunder, relating to prevailing wages, benefits and other requirements. Bidders shall examine and be familiar with such requirements. No claim for additional compensation will be allowed which is based upon a lack of knowledge or a misunderstanding of any such requirements by the Bidder or a failure to include in Bidder's price adequate increases in such wages during the performance of this Contract. A copy of the most recent prevailing wage schedule is in the Appendix of the specifications. Current prevailing wage rates for King County can be obtained from the Washington State Department of Labor and Industries at www.lni.wa.gov/TradesLicensing/PrevWage/.

6. PROGRESS AND COMPLETION:

Time is of the essence for this Project. Progress and completion of the Work shall comply with all requirements herein, and intermediate and final completion dates as may be set forth in the specifications. The submission of a bid constitutes the Bidder's acknowledgement that such progress and completion requirements have been taken into account in formulating a price for this Work.

7. PREVENTION OF ENVIRONMENTAL POLLUTION AND PRESERVATION OF PUBLIC NATURAL RESOURCES:

If awarded the Contract, the Bidder shall fully comply with all such environmental protection laws, ordinances and regulations dealing with prevention and environmental pollution and the preservation of public natural resources that may be applicable to this Project. The cost of such compliance shall be included in the bid prices.

8. BID FORM:

The Bid Form is included in the Contract Documents. The Bid Form must be completed in ink. Bids that contain omissions, erasures or irregularities of any kind may be rejected. Any qualification, addition, limitation or provision attached to or contained in a bid may render the bid non-responsive and not eligible for award. No oral, facsimile, telegraphic or telephonic bids or modifications will be considered.

All bids shall be signed by the Bidder, or the Bidder's authorized representative. If the bid is made:

- A. By an individual, the Bidder's name, signature, and address must be shown;
- B. By a partnership or joint venture, it shall contain the names of each partner, the mailing address of the partnership or joint venture and shall be signed in the firm name, followed by the signature of the person signing, indicating that person's position in the partnership or joint venture;
- C. By a corporation or limited liability company ("LLC"), the name of the state under the laws of which the corporation or LLC is chartered, the name and post office address of the corporation or LLC and the title of the person who signs on behalf of the corporation or LLC must be shown.

Upon the City's request, the Bidder shall provide copies of the articles of incorporation, bylaws, resolutions of board of directors, partnership papers, joint venture agreements, and any other documents evidencing the legal status of the Bidder and the authority of the Bidder's officer or representative who signed the bid on behalf of the Bidder.

The City is not responsible for any cost incurred in responding to this Call for Bids.

9. ACKNOWLEDGEMENT OF ADDENDA:

Each Bidder shall include on the Bid Form specific acknowledgment of receipt of each Addendum issued by the City during the bidding period. If the Bidder does not specifically acknowledge each addendum, the City may reject the bid as non-responsive unless the City determines from delivery records or from inclusion of information in the bid of information contained in the addenda that the Bidder received constructive notice of the addenda.

10. BID SECURITY:

The Bid shall be accompanied by a bid deposit in the amount equal to at least 5% of the Total Bid Price. The bid deposit shall be in one of the following formats and made payable to the City:

- A. A bid guaranty bond, in accordance with and using a form acceptable to the City which contains provisions substantially similar to those in the bid bond form included with the Contract

Documents, duly completed by a guaranty company authorized to carry on business in the state of Washington; or

- B. A postal money order, a certified check, or cashier's check drawn upon a banking institution with a branch office in the state of Washington.

The surety signing the bid guaranty bond shall be registered with the Washington State Insurance Commissioner, and the surety's name shall appear in the current Authorized Insurance Company List in the State of Washington published by the Office of the Insurance Commissioner. A Power of Attorney must accompany the bid guaranty bond and must appoint the surety's true and lawful attorney-in-fact to make, execute, seal and deliver the bid guarantee bond. Failure to submit the required bid security with the Bid shall render the bid non-responsive and the Bid shall be rejected.

11. NON-COLLUSION:

Each bid shall be accompanied by a signed Non-Collusion Declaration in accordance with, and using the form provided by the City. Failure to submit a signed Declaration with the Bid shall render the bid non-responsive and the Bid shall be rejected.

More than one Bid from an individual, firm, partnership, corporation, or association under the same or different names will not be considered. If the City believes that any Bidder is interested in more than one Bid for the work contemplated, all Bids in which such Bidder is interested will be rejected. If the City believes that collusion exists among the Bidders, all Bids will be rejected.

12. DELIVERY OF BID:

Due to the COVID-19 pandemic and temporary closure of City buildings, all bidders shall submit their bids in PDF format via electronic transmission to the Public Works email address at: publicworks@mercerisland.gov. The City will not consider bids received after the time fixed for opening bids in the Advertisement for Bids.

The submission of a Bid will constitute an incontrovertible representation by the Bidder that the Bidder has complied with every requirement of these instructions, that without exception the Bid is premised upon performing the work required by the Contract Documents and such means, methods, techniques, sequences, or procedures of construction as may be indicated in or required by the Contract Documents, and that the Contract Documents are sufficient in scope and detail to indicate and convey understanding of all terms and conditions for performance of the work.

13. MODIFICATION OF BID:

A modification of a Bid will be considered only if the modification is received prior to the time announced for the opening of Bids. All modifications shall be made in writing executed and submitted in the same form and manner as the original Bid.

14. RETURN OF BID SECURITY:

After the bid prices have been compared, the City may return the bid security if, in the City's judgment, the Bidder would not be considered for award. All other Proposal Guarantees will be held until the Contract and the Performance Bond of the successful bidder have been executed.

15. EVALUATION OF BIDS AND BID ERRORS:

After opening the Bids, the City will check them for correctness of extensions of the prices per unit and the total price. If a discrepancy exists between the price per unit and the extended amount of any bid item, the price per unit will control. The total of extensions, corrected where necessary, will be used by the City for award purposes.

Irregular Bids:

- A. A Bid will be considered irregular and will be rejected if:
 - i. The authorized Bid Form furnished by the City is not used or is materially altered;
 - ii. The completed Bid Form contains any unauthorized additions, deletions, alternate bids, or conditions;
 - iii. The bidder adds provisions reserving the right to reject or accept the Award, or enter into the Contract;
 - iv. A price per unit cannot be determined from the Bid Form;
 - v. The Bid Form is not properly executed;
 - vi. An executed non-collusion certificate is not provided; or
 - vii. Proper bid security does not accompany the Bid.

- B. A Bid may be considered irregular and may be rejected if:
 - i. The Bid Form does not include a unit price for every Bid item;
 - ii. Any of the unit prices are excessively unbalanced (either above or below the amount of a reasonable Bid) to the potential detriment of the City;
 - iii. Receipt of Addenda is not acknowledged;
 - iv. A member of a joint venture or partnership and the joint venture or partnership submit Bid Forms for the same project (in such an instance, both Bids may be rejected); or
 - v. If Bid Form entries are not made in ink.

Bids will be evaluated by the City to determine which bid is the apparent lowest, responsive bid.

Bid results will be posted on the City's web page at <https://www.mercerisland.gov/rfps>.

The City, in its sole discretion, reserves the right to waive minor bid errors, informalities, and immaterial irregularities when it is in the City's best interest to do so.

16. EVALUATION OF BIDDER RESPONSIBILITY:

A Contract shall only be awarded to a Bidder that demonstrates to the City's satisfaction that the Bidder is qualified to perform the Work and is, therefore, a responsible bidder.

- A. Bidder Responsibility Criteria. To be determined responsible, the Bidder must, in addition to satisfying the bidder responsibility criteria listed in Section 1. ELIGIBILITY TO BID above:
 - i. Have adequate financial resources to perform the contract, or the ability to obtain them;
 - ii. Have a satisfactory performance record;
 - iii. Have a satisfactory record of integrity and business ethics;

- iv. Have the necessary production, construction, and technical equipment and facilities or the ability to obtain them;
 - v. Be otherwise qualified and eligible to receive an award under applicable laws and regulations;
 - vi. Be in compliance with training requirements in RCW 39.04.350(1)(f); and
 - vii. Provide a statement in accordance with RCW 9A.72.085 verifying compliance with responsible bidder criteria requirement of RCW 39.04.350(1)(g).
- B. Reference Checking. To assist the City in the review of the Bidder's qualifications, the Bidder shall, within five (5) days of being requested to do so by the City, provide the following information:
- i. Past Experience in Similar Projects. Provide a list of all construction contracts (whether completed or in progress) entered into or performed by the Bidder within the past five (5) years for projects similar in scope, time and complexity to the work called for under this Contract. Provide the names of the contracts, the contract price, and the names and phone numbers of the owners.
 - ii. References. Provide a list of five (5) references. References will be asked to rate performance on the following items: overall project performance; acceptable experience and technical knowledge; effective coordination of subcontractors; ability to coordinate and work with utility companies and governmental entities; responsiveness to owner requests; attention to safety; quality and timeliness of submittals, change order proposals, project schedule, schedule updates and other applicable paperwork.

If the Bidder is a joint venture, the Bidder shall submit information for the joint venture if the members have worked together in the past and also information about each member of the joint venture. The Joint Venture Agreement shall be included in the submission.

If the Bidder fails to supply information requested concerning responsibility within the time and the manner specified, the City may base its determination of responsibility upon any available information related to the responsibility criteria or may find the Bidder is not responsible.

The City reserves the right to inspect records, reports and other information which may be maintained by or for the Bidder to the extent necessary, as determined by the City to verify, clarify or otherwise consider the information provided by the Bidder.

17. DETERMINATION OF NON-RESPONSIBILITY:

If the City determines a Bidder to be not responsible, the City will provide, in writing, the reasons for the determination. The Bidder may appeal the determination within ten (10) days of its receipt of the City's determination of non-responsibility by presenting additional information to the City. The City shall consider the additional information before issuing its final determination. If the City's final determination affirms that the Bidder is not responsible, the City shall not execute a contract with any other bidder until two (2) business days after the Bidder determined to be not responsible has received the final determination.

18. CONTRACT AWARD:

If a Contract is awarded, the City will award the contract to the responsible bidder that submits the lowest total responsive bid for the schedule(s) selected by City after bid opening and prior to award.

If the Contract is to be awarded, City will give the successful Bidder a Notice of Award within sixty (60) days after the day of the Bid opening. No other act of the City or others will constitute acceptance of a Bid.

The City reserves the right to request bidders to extend the effective period of their bids.

19. REJECTION OF ALL BIDS:

The City reserves the right to reject any or all Bids at any time up to actual execution of the Public Works Contract, even if there has been an award of the Contract.

Any or all Bids will be rejected if the City has reason to believe that collusion exists among the Bidders.

20. EXECUTION OF PUBLIC WORKS CONTRACT:

The Bidder to whom award is made shall execute a written Public Works Contract with the City on the form provided, shall secure all insurance, and shall furnish all certificates, endorsements and bonds required by the Contract Documents within ten (10) calendar days after receipt of the forms from the City. Failure or refusal to execute the Public Works Contract as herein provided or to conform to any of the stipulated requirements in connection therewith shall be just cause for annulment of the award and forfeiture of the Bid security. If the lowest responsive, responsible Bidder refuses or fails to execute the Public Works Contract, the City may award the Contract to the second lowest responsive, responsible Bidder. If the second lowest responsive, responsible Bidder refuses or fails to execute the Public Works Contract, the City may award the contract to the third lowest responsive, responsible Bidder. On the failure or refusal of such second or third lowest Bidder to execute the Agreement, each such Bidder's Bid securities shall be likewise forfeited to the City.

21. BID PROTEST PROCEDURES:

- A. Form of Protest. In order to be considered, a Protest shall be in writing, addressed and delivered to the attention of the project manager at the City of Mercer Island, 9611 SE 36th Street, Mercer Island, Washington 98040 The Protest shall include the following:
 - i. The name, address, and phone number of the Bidder protesting, or the authorized representative of the Bidder;
 - ii. A complete, detailed statement of all grounds for protest, supporting authority, and any supporting documentation. Supplemental information will not be considered unless the supplementation contains information not available at the time of protest;
 - iii. The specific ruling or relief requested; and
 - iv. Evidence that all persons with a financial interest in the procurement have been given notice of the Protest or if such persons are unknown, a statement to that effect.

- B. Who May Protest:
 - i. Protests based on specifications: Any prospective Bidder.
 - ii. Protests following Bid opening: Any Bidder with a substantial financial interest in the award of a Contract.

- C. Time to Protest:

- i. Protests based on specifications or other terms in the Contract Documents must be received by the City no later than ten (10) calendar days prior to the date established for submittal of Bids.
 - ii. The City must receive protests based on other circumstances within five (5) calendar days after the bids are opened and publicly read.
 - iii. In no event shall a Protest be considered if all bids are rejected or after execution of the Contract.

- D. Determination of Protest. Upon receipt of a timely written Protest, the City shall investigate the Protest and shall respond in writing to the Protest prior to the award of Contract. If protest is submitted in accordance with the procedures set forth above, the City will not execute a contract any sooner than two (2) business days after the City's decision on the Protest.

- E. Failure to Comply. Failure to comply with the procedures set forth herein may render a Protest untimely or inadequate and may result in rejection thereof by the City.

- F. Exhaustion of Administrative Remedies. By submitting a bid, the Bidder agrees the Bidder's compliance with the protest procedures set forth herein are a mandatory condition precedent to the Bidder initiating a lawsuit against the City.

- G. Venue. By submitting a bid, the Bidder acknowledges and agrees that a lawsuit or action related to or arising out of this procurement shall be brought in the Superior Court of King County, Washington.

III: BIDDER'S CHECK LIST

ALL BIDDERS must properly complete, execute and submit the following with their bids:

1. **NON-COLLUSION CERTIFICATE:** Failure to submit the certificate shall make the bid non-responsive and not eligible for award.
2. **BID FORM:** Bidders must bid on all items contained in the Bid Form and the Form must be signed. The omission or deletion of any bid item may render the bid non-responsive and result in the rejection of the bid. Bidders are reminded to comply with RCW 39.30.060.
3. **BID GUARANTY BOND:** Failure to furnish a bid deposit of a minimum of five percent (5%) shall make the bid non-responsive and not eligible for award.
4. **BIDDERS QUALIFICATION CERTIFICATE:** To be completed and signed. The City reserves the right to check all statements and to judge the adequacy of the bidder's qualifications.

THIS PUBLIC WORKS CONTRACT ("Contract") dated _____, 2022, is effective on the date the Contract is fully executed by the Parties. The Parties to this Contract are the CITY OF MERCER ISLAND, a Washington municipal corporation ("City" or "Owner"), and _____, a Washington Corporation ("Contractor").

A. The City desires to retain an independent contractor to furnish all labor and materials necessary to perform work at various street locations, Mercer Island, Washington ("Property"); and

B. The Contractor has the requisite skill and experience to perform such work and has submitted a proposal dated _____, 2022 to complete such work ("Proposal").

NOW, THEREFORE, the parties ("Parties") agree to the following terms and conditions:

1. SERVICES BY CONTRACTOR

1.1 Description of Work. Contractor shall perform all work and furnish all tools, materials, supplies, equipment, labor and other items incidental thereto necessary for the construction and completion of the work, more particularly described in the Contract Documents for the ROADSIDE SHOULDER IMPROVEMENTS WEST MERCER WAY PHASE 3 project, including this Public Works Contract, the Contractor's completed Bid Form, the City's General Terms and Conditions (February 2013 ed.), any Supplemental and/or Special Conditions, Technical Specifications, Drawings and Addenda, which documents are incorporated by this reference, ("Work"), which Work shall be completed to the City's satisfaction, within the time period prescribed by the City and pursuant to the direction of the City Manager or his or her designee.

1.2 Completion Date. The Work shall be commenced within ten (10) days of receipt by the Contractor of the City's Notice to Proceed and shall be Substantially Completed within **50 working days**, (the "Contract Time") as may be extended in accordance with the Contract Documents. In the event the Work is not completed within the time specified, Contractor agrees to pay to the City liquidated damages in the amount set forth in Section 1.3 of this Contract.

1.3 Liquidated Damages. TIME IS OF THE ESSENCE OF THIS CONTRACT. Delays inconvenience the residents of Mercer Island and cost taxpayers undue sums of money, adding time needed for administration, engineering, inspection and supervision. It is impractical for the City to calculate the actual cost of delays. Accordingly, the Contractor agrees to pay liquidated damages as follows: Liquidated damages for failure to achieve timely Substantial Completion shall be in the amount of \$250.00 per day.

1.4 Performance Standard. Contractor shall perform the Work in a manner consistent with accepted practices for highly skilled and competent contractors performing this type of work in this area.

1.5 Compliance with Laws. Contractor shall perform the Work in accordance with all applicable federal, state and City laws, including but not limited to all City ordinances, resolutions, standards or policies, as now existing or hereafter adopted or amended, and obtain all necessary permits and pay all permit, inspection or other fees, at its sole cost and expense.

1.6 Utility Location. Contractor is responsible for locating any underground utilities affected by the Work and is deemed to be an excavator for purposes of Chapter 19.122 RCW, as amended. Contractor shall be responsible for compliance with Chapter 19.122 RCW, including utilization of the "one call" locator system before commencing any excavation activities.

1.7 Air Environment. Contractor shall fully cover any and all loads of loose construction materials including without limitation, sand, dirt, gravel, asphalt, excavated materials, construction debris, etc., to protect said materials from air exposure and to minimize emission of airborne particles to the ambient air environment within the City of Mercer Island.

2. TERM

This Contract shall commence on the effective date of this Contract and continue until the Work is complete, and formally accepted by City, and all warranties have expired.

3. REQUISITE SKILL

The Contractor warrants that it has the requisite skill to complete the Work, and is appropriately accredited and licensed by all applicable agencies and governmental entities, including but not limited to being registered to do business in the City of Mercer Island by obtaining a City of Mercer Island business registration. Contractor represents that it has visited the site and is familiar with all of the plans and specifications in connection with the completion of the Work.

4. COMPENSATION

4.1 Total Compensation. In consideration of the Contractor performing the Services, the City agrees to pay the Contractor an amount not to exceed Dollars (\$), based on the Proposal submitted by Contractor dated and as may be adjusted under the Contract Documents.

4.2 Contractor Responsible for Taxes. Except as otherwise stated in the Contract Documents, the Contractor shall be solely responsible for the payment of any taxes imposed by any lawful jurisdiction as a result of the performance and payment of this Contract.

4.3 Method of Payment. Payment by the City for the Work will only be made after the Work has been completed, a voucher or invoice is submitted in a form satisfactory to the City, and such invoice is approved by the appropriate City representative. 4.4 Retainage. Pursuant to Chapter 60.28 RCW, five percent (5%) of the Total Compensation shall be retained by the City to assure payment of Contractor's state taxes as well as payment of subcontractors, suppliers and laborers. Upon execution of this Contract, Contractor shall

complete, execute and deliver to the City the Contractor's Retainage Agreement set forth in the Contract Documents. No payments shall be made by the City from the retained percentage fund ("Fund") nor shall the City release any retained percentage escrow account to any person, until the City has received from the Department of Revenue a certificate that all taxes, increases, and penalties due from the Contractor and all taxes due and to become due with respect to the Contract have been paid in full or that they are, in the Department's opinion, readily collectible without recourse to the State's lien on the retained percentage. Upon non-payment by the general contractor, any supplier or subcontractor may file a lien against the retainage funds, pursuant to Chapter 60.28 RCW. Subcontractors or suppliers are required to give notice of any lien within thirty (30) days of the completion of the Work and in the manner provided in RCW 39.08.030. Within sixty (60) days after completion of all Work on this Contract, the City shall release and pay in full the money held in the Fund, unless the City becomes aware of outstanding claims made against this Fund.

5. EQUAL OPPORTUNITY EMPLOYER

In all Contractor services, programs or activities, and all Contractor hiring and employment made possible by or resulting from this Contract, there shall be no discrimination by Contractor or by Contractor's employees, agents, subcontractors or representatives against any person because of sex, sexual orientation, age (except minimum age and retirement provisions), race, color, creed, national origin, marital status or the presence of any disability, including sensory, mental or physical handicaps, unless based upon a bona fide occupational qualification in relationship to hiring and employment. This requirement shall apply, but not be limited to the following: employment, advertising, layoff or termination, rates of pay or other forms of compensation, and selection for training, including apprenticeship. Contractor shall not violate any of the terms of Chapter 49.60 RCW, Title VII of the Civil Rights Act of 1964, the Americans With Disabilities Act, Section 504 of the Rehabilitation Act of 1973 or any other applicable federal, state or local law or regulation regarding non-discrimination. Any material violation of this provision shall be grounds for termination of this Contract by the City and, in the case of the Contractor's breach, may result in ineligibility for further City agreements.

6. INDEPENDENT CONTRACTOR/CONFLICT OF INTEREST

It is the intention and understanding of the Parties that the Contractor shall be an independent contractor and that the City shall be neither liable nor obligated to pay Contractor sick leave, vacation pay or any other benefit of employment, nor to pay any social security or other tax which may arise as an incident of employment. The Contractor shall pay all income and other taxes as due. Industrial or any other insurance which is purchased for the benefit of the City, regardless of whether such may provide a secondary or incidental benefit to the Contractor, shall not be deemed to convert this Contract to an employment contract. It is recognized that Contractor may perform work during the Term of this Contract for other third parties; provided, however, that such performance of other work shall not conflict with or interfere with the Contractor's ability to perform the Work. Contractor agrees to resolve any such conflicts of interest in favor of the City.

7. INDEMNIFICATION

7.1 Indemnification and Hold Harmless.

- A. The Contractor shall protect, defend, indemnify, and hold harmless City, its elected officials, officers, agents and employees, from any and all claims, demands, suits, penalties, losses, damages, judgments, or costs of any kind whatsoever (hereinafter

“claims”), arising out of or in any way resulting from the Contractor’s officers, employees, agents, and/or subcontractors of all tiers, acts or omissions, performance or failure to perform this Contract, to the maximum extent permitted by law or as defined by RCW 4.24.115, now enacted or as hereinafter amended.

- B. The Contractor’s obligations under this section shall include, but not be limited to,
- i. The duty to promptly accept tender of defense and provide defense to City at the Contractor’s own expense.
 - ii. The duty to indemnify and defend City, its elected officials, officers, agents and employees, from any claim, demand, and/or cause of action brought by or on behalf of any of its employees, or agents. The foregoing duty is specifically and expressly intended to constitute a waiver of the Contractor’s immunity under Washington’s Industrial Insurance Act, RCW Title 51, as respects City with a full and complete indemnity and defense of claims made by the Contractor’s employees. The parties acknowledge that these provisions were mutually negotiated upon by them.
 - iii. To the maximum extent permitted by law, the Contractor shall indemnify and defend City, its elected officials, officers, agents and employees, from and be liable for all damages and injury which shall be caused to owners of property on or in the vicinity of the work or which shall occur to any person or persons or property whatsoever arising out of the performance of this Contract, whether or not such injury or damage is caused by negligence of the Contractor or caused by the inherent nature of the work specified.
- C. City may, in its sole discretion, (1) withhold amounts sufficient to pay the amount of any claim for injury, and/or (2) pay any claim for injury of which City may have knowledge, regardless of the formalities of notice of such claim, arising out of the performance of this Contract.
- D. Any amount withheld will be held until the Contractor secures a written release from the claimant, obtains a court decision that such claim is without merit, or satisfies any judgment on such claim. In addition, the Contractor shall reimburse and otherwise be liable for claims costs incurred by City, including, without limitation, costs for claims adjusting services, attorneys, engineering, and administration.
- E. In the event City incurs any judgment, award, and/or costs arising therefrom, including attorneys’ fees, to enforce the provisions of this article, all such fees, expenses, and costs shall be recoverable from the Contractor.
- F. This provision has been mutually negotiated by the City and the Contractor.

7.2 Survival. The provisions of this Section shall survive the expiration or termination of this Contract with respect to any event occurring prior to such expiration or termination.

8. INSURANCE

The Contractor agrees to carry as a minimum, the following insurance against claims for injuries to persons or damage to property which may arise from or in connection with the performance

of the Work by Contractor, its agents, representatives, employees or subcontractors with a carriers having a current A.M. Best rating of not less than A:VII:

8.1 Workers' Compensation and Employer's Liability Insurance in amounts sufficient pursuant to the laws of the State of Washington.

8.2 Commercial general liability insurance shall be written on Insurance Services Office (ISO) occurrence form CG 00 01 and shall cover liability arising from premises, operations, independent contractors, products-completed operations, stop gap liability, personal injury and advertising injury, and liability assumed under an insured contract. The Commercial General Liability insurance shall be endorsed to provide the Aggregate Per Project Endorsement ISO form CG 25 03 11 85. There shall be no endorsement or modification of the Commercial General Liability insurance for liability arising from explosion, collapse or underground property damage. The City shall be named as an additional insured under the Commercial General Liability insurance policy with respect to the Work performed for the City using ISO Additional Insured endorsement CG 20 10 10 01 and Additional Insured Completed Operations endorsement CG 20 37 10 01 or substitute endorsements providing equivalent coverage with limits of no less than \$1,000,000 each occurrence, \$2,000,000 general aggregate and a \$2,000,000 products-completed operations aggregate limit.

8.3 Automobile liability insurance covering all owned, non-owned, hired and leased vehicles. Coverage shall be written on ISO form CA 00 01 or a substitute form providing equivalent liability coverage. If necessary, the policy shall be endorsed to provide contractual liability coverage with combined single limits for bodily injury and property damage of not less than \$1,000,000 per accident.

8.4 Asbestos Abatement or Hazardous Materials. If asbestos abatement or hazardous materials work is performed, Contractor shall review coverage with the City Attorney's office and provide scope and limits of coverage that are appropriate for the scope of Work and are satisfactory to the City. Contractor shall not commence any Work until its coverage has been approved by the City Attorney's office.

The City shall be named as additional insured on all such insurance policies, with the exception of workers' compensation coverages. Contractor shall provide certificates of insurance, concurrent with the execution of this Contract, evidencing such coverage and, at City's request, furnish the City with copies of all insurance policies and with evidence of payment of premiums or fees of such policies. All insurance policies shall contain a clause of endorsement providing that they may not be terminated or materially amended during the Term of this Contract, except after thirty (30) days prior written notice to the City. Contractor shall include all subcontractors as insureds under its policies or shall furnish separate certificates and endorsements for each subcontractor. All coverages for subcontractors shall be subject to all of the same insurance requirements as stated herein for the Contractor. Contractor's failure to maintain such insurance policies shall be grounds for the City's immediate termination of this Contract.

The provisions of this Section shall survive the expiration or termination of this Contract with respect to any event occurring prior to such expiration or termination.

9. PERFORMANCE/PAYMENT BOND OR ADDITIONAL RETAINAGE

Pursuant to RCW 39.08.010, Contractor shall provide Performance Bond and Payment Bond each in an amount equal to 100% of the amount of this Contract to cover the performance of all provisions of this Contract and the payment of all laborers and suppliers. The Contract bonds shall be in a form set forth in the Contract Documents. The Contract bond shall assure that the Contractor will faithfully perform all of the provisions of the Contract as well as pay all laborers, mechanic subcontractors, materialmen and suppliers. Contractor's obligations under this Contract shall not be limited to the bond amount.

Alternatively, pursuant to RCW 39.08.010, on contracts of Fifty-Five Thousand Dollars (\$55,000) or less, at the option of the Contractor, the City may, in lieu of a bond, retain ten percent (10%) of the Contract amount for a period of thirty (30) days after the date of final acceptance, or until receipt of all necessary releases from the Department of Revenue and the Department of Labor and Industries and settlement of any liens filed under Chapter 60.28 RCW, whichever is later.

10. SAFETY

Contractor shall take all necessary precautions for the safety of its employees on the work site and shall comply with all applicable provisions of federal, state and municipal safety and health laws and codes, including without limitation, all OSHA/WISHA requirements, Safety and Health Standards for Construction Work (Chapter 296-155 WAC), General Safety and Health Standards (Chapter 296-24 WAC), and General Occupational Health Standards (Chapter 296-62 WAC). Contractor shall erect and properly maintain, at all times, all necessary guards, barricades, signals and other safeguards at all unsafe places at or near the Work for the protection of its employees and the public, safe passageways at all road crossings, crosswalks, street intersections, post danger signs warning against known or unusual hazards and do all other things necessary to prevent accident or loss of any kind. Contractor shall protect from damage all water, sewer, gas, steam or other pipes or conduits, and all hydrants and all other property that is likely to become displaced or damaged by the execution of the Work. The Contractor shall, at its own expense, secure and maintain a safe storage place for its materials and equipment and is solely responsible for the same.

11. PREVAILING WAGES

11.1 Wages of Employees. This Contract is subject to the minimum wage requirements of Chapter 39.12 of the Revised Code of Washington, as now existing or hereafter amended or supplemented. In the payment of hourly wages and fringe benefits to be paid to any of Contractor's laborers, workpersons and/or mechanics, Contractor shall not pay less than the "prevailing rate of wage" for an hour's work in the same trade or occupation in the locality within the State of Washington where such labor is performed, as determined by the Industrial Statistician of the Department of Labor and Industries of the State of Washington. Prevailing wages paid pursuant to this Agreement shall be the prevailing wage rates which are in effect on the date when the bids, proposals, or quotes were required to be submitted to the City.

The State of Washington prevailing wage rates applicable for this public works project, which is located in King County, may be found at the following website address of the Department of Labor and Industries: <https://fortress.wa.gov/lni/wagelookup/prvWagelookup.aspx>. A copy of the applicable prevailing wage rates are also available for viewing at the office of the City located at 9611 SE 36th St, Mercer Island, WA 98040. Upon request, the City will mail a hard copy of the applicable prevailing wages for this project.

11.2 Reporting Requirements. Contractor shall comply with all reporting requirements of the Department of Labor and Industries of the State of Washington. Upon the execution of this Contract, Contractor shall complete and file a Statement of Intent to Pay Prevailing Wages with the Department of Labor and Industries. If requested by the City, the Contractor shall provide certified payroll records for its employees and the employees of its subcontractors. Upon completion of the Work, Contractor shall complete and file an Affidavit of Wages Paid with the Department of Labor and Industries. Contractor shall deliver copies of both the Statement of Intent to Pay Prevailing Wages and the Affidavit of Wages Paid, certified by the Department of Labor and Industries, to the City.

12. SUBCONTRACTOR RESPONSIBILITY

Contractor shall verify responsibility criteria for each first tier subcontractor, and a subcontractor of any tier that hires other subcontractors must verify responsibility criteria for each of its subcontractors. Verification shall include that each subcontractor, at the time of subcontract execution, meets the responsibility criteria listed in the Instructions to Bidders and possesses an electrical contractor license, if required by chapter 19.28 RCW, or an elevator contractor license, if required by chapter 70.87 RCW. This verification requirement must be included in every public works subcontract or every tier.

13. OWNERSHIP OF DOCUMENTS

All originals and copies of work product, including plans, sketches, layouts, designs, design specifications, records, files computer disks, magnetic media, all finished or unfinished documents or material which may be produced or modified by Contractor while performing the Work shall become the property of the City and shall be delivered to the City at its request.

14. CONFIDENTIALITY

If it is necessary to provide proprietary information, the Contractor shall clearly mark the information on each page of the document(s) as "Proprietary and Confidential". The City is subject to laws regarding the disclosure of public records and document. Proposals and other materials, submitted by the Contractor become public record and may be subject to public disclosure, in whole or in part, and may be released by the City in the event of a request for disclosure. In the event the City receives a public record request for information and the Contractor has marked the requested document as "Proprietary and Confidential", the City shall notify the Contractor of such request and withhold disclosure of such information for not less than five (5) business days, to permit the Contractor to seek judicial protection of such information; provided that the Contractor shall be solely responsible for all attorney fees and costs in such action and shall save and hold harmless the City from any costs, attorneys fees or penalty assessments under Chapter 42.56 RCW for withholding or delaying public disclosure of such information.

15. BOOKS AND RECORDS

The Contractor agrees to maintain books, records, and documents which sufficiently and properly reflect all direct and indirect costs related to the performance of this Contract and such accounting procedures and practices as may be deemed necessary by the City to assure proper accounting of all funds paid pursuant to this Contract. These records shall be subject at all reasonable times to inspection, review or audit by the City, its authorized representative, the State Auditor, or other governmental officials authorized by law to monitor this Contract.

16. CLEAN UP

At any time ordered by the City and immediately after completion of the Work, the Contractor shall, at its own expense, clean up and remove all refuse and unused materials of any kind resulting from the Work. In the event the Contractor fails to perform the necessary clean up, the City may, but in no event is it obligated to, perform the necessary clean up and the costs thereof shall be immediately paid by the Contractor to the City and/or the City may deduct its costs from any remaining payments due to the Contractor.

17. GENERAL PROVISIONS

This Contract, the Contract Documents and any supporting contract documents contain all of the agreements of the Parties with respect to any matter covered or mentioned in this Contract and no prior agreements or understandings shall be effective for any purpose. No provision of this Contract may be amended except by written agreement of the Parties. Any provision of this Contract which is declared invalid, void or illegal shall in no way affect, impair, or invalidate any other provision hereof and such other provisions shall remain in full force and effect. The Contractor shall not transfer or assign, in whole or in part, any or all of its obligations and rights hereunder without the prior written consent of the City. In the event the City consents to any such assignment or transfer, such consent shall in no way release the Contractor from any of its obligations or liabilities under this Contract. Subject to the preceding sentence, this Contract shall be binding upon and inure to the benefit of the Parties' successors in interest, heirs and assigns. In the event the City or the Contractor defaults on the performance of any terms in this Contract, and the Contractor or City places the enforcement of the Contract or any part thereof, or the collection of any monies due, in the hands of an attorney, or files suit, each Party shall pay all its own attorneys' fees and expenses. The venue for any dispute related to this Contract shall be King County, Washington. Failure of the City to declare any breach or default immediately upon occurrence thereof, or delay in taking any action in connection with, shall not waive such breach or default. This Contract shall be governed by and interpreted in accordance with the laws of the State of Washington. Each individual executing this Contract on behalf of the City and Contractor represents and warrants that such individuals are duly authorized to execute this Contract. Time is of the essence of this Contract and each and all of its provisions in which performance is a factor. Adherence to completion dates is essential to the Contractor's performance of this Contract.

SPECIAL PROVISIONS

INTRODUCTION TO THE SPECIAL PROVISIONS

(August 14, 2013 APWA GSP)

The Work on this project shall be accomplished in accordance with the *Standard Specifications for Road, Bridge and Municipal Construction*, 2018 edition, as issued by the Washington State Department of Transportation (WSDOT) and the American Public Works Association (APWA), Washington State Chapter (hereafter "Standard Specifications"). The Standard Specifications, as modified or supplemented by the Amendments to the Standard Specifications and these Special Provisions, all of which are made a part of the Contract Documents, shall govern all of the Work.

These Special Provisions are made up of both General Special Provisions (GSPs) from various sources, which may have project-specific fill-ins; and project-specific Special Provisions. Each Provision either supplements, modifies, or replaces the comparable Standard Specification, or is a new Provision. The deletion, amendment, alteration, or addition to any subsection or portion of the Standard Specifications is meant to pertain only to that particular portion of the section, and in no way should it be interpreted that the balance of the section does not apply.

The project-specific Special Provisions are not labeled as such. The GSPs are labeled under the headers of each GSP, with the effective date of the GSP and its source. For example:

(March 8, 2013 APWA GSP)

(April 1, 2013 WSDOT GSP)

(Special Provision)

The Special Provisions noted herein are City of Mercer Island special provisions and are in addition to, or as a replacement for, the Standard Specifications. Where sections are marked "Revised Section," the specifications herein are intended to be a revision or partial revision to the Specifications section noted. Where sections are marked as "New Section," the specifications herein will be an addition to the Standard Specifications section noted. Where sections are marked "Supplement," the specifications herein are to be a supplement to the Standard Specifications section noted. Sections of the Standard Specifications that are not modified or replaced as addressed in these Special Provisions shall remain as described in the Standard Specifications.

Also incorporated into the Contract Documents by reference are:

- *Manual on Uniform Traffic Control Devices for Streets and Highways*, currently adopted edition, with Washington State modifications, if any
- *Standard Plans for Road, Bridge and Municipal Construction*, WSDOT/APWA, current edition

Contractor shall obtain copies of these publications, at Contractor's own expense.

1-01 DEFINITIONS AND TERMS

1-01.3 Definitions

(January 4, 2016 APWA GSP)

Dates

Bid Opening Date

The date on which the Contracting Agency publicly opens and reads the Bids.

Award Date

The date of the formal decision of the Contracting Agency to accept the lowest responsible and responsive Bidder for the Work.

Contract Execution Date

The date the Contracting Agency officially binds the Agency to the Contract.

Notice to Proceed Date

The date stated in the Notice to Proceed on which the Contract time begins.

Substantial Completion Date

The day the Engineer determines the Contracting Agency has full and unrestricted use and benefit of the facilities, both from the operational and safety standpoint, any remaining traffic disruptions will be rare and brief, and only minor incidental work, replacement of temporary substitute facilities, plant establishment periods, or correction or repair remains for the Physical Completion of the total Contract.

Physical Completion Date

The day all of the Work is physically completed on the project. All documentation required by the Contract and required by law does not necessarily need to be furnished by the Contractor by this date.

Completion Date

The day all the Work specified in the Contract is completed and all the obligations of the Contractor under the contract are fulfilled by the Contractor. All documentation required by the Contract and required by law must be furnished by the Contractor before establishment of this date.

Final Acceptance Date

The date on which the Contracting Agency accepts the Work as complete.

Supplement this Section with the following:

All references in the Standard Specifications, Amendments, or WSDOT General Special Provisions, to the terms "Department of Transportation", "Washington State Transportation

Commission”, “Commission”, “Secretary of Transportation”, “Secretary”, “Headquarters”, and “State Treasurer” shall be revised to read “Contracting Agency”.

All references to the terms “State” or “state” shall be revised to read “Contracting Agency” unless the reference is to an administrative agency of the State of Washington, a State statute or regulation, or the context reasonably indicates otherwise.

All references to “State Materials Laboratory” shall be revised to read “Contracting Agency designated location”.

All references to “final contract voucher certification” shall be interpreted to mean the Contracting Agency form(s) by which final payment is authorized, and final completion and acceptance granted.

Additive

A supplemental unit of work or group of bid items, identified separately in the Bid Proposal, which may, at the discretion of the Contracting Agency, be awarded in addition to the base bid.

Alternate

One of two or more units of work or groups of bid items, identified separately in the Bid Proposal, from which the Contracting Agency may make a choice between different methods or material of construction for performing the same work.

Business Day

A business day is any day from Monday through Friday except holidays as listed in Section 1-08.5.

Contract Bond

The definition in the Standard Specifications for “Contract Bond” applies to whatever bond form(s) are required by the Contract Documents, which may be a combination of a Payment Bond and a Performance Bond.

Contract Documents

See definition for “Contract”.

Contract Time

The period of time established by the terms and conditions of the Contract within which the Work must be physically completed.

Notice of Award

The written notice from the Contracting Agency to the successful Bidder signifying the Contracting Agency’s acceptance of the Bid Proposal.

Notice to Proceed

The written notice from the Contracting Agency or Engineer to the Contractor authorizing and directing the Contractor to proceed with the Work and establishing the date on which the Contract time begins.

Traffic

Both vehicular and non-vehicular traffic, such as pedestrians, bicyclists, wheelchairs, and equestrian traffic.

1-02 BID PROCEDURES AND CONDITIONS

1-02.1 Prequalification of Bidders

Delete this section and replace it with the following:

1-02.1 Qualifications of Bidder
(January 24, 2011 APWA GSP)

Before award of a public works contract, a bidder must meet at least the minimum qualifications of RCW 39.04.350(1) to be considered a responsible bidder and qualified to be awarded a public works project.

1-02.2 Plans and Specifications

(June 27, 2011 APWA GSP)

Delete this section and replace it with the following:

Information as to where Bid Documents can be obtained or reviewed can be found in the Call for Bids (Advertisement for Bids) for the work.

After award of the contract, plans and specifications will be issued to the Contractor at no cost as detailed below:

1-02.4(2) Subsurface Information

(March 8, 2013 APWA GSP)

The second sentence in the first paragraph is revised to read:

The Summary of Geotechnical Conditions and the boring logs, if and when included as an appendix to the Special Provisions, shall be considered as part of the Contract.

1-02.5 Proposal Forms

(July 31, 2017 APWA GSP)

Delete this section and replace it with the following:

The Proposal Form will identify the project and its location and describe the work. It will also list estimated quantities, units of measurement, the items of work, and the materials to be furnished at the unit bid prices. The bidder shall complete spaces on the proposal form that call for, but are not limited to, unit prices; extensions; summations; the total bid amount; signatures; date; and, where applicable, retail sales taxes and acknowledgment of addenda; the bidder's name, address, telephone number, and signature; the bidder's UDBE/DBE/M/WBE commitment, if applicable; a State of Washington Contractor's Registration Number; and a Business License Number, if applicable. Bids shall be completed by typing or shall be printed in ink by hand, preferably in black ink. The required certifications are included as part of the Proposal Form.

The Contracting Agency reserves the right to arrange the proposal forms with alternates and additives, if such be to the advantage of the Contracting Agency. The bidder shall bid on all alternates and additives set forth in the Proposal Form unless otherwise specified.

1-02.7 Bid Deposit

(March 8, 2013 APWA GSP)

Supplement this section with the following:

Bid bonds shall contain the following:

1. Contracting Agency-assigned number for the project;
2. Name of the project;
3. The Contracting Agency named as obligee;
4. The amount of the bid bond stated either as a dollar figure or as a percentage which represents five percent of the maximum bid amount that could be awarded;
5. Signature of the bidder's officer empowered to sign official statements. The signature of the person authorized to submit the bid should agree with the signature on the bond, and the title of the person must accompany the said signature;
6. The signature of the surety's officer empowered to sign the bond and the power of attorney.

If so stated in the Contract Provisions, bidder must use the bond form included in the Contract Provisions.

If so stated in the Contract Provisions, cash will not be accepted for a bid deposit.

1-02.9 Delivery of Proposal

Delete this section and replace it with the following:

Each Proposal shall be submitted in PDF format via electronic transmission to the Public Works email address at: publicworks@mercerisland.gov, by the date and time shown in the Advertisement for Bids.

1-02.10 Withdrawing, Revising, or Supplementing Proposal

(July 23, 2015 APWA GSP)

Delete this section, and replace it with the following:

1. After submitting a physical Bid Proposal to the Contracting Agency, the Bidder may withdraw, revise, or supplement it if:
 - a. The Bidder submits a written request signed by an authorized person and physically delivers it to the place designated for receipt of Bid Proposals, and
 - b. The Contracting Agency receives the request before the time set for receipt of Bid Proposals, and
 - c. The revised or supplemented Bid Proposal (if any) is received by the Contracting Agency before the time set for receipt of Bid Proposals.
2. If the Bidder's request to withdraw, revise, or supplement its Bid Proposal is received before the time set for receipt of Bid Proposals, the Contracting Agency will return the unopened Proposal package to the Bidder. The Bidder must then submit the revised or supplemented package in its entirety. If the Bidder does not submit a revised or supplemented package, then its bid shall be considered withdrawn.
3. Late revised or supplemented Bid Proposals or late withdrawal requests will be date recorded by the Contracting Agency and returned unopened. Mailed, emailed, or faxed requests to withdraw, revise, or supplement a Bid Proposal are not acceptable.

1-02.13 Irregular Proposals

(June 20, 2017 APWA GSP)

Delete this section and replace it with the following:

1. A Proposal will be considered irregular and will be rejected if:
 - a. The Bidder is not prequalified when so required;
 - b. The authorized Proposal form furnished by the Contracting Agency is not used or is altered;
 - c. The completed Proposal form contains any unauthorized additions, deletions, alternate Bids, or conditions;
 - d. The Bidder adds provisions reserving the right to reject or accept the award, or enter into the Contract;
 - e. A price per unit cannot be determined from the Bid Proposal;
 - f. The Proposal form is not properly executed;

- g. The Bidder fails to submit or properly complete a Subcontractor list, if applicable, as required in Section 1-02.6;
 - h. The Bidder fails to submit or properly complete an Underutilized Disadvantaged Business Enterprise Certification, if applicable, as required in Section 1-02.6;
 - i. The Bidder fails to submit written confirmation from each UDBE firm listed on the Bidder's completed UDBE Utilization Certification that they are in agreement with the bidder's UDBE participation commitment, if applicable, as required in Section 1-02.6, or if the written confirmation that is submitted fails to meet the requirements of the Special Provisions;
 - j. The Bidder fails to submit UDBE Good Faith Effort documentation, if applicable, as required in Section 1-02.6, or if the documentation that is submitted fails to demonstrate that a Good Faith Effort to meet the Condition of Award was made;
 - k. The Bid Proposal does not constitute a definite and unqualified offer to meet the material terms of the Bid invitation; or
 - l. More than one Proposal is submitted for the same project from a Bidder under the same or different names.
2. A Proposal may be considered irregular and may be rejected if:
- a. The Proposal does not include a unit price for every Bid item;
 - b. Any of the unit prices are excessively unbalanced (either above or below the amount of a reasonable Bid) to the potential detriment of the Contracting Agency;
 - c. Receipt of Addenda is not acknowledged;
 - d. A member of a joint venture or partnership and the joint venture or partnership submit Proposals for the same project (in such an instance, both Bids may be rejected); or
 - e. If Proposal form entries are not made in ink.

1-02.14 Disqualification of Bidders

(May 17, 2018 APWA GSP, Option A)

Delete this section and replace it with the following:

A Bidder will be deemed not responsible if the Bidder does not meet the mandatory bidder responsibility criteria in RCW 39.04.350(1), as amended.

The Contracting Agency will verify that the Bidder meets the mandatory bidder responsibility criteria in RCW 39.04.350(1). To assess bidder responsibility, the Contracting Agency reserves the right to request documentation as needed from the Bidder and third parties concerning the Bidder's compliance with the mandatory bidder responsibility criteria.

If the Contracting Agency determines the Bidder does not meet the mandatory bidder responsibility criteria in RCW 39.04.350(1) and is therefore not a responsible Bidder, the Contracting Agency shall notify the Bidder in writing, with the reasons for its determination. If the Bidder disagrees with this determination, it may appeal the determination within two (2) business days of the Contracting Agency's determination by presenting its appeal and any additional information to the Contracting Agency. The Contracting Agency will consider

the appeal and any additional information before issuing its final determination. If the final determination affirms that the Bidder is not responsible, the Contracting Agency will not execute a contract with any other Bidder until at least two business days after the Bidder determined to be not responsible has received the Contracting Agency's final determination.

1-02.15 Pre Award Information

(August 14, 2013 APWA GSP)

Revise this section to read:

Before awarding any contract, the Contracting Agency may require one or more of these items or actions of the apparent lowest responsible bidder:

1. A complete statement of the origin, composition, and manufacture of any or all materials to be used,
2. Samples of these materials for quality and fitness tests,
3. A progress schedule (in a form the Contracting Agency requires) showing the order of and time required for the various phases of the work,
4. A breakdown of costs assigned to any bid item,
5. Attendance at a conference with the Engineer or representatives of the Engineer,
6. Obtain, and furnish a copy of, a business license to do business in the city or county where the work is located.
7. Any other information or action taken that is deemed necessary to ensure that the bidder is the lowest responsible bidder.

1-03 AWARD AND EXECUTION OF THE CONTRACT

1-03.4 Contract Bond

(July 23, 2015 APWA GSP)

Delete the first paragraph and replace it with the following:

The successful bidder shall provide executed payment and performance bond(s) for the full contract amount. The bond may be a combined payment and performance bond; or be separate payment and performance bonds. In the case of separate payment and performance bonds, each shall be for the full contract amount. The bond(s) shall:

1. Be on Contracting Agency-furnished form(s);
2. Be signed by an approved surety (or sureties) that:
 - a. Is registered with the Washington State Insurance Commissioner, and
 - b. Appears on the current Authorized Insurance List in the State of Washington published by the Office of the Insurance Commissioner,
3. Guarantee that the Contractor will perform and comply with all obligations, duties, and conditions under the Contract, including but not limited to the duty and obligation to indemnify, defend, and protect the Contracting Agency against all losses and claims related directly or indirectly from any failure:

- a. Of the Contractor (or any of the employees, subcontractors, or lower tier subcontractors of the Contractor) to faithfully perform and comply with all contract obligations, conditions, and duties, or
- b. Of the Contractor (or the subcontractors or lower tier subcontractors of the Contractor) to pay all laborers, mechanics, subcontractors, lower tier subcontractors, material person, or any other person who provides supplies or provisions for carrying out the work;
4. Be conditioned upon the payment of taxes, increases, and penalties incurred on the project under titles 50, 51, and 82 RCW; and
5. Be accompanied by a power of attorney for the Surety's officer empowered to sign the bond; and
6. Be signed by an officer of the Contractor empowered to sign official statements (sole proprietor or partner). If the Contractor is a corporation, the bond(s) must be signed by the president or vice president, unless accompanied by written proof of the authority of the individual signing the bond(s) to bind the corporation (i.e., corporate resolution, power of attorney, or a letter to such effect signed by the president or vice president).

1-03.7 Judicial Review

(November 30, 2018 APWA GSP)

Revise this section to read:

Any decision made by the Contracting Agency regarding the Award and execution of the Contract or Bid rejection shall be conclusive subject to the scope of judicial review permitted under Washington Law. Such review, if any, shall be timely filed in the Superior Court of the county where the Contracting Agency headquarters is located, provided that where an action is asserted against a county, RCW 36.01.050 shall control venue and jurisdiction.

1-04 SCOPE of WORK

1-04.2 Coordination of Contract Documents, Plans, Special Provisions, Specifications, and Addenda

(March 13, 2012 APWA GSP)

Revise the second paragraph to read:

Any inconsistency in the parts of the contract shall be resolved by following this order of precedence (e.g., 1 presiding over 2, 2 over 3, 3 over 4, and so forth):

1. Addenda,
2. Proposal Form,
3. Special Provisions,
4. Contract Plans,
5. Amendments to the Standard Specifications,
6. Standard Specifications,
7. Contracting Agency's Standard Plans or Details (if any), and

8. WSDOT Standard Plans for Road, Bridge, and Municipal Construction.

1-05 CONTROL OF WORK

1-05.7 Removal of Defective and Unauthorized Work

(October 1, 2005 APWA GSP)

Supplement this section with the following:

If the Contractor fails to remedy defective or unauthorized work within the time specified in a written notice from the Engineer, or fails to perform any part of the work required by the Contract Documents, the Engineer may correct and remedy such work as may be identified in the written notice, with Contracting Agency forces or by such other means as the Contracting Agency may deem necessary.

If the Contractor fails to comply with a written order to remedy what the Engineer determines to be an emergency situation, the Engineer may have the defective and unauthorized work corrected immediately, have the rejected work removed and replaced, or have work the Contractor refuses to perform completed by using Contracting Agency or other forces. An emergency situation is any situation when, in the opinion of the Engineer, a delay in its remedy could be potentially unsafe, or might cause serious risk of loss or damage to the public.

Direct or indirect costs incurred by the Contracting Agency attributable to correcting and remedying defective or unauthorized work, or work the Contractor failed or refused to perform, shall be paid by the Contractor. Payment will be deducted by the Engineer from monies due, or to become due, the Contractor. Such direct and indirect costs shall include in particular, but without limitation, compensation for additional professional services required, and costs for repair and replacement of work of others destroyed or damaged by correction, removal, or replacement of the Contractor's unauthorized work.

No adjustment in contract time or compensation will be allowed because of the delay in the performance of the work attributable to the exercise of the Contracting Agency's rights provided by this Section.

The rights exercised under the provisions of this section shall not diminish the Contracting Agency's right to pursue any other avenue for additional remedy or damages with respect to the Contractor's failure to perform the work as required.

1-05.11 Final Inspection

Delete this section and replace it with the following:

1-05.11 Final Inspections and Operational Testing *(October 1, 2005 APWA GSP)*

1-05.11(1) Substantial Completion Date

When the Contractor considers the work to be substantially complete, the Contractor shall so notify the Engineer and request the Engineer establish the Substantial Completion Date. The Contractor's request shall list the specific items of work that remain to be completed in order to reach physical completion. The Engineer will schedule an inspection of the work with the Contractor to determine the status of completion. The Engineer may also establish the Substantial Completion Date unilaterally.

If, after this inspection, the Engineer concurs with the Contractor that the work is substantially complete and ready for its intended use, the Engineer, by written notice to the Contractor, will set the Substantial Completion Date. If, after this inspection the Engineer does not consider the work substantially complete and ready for its intended use, the Engineer will, by written notice, so notify the Contractor giving the reasons therefor.

Upon receipt of written notice concurring in or denying substantial completion, whichever is applicable, the Contractor shall pursue vigorously, diligently and without unauthorized interruption, the work necessary to reach Substantial and Physical Completion. The Contractor shall provide the Engineer with a revised schedule indicating when the Contractor expects to reach substantial and physical completion of the work.

The above process shall be repeated until the Engineer establishes the Substantial Completion Date and the Contractor considers the work physically complete and ready for final inspection.

1-05.11(2) Final Inspection and Physical Completion Date

When the Contractor considers the work physically complete and ready for final inspection, the Contractor by written notice, shall request the Engineer to schedule a final inspection. The Engineer will set a date for final inspection. The Engineer and the Contractor will then make a final inspection and the Engineer will notify the Contractor in writing of all particulars in which the final inspection reveals the work incomplete or unacceptable. The Contractor shall immediately take such corrective measures as are necessary to remedy the listed deficiencies. Corrective work shall be pursued vigorously, diligently, and without interruption until physical completion of the listed deficiencies. This process will continue until the Engineer is satisfied the listed deficiencies have been corrected.

If action to correct the listed deficiencies is not initiated within 7 days after receipt of the written notice listing the deficiencies, the Engineer may, upon written notice to the Contractor, take whatever steps are necessary to correct those deficiencies pursuant to Section 1-05.7.

The Contractor will not be allowed an extension of contract time because of a delay in the performance of the work attributable to the exercise of the Engineer's right hereunder.

Upon correction of all deficiencies, the Engineer will notify the Contractor and the Contracting Agency, in writing, of the date upon which the work was considered physically complete. That date shall constitute the Physical Completion Date of the contract, but shall not imply acceptance of the work or that all the obligations of the Contractor under the contract have been fulfilled.

1-05.11(3) Operational Testing

It is the intent of the Contracting Agency to have at the Physical Completion Date a complete and operable system. Therefore when the work involves the installation of machinery or other mechanical equipment; street lighting, electrical distribution or signal systems; irrigation systems; buildings; or other similar work it may be desirable for the Engineer to have the Contractor operate and test the work for a period of time after final inspection but prior to the physical completion date. Whenever items of work are listed in the Contract Provisions for operational testing they shall be fully tested under operating conditions for the time period specified to ensure their acceptability prior to the Physical Completion Date. During and following the test period, the Contractor shall correct any items of workmanship, materials, or equipment which prove faulty, or that are not in first class operating condition. Equipment, electrical controls, meters, or other devices and equipment to be tested during this period shall be tested under the observation of the Engineer, so that the Engineer may determine their suitability for the purpose for which they were installed. The Physical Completion Date cannot be established until testing and corrections have been completed to the satisfaction of the Engineer.

The costs for power, gas, labor, material, supplies, and everything else needed to successfully complete operational testing, shall be included in the unit contract prices related to the system being tested, unless specifically set forth otherwise in the proposal.

Operational and test periods, when required by the Engineer, shall not affect a manufacturer's guaranties or warranties furnished under the terms of the contract.

1-05.13 Superintendents, Labor and Equipment of Contractor

(August 14, 2013 APWA GSP)

Delete the sixth and seventh paragraphs of this section.

1-05.15 Method of Serving Notices

(March 25, 2009 APWA GSP)

Revise the second paragraph to read:

All correspondence from the Contractor shall be directed to the Project Engineer. All correspondence from the Contractor constituting any notification, notice of protest, notice of dispute, or other correspondence constituting notification required to be furnished under the Contract, must be in paper format, hand delivered or sent via mail delivery service to the Project Engineer's office. Electronic copies such as e-mails or

electronically delivered copies of correspondence will not constitute such notice and will not comply with the requirements of the Contract.

Add the following new section:

1-05.16 Water and Power
(October 1, 2005 APWA GSP)

The Contractor shall make necessary arrangements, and shall bear the costs for power and water necessary for the performance of the work, unless the contract includes power and water as a pay item.

1-07 LEGAL RELATIONS AND RESPONSIBILITY TO THE PUBLIC

1-07.1 Laws to be Observed
(October 1, 2005 APWA GSP)

Supplement this section with the following:

In cases of conflict between different safety regulations, the more stringent regulation shall apply.

The Washington State Department of Labor and Industries shall be the sole and paramount administrative agency responsible for the administration of the provisions of the Washington Industrial Safety and Health Act of 1973 (WISHA).

The Contractor shall maintain at the project site office, or other well known place at the project site, all articles necessary for providing first aid to the injured. The Contractor shall establish, publish, and make known to all employees, procedures for ensuring immediate removal to a hospital, or doctor's care, persons, including employees, who may have been injured on the project site. Employees should not be permitted to work on the project site before the Contractor has established and made known procedures for removal of injured persons to a hospital or a doctor's care.

The Contractor shall have sole responsibility for the safety, efficiency, and adequacy of the Contractor's plant, appliances, and methods, and for any damage or injury resulting from their failure, or improper maintenance, use, or operation. The Contractor shall be solely and completely responsible for the conditions of the project site, including safety for all persons and property in the performance of the work. This requirement shall apply continuously, and not be limited to normal working hours. The required or implied duty of the Engineer to conduct construction review of the Contractor's performance does not, and shall not, be intended to include review and adequacy of the Contractor's safety measures in, on, or near the project site.

1-07.2 State Taxes

Delete this section, including its sub-sections, in its entirety and replace it with the following:

1-07.2 State Sales Tax

(June 27, 2011 APWA GSP)

The Washington State Department of Revenue has issued special rules on the State sales tax. Sections 1-07.2(1) through 1-07.2(3) are meant to clarify those rules. The Contractor should contact the Washington State Department of Revenue for answers to questions in this area. The Contracting Agency will not adjust its payment if the Contractor bases a bid on a misunderstood tax liability.

The Contractor shall include all Contractor-paid taxes in the unit bid prices or other contract amounts. In some cases, however, state retail sales tax will not be included. Section 1-07.2(2) describes this exception.

The Contracting Agency will pay the retained percentage (or release the Contract Bond if a FHWA-funded Project) only if the Contractor has obtained from the Washington State Department of Revenue a certificate showing that all contract-related taxes have been paid (RCW 60.28.051). The Contracting Agency may deduct from its payments to the Contractor any amount the Contractor may owe the Washington State Department of Revenue, whether the amount owed relates to this contract or not. Any amount so deducted will be paid into the proper State fund.

1-07.2(1) State Sales Tax — Rule 171

WAC 458-20-171, and its related rules, apply to building, repairing, or improving streets, roads, etc., which are owned by a municipal corporation, or political subdivision of the state, or by the United States, and which are used primarily for foot or vehicular traffic. This includes storm or combined sewer systems within and included as a part of the street or road drainage system and power lines when such are part of the roadway lighting system. For work performed in such cases, the Contractor shall include Washington State Retail Sales Taxes in the various unit bid item prices, or other contract amounts, including those that the Contractor pays on the purchase of the materials, equipment, or supplies used or consumed in doing the work.

1-07.2(2) State Sales Tax — Rule 170

WAC 458-20-170, and its related rules, apply to the constructing and repairing of new or existing buildings, or other structures, upon real property. This includes, but is not limited to, the construction of streets, roads, highways, etc., owned by the state of Washington; water mains and their appurtenances; sanitary sewers and sewage disposal systems unless such sewers and disposal systems are within, and a part of, a street or road drainage system; telephone, telegraph, electrical power distribution lines, or other conduits or lines in or above streets or roads, unless such power lines become a part of a street or road lighting system; and installing or attaching of any article of tangible personal property in or

to real property, whether or not such personal property becomes a part of the realty by virtue of installation.

For work performed in such cases, the Contractor shall collect from the Contracting Agency, retail sales tax on the full contract price. The Contracting Agency will automatically add this sales tax to each payment to the Contractor. For this reason, the Contractor shall not include the retail sales tax in the unit bid item prices, or in any other contract amount subject to Rule 170, with the following exception.

Exception: The Contracting Agency will not add in sales tax for a payment the Contractor or a subcontractor makes on the purchase or rental of tools, machinery, equipment, or consumable supplies not integrated into the project. Such sales taxes shall be included in the unit bid item prices or in any other contract amount.

1-07.2(3) Services

The Contractor shall not collect retail sales tax from the Contracting Agency on any contract wholly for professional or other services (as defined in Washington State Department of Revenue Rules 138 and 244).

1-07.18 Public Liability and Property Damage Insurance

Delete this section in its entirety, and replace it with the following:

1-07.18 Insurance

(January 4, 2016 APWA GSP)

1-07.18(1) General Requirements

- A. The Contractor shall procure and maintain the insurance described in all subsections of section 1-07.18 of these Special Provisions, from insurers with a current A. M. Best rating of not less than A-: VII and licensed to do business in the State of Washington. The Contracting Agency reserves the right to approve or reject the insurance provided, based on the insurer's financial condition.
- B. The Contractor shall keep this insurance in force without interruption from the commencement of the Contractor's Work through the term of the Contract and for thirty (30) days after the Physical Completion date, unless otherwise indicated below.
- C. If any insurance policy is written on a claims made form, its retroactive date, and that of all subsequent renewals, shall be no later than the effective date of this Contract. The policy shall state that coverage is claims made, and state the retroactive date. Claims-made form coverage shall be maintained by the Contractor for a minimum of 36 months following the Completion Date or earlier termination of this Contract, and the Contractor shall annually provide the Contracting Agency with proof of renewal. If renewal of the claims made form of coverage becomes unavailable, or economically prohibitive, the Contractor shall purchase an extended reporting period ("tail") or execute another form of guarantee acceptable to the Contracting Agency to assure financial responsibility for liability for services performed.

- D. The Contractor's Automobile Liability, Commercial General Liability and Excess or Umbrella Liability insurance policies shall be primary and non-contributory insurance as respects the Contracting Agency's insurance, self-insurance, or self-insured pool coverage. Any insurance, self-insurance, or self-insured pool coverage maintained by the Contracting Agency shall be excess of the Contractor's insurance and shall not contribute with it.
- E. The Contractor shall provide the Contracting Agency and all additional insureds with written notice of any policy cancellation, within two business days of their receipt of such notice.
- F. The Contractor shall not begin work under the Contract until the required insurance has been obtained and approved by the Contracting Agency
- G. Failure on the part of the Contractor to maintain the insurance as required shall constitute a material breach of contract, upon which the Contracting Agency may, after giving five business days' notice to the Contractor to correct the breach, immediately terminate the Contract or, at its discretion, procure or renew such insurance and pay any and all premiums in connection therewith, with any sums so expended to be repaid to the Contracting Agency on demand, or at the sole discretion of the Contracting Agency, offset against funds due the Contractor from the Contracting Agency.
- H. All costs for insurance shall be incidental to and included in the unit or lump sum prices of the Contract and no additional payment will be made.

1-07.18(2) Additional Insured

All insurance policies, with the exception of Workers Compensation, and of Professional Liability and Builder's Risk (if required by this Contract) shall name the following listed entities as additional insured(s) using the forms or endorsements required herein:

- the Contracting Agency and its officers, elected officials, employees, agents, and volunteers

The above-listed entities shall be additional insured(s) for the full available limits of liability maintained by the Contractor, irrespective of whether such limits maintained by the Contractor are greater than those required by this Contract, and irrespective of whether the Certificate of Insurance provided by the Contractor pursuant to 1-07.18(4) describes limits lower than those maintained by the Contractor.

For Commercial General Liability insurance coverage, the required additional insured endorsements shall be at least as broad as ISO forms CG 20 10 10 01 for ongoing operations and CG 20 37 10 01 for completed operations.

1-07.18(3) Subcontractors

The Contractor shall cause each Subcontractor of every tier to provide insurance coverage that complies with all applicable requirements of the Contractor-provided insurance as set forth herein, except the Contractor shall have sole responsibility for determining the limits of coverage required to be obtained by Subcontractors.

The Contractor shall ensure that all Subcontractors of every tier add all entities listed in 1-07.18(2) as additional insureds, and provide proof of such on the policies as required by that section as detailed in 1-07.18(2) using an endorsement as least as broad as ISO CG 20 10 10 01 for ongoing operations and CG 20 37 10 01 for completed operations.

Upon request by the Contracting Agency, the Contractor shall forward to the Contracting Agency evidence of insurance and copies of the additional insured endorsements of each Subcontractor of every tier as required in 1-07.18(4) Verification of Coverage.

1-07.18(4) Verification of Coverage

The Contractor shall deliver to the Contracting Agency a Certificate(s) of Insurance and endorsements for each policy of insurance meeting the requirements set forth herein when the Contractor delivers the signed Contract for the work. Failure of Contracting Agency to demand such verification of coverage with these insurance requirements or failure of Contracting Agency to identify a deficiency from the insurance documentation provided shall not be construed as a waiver of Contractor's obligation to maintain such insurance.

Verification of coverage shall include:

1. An ACORD certificate or a form determined by the Contracting Agency to be equivalent.
2. Copies of all endorsements naming Contracting Agency and all other entities listed in 1-07.18(2) as additional insured(s), showing the policy number. The Contractor may submit a copy of any blanket additional insured clause from its policies instead of a separate endorsement.
3. Any other amendatory endorsements to show the coverage required herein.
4. A notation of coverage enhancements on the Certificate of Insurance shall not satisfy these requirements – actual endorsements must be submitted.

Upon request by the Contracting Agency, the Contractor shall forward to the Contracting Agency a full and certified copy of the insurance policy(s). If Builders Risk insurance is required on this Project, a full and certified copy of that policy is required when the Contractor delivers the signed Contract for the work.

1-07.18(5) Coverages and Limits

The insurance shall provide the minimum coverages and limits set forth below. Contractor's maintenance of insurance, its scope of coverage, and limits as required herein shall not be construed to limit the liability of the Contractor to the coverage provided by such insurance, or otherwise limit the Contracting Agency's recourse to any remedy available at law or in equity.

All deductibles and self-insured retentions must be disclosed and are subject to approval by the Contracting Agency. The cost of any claim payments falling within the deductible or self-insured retention shall be the responsibility of the Contractor. In the event an additional insured incurs a liability subject to any policy's deductibles or self-insured retention, said deductibles or self-insured retention shall be the responsibility of the Contractor.

1-07.18(5)A Commercial General Liability

Commercial General Liability insurance shall be written on coverage forms at least as broad as ISO occurrence form CG 00 01, including but not limited to liability arising from premises, operations, stop gap liability, independent contractors, products-completed operations, personal and advertising injury, and liability assumed under an insured contract. There shall be no exclusion for liability arising from explosion, collapse or underground property damage.

The Commercial General Liability insurance shall be endorsed to provide a per project general aggregate limit, using ISO form CG 25 03 05 09 or an equivalent endorsement.

Contractor shall maintain Commercial General Liability Insurance arising out of the Contractor’s completed operations for at least three years following Substantial Completion of the Work.

Such policy must provide the following minimum limits:

Automobile Liability shall cover owned, non-owned, hired, and leased vehicles; and shall be written on a coverage form at least as broad as ISO form CA 00 01. If the work involves the transport of pollutants, the automobile liability policy shall include MCS 90 and CA 99 48 endorsements.

Such policy must provide the following minimum limit:

1-07.18(5)C Workers’ Compensation

The Contractor shall comply with Workers’ Compensation coverage as required by the Industrial Insurance laws of the State of Washington.

1-08 PROSECUTION AND PROGRESS

Add the following new section:

1-08.0 Preliminary Matters

(May 25, 2006 APWA GSP)

Add the following new section:

1-08.0(1) Preconstruction Conference

(October 10, 2008 APWA GSP)

Prior to the Contractor beginning the work, a preconstruction conference will be held between the Contractor, the Engineer and such other interested parties as may be invited. The purpose of the preconstruction conference will be:

1. To review the initial progress schedule;
2. To establish a working understanding among the various parties associated or affected by the work;
3. To establish and review procedures for progress payment, notifications, approvals, submittals, etc.;
4. To establish normal working hours for the work;
5. To review safety standards and traffic control; and
6. To discuss such other related items as may be pertinent to the work.

The Contractor shall prepare and submit at the preconstruction conference the following:

1. A breakdown of all lump sum items;
2. A preliminary schedule of working drawing submittals; and
3. A list of material sources for approval if applicable.

Add the following new section:

1-08.0(2) Hours of Work

(December 8, 2014 APWA GSP)

Except in the case of emergency or unless otherwise approved by the Engineer, the normal working hours for the Contract shall be any consecutive 8-hour period between 7:00 a.m. and 6:00 p.m. Monday through Friday, exclusive of a lunch break. If the Contractor desires different than the normal working hours stated above, the request must be submitted in writing prior to the preconstruction conference, subject to the provisions below. The working hours for the Contract shall be established at or prior to the preconstruction conference.

All working hours and days are also subject to local permit and ordinance conditions (such as noise ordinances).

If the Contractor wishes to deviate from the established working hours, the Contractor shall submit a written request to the Engineer for consideration. This request shall state what hours are being requested, and why. Requests shall be submitted for review no later than five (5) days prior to the day(s) the Contractor is requesting to change the hours.

If the Contracting Agency approves such a deviation, such approval may be subject to certain other conditions, which will be detailed in writing. For example:

1. On non-Federal aid projects, requiring the Contractor to reimburse the Contracting Agency for the costs in excess of straight-time costs for Contracting Agency representatives who worked during such times. (The Engineer may require designated representatives to be present during the work. Representatives who may be deemed necessary by the Engineer include, but are not limited to: survey crews; personnel from the Contracting Agency's material testing lab; inspectors; and other Contracting Agency employees or third party consultants when, in the opinion of the Engineer, such work necessitates their presence.)

2. Considering the work performed on Saturdays, Sundays, and holidays as working days with regard to the contract time.
3. Considering multiple work shifts as multiple working days with respect to contract time even though the multiple shifts occur in a single 24-hour period.
4. If a 4-10 work schedule is requested and approved the non working day for the week will be charged as a working day.
5. If Davis Bacon wage rates apply to this Contract, all requirements must be met and recorded properly on certified payroll

1-08.1 Subcontracting

(November 30, 2018 APWA GSP, Option B)

Delete the eighth paragraph.

1-08.3(2)A Type A Progress Schedule

(March 13, 2012 APWA GSP)

Revise this section to read:

The Contractor shall submit two(2) copies of a Type A Progress Schedule no later than at the preconstruction conference, or some other mutually agreed upon submittal time. The schedule may be a critical path method (CPM) schedule, bar chart, or other standard schedule format. Regardless of which format used, the schedule shall identify the critical path. The Engineer will evaluate the Type A Progress Schedule and approve or return the schedule for corrections within 15 calendar days of receiving the submittal.

1-08.4 Prosecution of Work

Delete this section and replace it with the following:

1-08.4 Notice to Proceed and Prosecution of Work

(July 23, 2015 APWA GSP)

Notice to Proceed will be given after the contract has been executed and the contract bond and evidence of insurance have been approved and filed by the Contracting Agency. The Contractor shall not commence with the work until the Notice to Proceed has been given by the Engineer. The Contractor shall commence construction activities on the project site within ten days of the Notice to Proceed Date, unless otherwise approved in writing. The Contractor shall diligently pursue the work to the physical completion date within the time specified in the contract. Voluntary shutdown or slowing of operations by the Contractor shall not relieve the Contractor of the responsibility to complete the work within the time(s) specified in the contract.

When shown in the Plans, the first order of work shall be the installation of high visibility fencing to delineate all areas for protection or restoration, as described in the Contract. Installation of high visibility fencing adjacent to the roadway shall occur after the placement

of all necessary signs and traffic control devices in accordance with 1-10.1(2). Upon construction of the fencing, the Contractor shall request the Engineer to inspect the fence. No other work shall be performed on the site until the Contracting Agency has accepted the installation of high visibility fencing, as described in the Contract.

1-08.5 Time for Completion

(November 30, 2018 APWA GSP, Option A)

Revise the third and fourth paragraphs to read:

Contract time shall begin on the first working day following the Notice to Proceed Date.

Each working day shall be charged to the contract as it occurs, until the contract work is physically complete. If substantial completion has been granted and all the authorized working days have been used, charging of working days will cease. Each week the Engineer will provide the Contractor a statement that shows the number of working days: (1) charged to the contract the week before; (2) specified for the physical completion of the contract; and (3) remaining for the physical completion of the contract. The statement will also show the nonworking days and any partial or whole day the Engineer declares as unworkable. Within 10 calendar days after the date of each statement, the Contractor shall file a written protest of any alleged discrepancies in it. To be considered by the Engineer, the protest shall be in sufficient detail to enable the Engineer to ascertain the basis and amount of time disputed. By not filing such detailed protest in that period, the Contractor shall be deemed as having accepted the statement as correct. If the Contractor is approved to work 10 hours a day and 4 days a week (a 4-10 schedule) and the fifth day of the week in which a 4-10 shift is worked would ordinarily be charged as a working day then the fifth day of that week will be charged as a working day whether or not the Contractor works on that day.

Revise the sixth paragraph to read:

The Engineer will give the Contractor written notice of the completion date of the contract after all the Contractor's obligations under the contract have been performed by the Contractor. The following events must occur before the Completion Date can be established:

1. The physical work on the project must be complete; and
2. The Contractor must furnish all documentation required by the contract and required by law, to allow the Contracting Agency to process final acceptance of the contract. The following documents must be received by the Project Engineer prior to establishing a completion date:
 - a. Certified Payrolls (per Section 1-07.9(5)).
 - b. Material Acceptance Certification Documents
 - c. Monthly Reports of Amounts Credited as DBE Participation, as required by the Contract Provisions.
 - d. Final Contract Voucher Certification
 - e. Copies of the approved "Affidavit of Prevailing Wages Paid" for the Contractor and all Subcontractors

- f. A copy of the Notice of Termination sent to the Washington State Department of Ecology (Ecology); the elapse of 30 calendar days from the date of receipt of the Notice of Termination by Ecology; and no rejection of the Notice of Termination by Ecology. This requirement will not apply if the Construction Stormwater General Permit is transferred back to the Contracting Agency in accordance with Section 8-01.3(16).
- g. Property owner releases per Section 1-07.24

1-08.9 Liquidated Damages

(August 14, 2013 APWA GSP)

Revise the fourth paragraph to read:

When the Contract Work has progressed to Substantial Completion as defined in the Contract, the Engineer may determine that the work is Substantially Complete. The Engineer will notify the Contractor in writing of the Substantial Completion Date. For overruns in Contract time occurring after the date so established, the formula for liquidated damages shown above will not apply. For overruns in Contract time occurring after the Substantial Completion Date, liquidated damages shall be assessed on the basis of direct engineering and related costs assignable to the project until the actual Physical Completion Date of all the Contract Work. The Contractor shall complete the remaining Work as promptly as possible. Upon request by the Project Engineer, the Contractor shall furnish a written schedule for completing the physical Work on the Contract.

1-09 MEASUREMENT AND PAYMENT

1-09.2(5) Measurement

(May 2, 2017 APWA GSP)

Revise the first paragraph to read:

Scale Verification Checks – At the Engineer’s discretion, the Engineer may perform verification checks on the accuracy of each batch, hopper, or platform scale used in weighing contract items of Work.

1-09.6 Force Account

(October 10, 2008 APWA GSP)

Supplement this section with the following:

The Contracting Agency has estimated and included in the Proposal, dollar amounts for all items to be paid per force account, only to provide a common proposal for Bidders. All such dollar amounts are to become a part of Contractor's total bid. However, the Contracting Agency does not warrant expressly or by implication, that the actual amount of work will correspond with those estimates. Payment will be made on the basis of the amount of work actually authorized by Engineer.

1-09.11(3) Time Limitation and Jurisdiction

(November 30, 2018 APWA GSP)

Revise this section to read:

For the convenience of the parties to the Contract it is mutually agreed by the parties that any claims or causes of action which the Contractor has against the Contracting Agency arising from the Contract shall be brought within 180 calendar days from the date of final acceptance (Section 1-05.12) of the Contract by the Contracting Agency; and it is further agreed that any such claims or causes of action shall be brought only in the Superior Court of the county where the Contracting Agency headquarters is located, provided that where an action is asserted against a county, RCW 36.01.050 shall control venue and jurisdiction. The parties understand and agree that the Contractor's failure to bring suit within the time period provided, shall be a complete bar to any such claims or causes of action. It is further mutually agreed by the parties that when any claims or causes of action which the Contractor asserts against the Contracting Agency arising from the Contract are filed with the Contracting Agency or initiated in court, the Contractor shall permit the Contracting Agency to have timely access to any records deemed necessary by the Contracting Agency to assist in evaluating the claims or action.

1-09.13(3) Claims \$250,000 or Less

(October 1, 2005 APWA GSP)

Delete this section and replace it with the following:

The Contractor and the Contracting Agency mutually agree that those claims that total \$250,000 or less, submitted in accordance with Section 1-09.11 and not resolved by nonbinding ADR processes, shall be resolved through litigation unless the parties mutually agree in writing to resolve the claim through binding arbitration.

1-09.13(3)A Administration of Arbitration

(November 30, 2018 APWA GSP)

Revise the third paragraph to read:

The Contracting Agency and the Contractor mutually agree to be bound by the decision of the arbitrator, and judgment upon the award rendered by the arbitrator may be entered in the Superior Court of the county in which the Contracting Agency's headquarters is located, provided that where claims subject to arbitration are asserted against a county, RCW 36.01.050 shall control venue and jurisdiction of the Superior Court. The decision of the arbitrator and the specific basis for the decision shall be in writing. The arbitrator shall use the Contract as a basis for decisions.

1-10 TEMPORARY TRAFFIC CONTROL

1-10.4(2) Measurement

(Special Provision)

Supplement

“Traffic Control Labor” will be measured by the hour. Hours will be measured for activities performed under the description of “Flaggers” and “Other Traffic Control Labor”, herein.

“Traffic Control Supervisor” will be measured by lump sum for activities performed under the description of “Traffic Control Supervisor”.

1-10.5(2) Payment

(Special Provision)

Supplement

Traffic control devices and the Traffic Control Supervisor’s truck will be **incidental** to related Bid items and no additional payments will be made.

Payment will be made for the following bid item(s):

“Traffic Control Labor”, per hour.

The unit price per hour of “Traffic Control Labor” when applied to the number of units measured for this item in accordance with Section 1-10.4(2) shall be full compensation for all costs incurred by the Contractor for flagging activities and other traffic control activities as described in Section 1-10.3(1) of the Standard Specifications.

“Traffic Control Supervisor”, per lump sum.

The lump sum price of “Traffic Control Supervisor” shall be full compensation for all costs incurred by the Contractor for Traffic Control Supervisor activities and other traffic control activities as described in Section 1-10.2(1)B of the Standard Specifications.

**DIVISION 2
EARTHWORK**

2-01 CLEARING, GRUBBING, AND ROADSIDE CLEANUP

2-01.1 Description

(Special Provision)

Supplement

The Contractor shall stake the proposed clearing limits at a minimum of fifty (50) foot intervals. The Contractor shall allow 48 hours for the Engineer to approve the clearing limits before commencing activities. At the direction of the Engineer, the limits shall be adjusted in the field. When staking the clearing limits, the Contractor shall strive to protect from damage existing items such as vegetation, rockeries, fences, mailboxes, and irrigation.

2-01.2 Disposal of Usable Material and Debris

2-01.5 Payment

(Special Provision)

Supplement

All costs involved in obtaining and providing a waste site shall be considered **incidental** to related bid items.

2-02 REMOVAL OF STRUCTURES AND OBSTRUCTIONS

2-02.3 Construction Requirements

(Special Provision)

Supplement

The following items shall be satisfactorily removed and disposed of:

- Approximately 225 LF of 12" diameter storm drain pipe at various locations
- Approximately 25 LF of railroad tie landscaping timbers in the vicinity of station 23+70
- Type 1 catch basin in the vicinity of station 26+48

Voids resulting from removal work shall be backfilled and compacted to 95% maximum density with Crushed Surfacing Top Course (or Base Course).

Existing trees, landscaping and plantings, utility boxes, signs, meters, bollards, mailboxes, posts, etc. located near the construction which conflict with the Work shall be removed or relocated in a manner satisfactory to the Engineer to allow for construction.

2-02.3(3)1 Removing Asphalt or Cement Concrete Pavement

(Special Provision)

New Section

Existing asphalt concrete pavement shall be removed at the locations shown in the Plans and where designated by the Engineer.

Removal shall be accomplished by making a neat longitudinal vertical cut along the boundaries of the area to be removed. Sawcutting shall be accomplished with a self-propelled machine

capable of cutting the full pavement depth and approved by the Engineer. The use of pneumatic hammers or punches will not be permitted unless sawcutting follows.

Care shall be taken in removing the pavement not to damage any of the existing pavement that is to remain in place. Any remaining asphalt or cement concrete pavement damaged due to the Contractor's operations shall be replaced by the Contractor to the satisfaction of the Engineer at the Contractor's expense.

2-02.3(3)3 Sawcutting

(Special Provision)

New Section

All pavements, curbs, gutters, sidewalks, and other surfacing materials to be removed shall be sawcut where removals abut other pavement areas to remain.

The Contractor shall be responsible for ensuring that special precautions are undertaken so that no concrete or concrete by-products, or products and by-products used in the sawcut of asphalt or concrete, are discharged into any storm drain or surface water system.

In accordance with the Department of Ecology guidelines, wastewater from Portland Cement Concrete, masonry, and asphalt concrete cutting operations shall not be discharged to storm drainage systems or surface waters. Cutting operations increase the pH of wastewater; therefore filtering prior to discharge is not acceptable.

To thoroughly clean sawcuts where necessary, the Contractor may use high pressure water (high pressure water is considered greater than 1400 psi).

All wastewater shall be collected using a wet-dry vacuum or pumped into drums for disposal. Disposal of the waste liquid may be to soil or other porous surfaces away from storm drains and surface water, only if the Contractor collects and disposes of remaining sediment after water has filtered into soil or evaporated. Impervious surfaces contaminated with sediment and grit from cutting, planing or pulverizing operations shall be cleaned by sweepers to prevent contaminants from entering the storm drainage system or surface waters when it rains.

2-02.3(4) Removing and/or Resetting of Miscellaneous Items

(Special Provision)

New Section

The Contractor shall remove and/or reset miscellaneous items as described in the Plans and as necessary to satisfactorily complete the Work. The items requiring resetting shall be protected from damage during removal as far as is practical. If in the opinion of the Engineer an item requires replacement due to the Contractor's negligence it shall be replaced in kind at the Contractor's expense.

2-02.4 Measurement

(Special Provision)

Supplement

"Remove Asphalt Concrete Pavement" shall be per square yard regardless of the pavement thickness. Items to be included in the bid price shall include but not be limited to: sawcutting, removal, haul, and legal disposal of asphalt pavement, asphalt walkways, thickened edges, asphalt berms, and the like.

“Remove Cement Concrete Pavement” shall be per square yard regardless of the pavement thickness. Items to be included in the bid price shall include but not be limited to: sawcutting, removal, haul, and legal disposal of cement concrete pavements, driveways, and sidewalks.

2-02.5 Payment

(Special Provision)

Supplement

Structure Excavation shall be considered **incidental** to the Removal of Structures and Obstructions and no further compensation will be made.

All costs associated with sawcutting shall be considered **incidental** to the type of material to be removed or improvement to be installed. Collection of wasted water with vacuum system and pollution control shall be considered **incidental** to related Bid items which require sawcutting.

All costs for removing and resetting of miscellaneous items on or near the construction site shall be considered **incidental** to related Bid items.

Payment will be made for the following bid item(s):

“Remove Asphalt Concrete Pavement”, per square yard.

“Remove Cement Concrete Pavement”, per square yard.

“Removal of Structures and Obstructions”, per lump sum, shall be compensation for all other removals and items of work not specifically mentioned in or included as a separate pay item.

The contract bid price for the item(s) above, including all incidental work, shall be full compensation for all labor, material, tools, and equipment necessary to satisfactorily complete the Work as defined in the Standard Specifications and these Special Provisions.

2-03 ROADWAY EXCAVATION AND EMBANKMENT

2-03.1 Description

(Special Provision)

Supplement

For the purposes of this contract, Roadway Excavation Including Haul shall be all excavation required for roadway grading areas, new walkway areas, driveway approaches and shoulder grading (where excess materials exists on shoulder areas), in conformance with the Plans.

For this project, “Roadway Excavation Including Haul” shall include the bid item “Pavement Repair Excavation Including Haul”.

2-03.3 Construction Requirements

2-03.3(7)C Contractor-Provided Disposal Site

(Special Provision)

Supplement

No waste site has been provided by the City for the disposal of material and debris. The Contractor shall make all arrangements, at Contractor's expense, for the disposal of waste materials and shall protect the City from any and all damages arising therefrom.

2-03.4 Measurement

(Special Provision)

Supplement

"Roadway Excavation Incl. Haul" will be measured loose, in the haul truck by cubic yard by visual inspection and agreed upon by the Engineer and Contractor.

For this project, pavement and subgrade material excavated under the "Pavement Repair Excavation Incl. Haul" item shall be measured and included in the "Remove Asphalt Concrete Pavement" and "Roadway Excavation Incl. Haul" bid items, respectively.

2-03.5 Payment

(Special Provision)

Supplement

All costs in connection with hauling surplus materials to a disposal site will be considered **incidental** to related bid items.

Payment for "Roadway Excavation Incl. Haul", per cubic yard.

2-06 SUBGRADE PREPARATION

2-06.1 Subgrade Preparation

(Special provision)

Supplement

Subgrade preparation shall include preparing roadbeds, curbs, curbs and gutters, sidewalks, driveway approaches, driveways, or any other permanent hard surface improvement for base material or final surfacing.

2-06.3 Construction Requirements

(Special provision)

Supplement

The subgrade shall be shaped and maintained to drain at all times during construction, including temporary ditches, and modifications to drainage structures necessary to eliminate standing water on the subgrade.

Local traffic will be allowed on the subgrade during the period of subgrade exposure.

2-06.5 Payment

(Special provision)

Supplement

Compaction of the subgrade shall be considered **incidental** to related Bid items.

All costs for protection of the subgrade, including replacement of damaged or contaminated suitable material, shall be considered **incidental** to related Bid items.

DIVISION 3
PRODUCTION FROM QUARRY AND PIT SITES AND STOCKPILING

3-01 PRODUCTION FROM QUARRY AND PIT SITES

3-01.4 Contractor Furnished Material Sources

(Special Provision)

Supplement

If the source of materials provided by the Contractor necessitates hauling over roads other than City streets, the Contractor shall at his or her own expense make all arrangements for the use of haul routes.

**DIVISION 4
BASES**

This work also consists of roadway pavement repair, paved shoulders, minor widening, driveway approaches, thickened edges, and berms.

5-04.2 Materials

The grade of asphalt binder used in HMA shall be PG 58H-22.

5-04.3(3) Hot Mix Asphalt Pavers

Asphalt thickened edges may be constructed using a paving machine or may be hand formed, provided that the hand formed areas are of uniform height, width, and shape. For this project, a hand pulled extrusion box is an acceptable tool for forming thickened edges.

5-04.3(8)A Acceptance Sampling and Testing – HMA Mixture

For this project, the items “HMA Cl. __ PG __”, “HMA for __ Cl. __ PG __”, and “Commercial HMA” shall be measured as “HMA for Paving Cl. ½” PG 58H-22”.

The contract bid price above shall be full compensation for all costs for all labor, material, tools, incidental work, and equipment necessary to satisfactorily complete the Work as defined in the Standard Specifications and these Special Provisions.

DIVISION 7
DRAINAGE STRUCTURES, STORM SEWERS, SANITARY SEWERS, WATER MAINS, AND CONDUITS

7-00 GENERAL MATTERS

(Special Provision)

New Section

7-00.1 General

The Contractor is advised that the locations of various existing utilities including but not limited to: gas, water, telephone, cable service lines, and other obstructions are not necessarily shown on the Plans. Locations, if shown, are approximate and have been obtained from records and cannot be guaranteed accurate. The Contractor shall diligently check for interferences with existing utilities ahead of his or her work including exploration in advance of excavation. It will be the Contractor's responsibility to coordinate with franchise utilities so that services are maintained per City standards. This will include coordination and making necessary arrangements with service providers for the reconnection or relocation of service lines away from the proposed storm drainage system.

The Contractor is further alerted to the provisions of RCW 19.122 and his or her responsibilities by performing excavation required by the Contractor Documents and Standard Specifications.

Potholing

In general, the Contractor shall pothole ahead of excavation operations at locations indicated on the Plans or as approved by the Engineer, noting the depth, location, size and material of the underground utilities exposed. Any necessary design modifications resulting from potholing shall be returned to the Contractor within three (3) calendar days and shall constitute no basis for delay.

Potholing of existing utilities ahead of pipe installation shall be performed, at a minimum, at the following locations:

- Station 15+55 – gas main
- Station 15+58 – water main
- Station 15+71 – gas service
- Station 17+08 – water service
- Station 17+41 – water service
- Station 18+96 – gas service

Potholing of existing water service lines and service taps at the main shall be performed, at a minimum, at the following locations:

- Station 13+74 – house #6914
- Station 15+82 – house #6870
- Station 17+40 – house #6750
- Station 27+84 – house #6530
- Station 28+62 – house #6520
- Station 29+32 – house #6510

Potholing shall be done by hydro excavation, a.k.a. "vactoring", to minimize the risk of damage to existing utilities unless another method is discussed and agreed to with the Engineer.

Any utilities damaged during potholing shall be immediately reported to the Engineer and repairs made immediately as required by the Standard Specifications and these Special Provisions.

Records of the location, elevation, and dimensions of all utilities and improvements verified or discovered by potholing shall be submitted to the Engineer within two (2) working days after the completion of potholing in each area.

Upon completion of potholing in each area, potholes shall be immediately backfilled and compacted as required by the Standard Specifications and these Special Provisions or restored as directed by the Engineer.

Measurement

"Pothole Existing Utility" shall be measured per each. A single pothole shall be up to three feet in any horizontal direction, regardless of depth. For example, if a water meter and service tap are within three feet of each other, exposing both shall be measured as a single pothole.

Payment

Payment will be made for the following bid item(s):

"Pothole Existing Utility", per each.

The unit Contract price for "Pothole Existing Utility" shall be full pay for all work to hydro excavate and expose the utility, including but not limited to sawcutting, removing pavement, excavating, disposing of displaced material, and placing and removing temporary asphalt and steel plating. Backfilling and permanent asphalt restoration shall be paid under the items "Crushed Surfacing Top Course (or Base Course)" and "HMA Cl. 1/2" PG 58H-22", respectively.

7-01.4 Measurement

(Special Provision)

“2” Railroad Ballast” shall be measured per cubic yard.

7-01.5 Payment

(Special Provision)

Supplement

Structure Excavation Class B Including Haul for the installation and/or removal of underground pipes shall be considered **incidental** to and included in the pipe installed or removed.

Geotextile fabric shall be **incidental** to the Gravel Backfill for Drain item.

“2” Railroad Ballast”, per cubic yard.

7-04 STORM SEWERS

7-04.1 Description

(Special Provision)

Supplement

The Work also consists of storm drainpipe extensions and connections of pipes into catch basins.

7-04.2 Materials

(Special Provision)

Supplement

Ductile Iron (DI) Storm Sewer Pipe

9-30.1 and 9-30.2(1)

Ductile Iron Storm Sewer Pipe shall be Class 50 with rubber gasket joints.

7-04.3 Construction Requirements

(Special Provision)

Supplement

Connect Private Drain Lines

Private drains identified in the Plans for connection and those discovered during construction shall be excavated a sufficient distance to provide a point of connection with adequate cover as determined by the Engineer. Install a coupling or adapter on the existing pipe and connect new 4” or 6” PVC SDR 35 or 6” single wall corrugated polyethylene pipe as directed by the Engineer. Route and connect the new pipe and fittings to an approved discharge point, typically a new or existing catch basin, as directed by the Engineer. Backfill trenches and cover exposed pipe with Crushed Surfacing Top Course.

The unit contract price per linear foot for storm sewer pipe of the kind and size specified shall be full pay for furnishing, hauling, and assembling in place the completed installation including trenching, trench waste, coupling bands, fittings, elbows, bends, tees, and adjustment of inverts to catch basins and manholes for the completion of the installation to the required lines and grades. All costs for pavement removal and bedding and backfill material will be paid for under separate bid items.

Utility-related Clearing & Grubbing outside of shoulder widening limits shall be **incidental** to the utility.

Structure Excavation Class B Incl. Haul shall be **incidental** to the pipe being installed or removed.

Payment will be made for the following bid item(s):

“Ductile Iron Storm Sewer Pipe, ____ In. Diam.”, per linear foot.

“Connect Private Drain Lines”, by force account. Measurement by force account shall be full compensation for all labor, material, tools, and equipment necessary to satisfactorily complete the Work as defined in the Standard Specifications and these Special Provisions and as directed by the Engineer. To provide a common proposal for all bidders, the Contracting Agency has entered amounts in the proposal to become part of the Contractor’s total bid. Pavement removal, backfill material, and permanent pavement restoration shall be paid separately.

7-05 MANHOLES, INLETS, CATCH BASINS, AND DRYWELLS

7-05.1 Description

(Special Provision)

Supplement

The Work consists of furnishing and installing inlets, catch basins, and manholes of the type and size shown on the Plans in reasonably close conformity with the lines and grades shown on the Plans.

This Work shall also consist of replacing existing grates with solid lids, furnishing and installing new catch basin frames, grates, and solid lids, and replacing existing manhole ring and covers.

7-05.2 Materials

(Special Provision)

Supplement

Crushed Surfacing

9-03.9(3)

All new catch basin frames and grates or solid locking lids shall be the 18” x 24” size unless noted otherwise.

Concrete adjustment risers shall conform to the ASTM C-32, Grade MA.

7-05.3 Construction Requirements

(Special Provision)

Supplement

Bedding and backfill material for manholes, inlets, and catch basins shall be Crushed Surfacing Top Course (or Base Course).

New Catch Basin Adjustment to Grade

Newly installed drainage structures shall include at least one adjustment riser. If additional adjustment is required to achieve finished grade, the Contractor shall install a combination of 2", 4", 6", and/or 12" precast risers so that no more than three risers are used at any drainage structure.

Furnish and Install New Catch Basin Frame and Grate or Solid Lid

Where indicated on the Plans, the Contractor shall remove the existing frame and grate, furnish and install a new ductile iron frame and grate on the existing catch basin, and adjust the frame and grate to new finished grade. The removed catch basin frame and grate shall become the property of the City and shall be delivered to the City Public Works Shop.

Install New Sewer Manhole Ring and Cover

Where indicated on the Plans, the Contractor shall the remove the existing ring and cover, install a new ductile iron ring and cover on the existing manhole, and adjust the ring and cover to new finished grade. The City shall furnish the new ring and cover. The removed ring and cover shall become the property of the City and shall be delivered to the City Public Works Shop.

7-05.3(1) Adjusting Manholes and Catch Basins to Grade

(Special Provision)

Supplement

Jackhammer around the casting with a maximum clearance of twelve (12) inches. Following the removal of the asphalt and concrete around the structure, clean the castings and the inside of the structure, and remove all tack coat, asphalt, paper, and other debris. Remove failed, crushed, or defective brickwork down to solid full-width bricks. Provide and install new concrete brick or concrete riser sections, conforming to Section 9-12.2, to bring the frame to the proper finished grade and cross slope of the finished asphalt pavement. Set the casting on full-width bricks or risers, using shims to make final grade adjustment. Completely grout the inside and outside to fill any voids between riser bricks. Remove any wooden shims prior to final grout work. Place "HMA for Paving Cl. _____" around the casting to match into the adjacent finished pavement. Seal all asphalt joints. Compaction shall be done using a pneumatic or hydraulic 'pogo stick'.

Any utility structure lid, casting, cover, grate, or asphalt patch in the traveled way whose finished grade is higher or lower than the adjacent finished asphalt pavement, as measured by a six foot straight edge, by ¼-inch or more shall be readjusted by the Contractor at his or her own expense.

Utility castings shown on the drawings or designated by the Engineer for replacement shall be installed and adjusted to final grade in the above described manner.

7-05.4 Measurement

“Furnish and Install New Catch Basin Frame and _____” will be measured per each.

“Install New Sewer Manhole Ring and Cover” will be measured per each.

“Connection to Existing Catch Basin Type 2” will be measured per each.

“Shoring or Extra Excavation Class B” will be per lump sum.

7-05.5 Payment

(Special Provision)

Supplement

Utility-related Clearing & Grubbing outside of shoulder widening limits shall be **incidental** to the utility.

Structure Excavation Class B shall be considered **incidental** to and included in the price for the structure being installed.

Connection to drainage structures shall be considered **incidental** to the pipe or structure being installed except for existing type 2 catch basins.

All costs associated with temporarily plugging existing storm drainpipes so that new drainage structures can be installed shall be considered **incidental** to and included in the unit contract price for the type and size of structure installed.

All work necessary to intercept existing storm drain lines for the installation of catch basins, inlets, or manholes as shown on the Plans or as directed by the Engineer, shall be considered **incidental** to the type and size of drainage structure installed.

Removal and cleaning of pavement and tack from lids and grates shall be **incidental** to related Bid items.

Included in the cost for new drainage structures shall be furnishing, installing, and adjusting to final grade the frame and grate of the type specified.

A Concrete Inlet may be used in lieu of a Catch Basin Type 1, at the same unit price, if a Catch Basin Type 1 cannot be installed due to a conflict. The resulting change in quantities will not be grounds for renegotiating the unit price.

Payment will be made for the following bid item(s):

“Connection to Existing Catch Basin Type 2”, per each.

“Shoring or Extra Excavation Class B”, per lump sum.

“Furnish and Install New Catch Basin Frame and _____”, per each.

“Install New Sanitary Sewer Manhole Ring and Cover”, per each.

Payment will be made once for each casting, upon adjustment to final grade.

The contract bid price above, including all incidental work, shall be full compensation for all labor, material, tools, and equipment necessary to satisfactorily complete the Work as defined in the Standard Specifications and these Special Provisions.

7-07 CLEANING EXISTING DRAINAGE STRUCTURES

7-07.5 Payment

(Special Provision)

Supplement

Cleaning of storm drainage and sanitary sewer structures at project completion shall be measured and paid under the bid item "Erosion/Water Pollution Control".

7-08 GENERAL PIPE INSTALLATION REQUIREMENTS

7-08.2 Materials

(Special Provision)

Supplement

Crushed Surfacing

9-03.9(3)

7-08.3 Construction Requirements

7-08.3(1)A Trenches

(Special Provision)

Supplement

Pipe zone bedding and backfill shall be Crushed Surfacing Top Course.

Foundation material and trench backfill may be Crushed Surfacing Top Course or Base Course.

Material excavated shall not be used as backfill and shall be hauled away to an approved waste site.

Trench shall be excavated to a sufficient width to allow for pipe installation, compaction equipment, and shoring when necessary. Paving width shall be as shown on the City Standard Detail Trench Section W-3. No additional payment will be made for excavation and backfill of additional trench widths beyond the maximum trench width (nor for related quantities such as bedding, paving, imported backfill, rock excavation, etc.) unless extra trench width has been specifically directed by the Engineer.

All construction shall conform to these Specifications, to the lines, limits and grades shown on the drawings and as designated by the Engineer. Line and grade shall be provided by the Contractor.

Temporary HMA patching is required if the surface becomes difficult to maintain as determined by the Engineer.

7-08.3(1)B Shoring

(Special Provision)

Supplement

Shoring design shall be the responsibility of the Contractor. No implication of methods, means or materials is implied within the Plans.

7-08.3(1)C Bedding the Pipe

(Special Provision)

Supplement

Pipe zone bedding material shall be Crushed Surfacing Top Course (or Base Course).

If foundation material at the base of pipe excavation is unsuitable, it shall be removed and replaced per Section 2-03.3(14)F with Crushed Surfacing Top Course (or Base Course).

7-08.3(2)F Plugs and Connections

(Special Provision)

Supplement

New storm sewer pipe shall be connected to existing catch basins and manholes per Section 7-05.3(3).

7-08.3(3) Backfilling

(Special Provision)

Supplement

Backfill material shall be Crushed Surfacing Top Course (or Base Course).

Backfill shall be compacted to 95% maximum density.

7-08.5 Payment

(Special Provision)

Supplement

Trench excavation shall be considered **incidental** to and included in the unit contract price for pipe. Pipe bedding material, pipe backfill material, and structure backfill material will be paid for by the ton under a separate bid item.

Plugging existing storm sewer or culvert pipe shall be considered **incidental** to related Bid items.

Connection of new or existing pipes to a new drainage structure shall be considered **incidental** and included in the various unit bid prices for catch basins and concrete inlets.

7-12 VALVES FOR WATER MAINS

7-12.1 Description

Adjusting Valve Box to Grade

Existing and new water and gas valve boxes shall be adjusted to grade per the requirements of Section 7-05.3(1) herein.

7-12.4 Measurement

7-12.5 Payment

(Special Provision)

Supplement

“Adjust Valve Box”, per each.

The unit price per each for “Adjust Valve Box” shall be full compensation for furnishing all materials, installing, and adjusting the water or gas valve box to grade in accordance with the plans and details.

7-14 HYDRANTS

7-14.1 Description

(Special Provision)

Supplement

This Work shall also consist of removing existing fire hydrants.

7-14.2 Materials

(Special Provision)

Supplement

Pipe and Fittings

Unless otherwise indicated, all pipe and fittings shall be ductile iron in conformance with Sections 9-30.1(1) and 9-30.2(1) of the Standard Specifications, except that the thickness for other than restrained mechanical joint pipe shall be Standard Thickness Class 52. Pipe and fittings shall be double-thickness cement-mortar lined and seal coated with bituminous material conforming to ANSI A21.4 or AWWA C 104 and shall have exterior bituminous coating conforming to ANSI A21.4 or AWWA C 104. US Pipe Ductile Iron Tyton Pipe or approved equal will be accepted.

Pipe joints shall be push-on joints unless otherwise shown or required. The pipe manufacturer shall supply a sufficient quantity of a non-toxic vegetable soap lubricant for installing the pipe.

Mechanical joints shall conform to ANSI A21.11 or AWWA C111. Bolts for mechanical joints shall be Dresserloy or Cor-Ten high strength, low-alloy steel conforming to ASTM A242 and A558. Sigma Mechanical Joint Bolts or approved equal will be accepted.

In situations where a hydrant gate valve is to be installed on a sloped roadway, a MJxMJ adapter, Infact Foster Adapter, shall be used to keep gate valve plum with the tee.

Flanged joints shall conform to ANSI A21.10 or AWWA C110, or ANSI A21.12 or AWWA C115. Flanges shall be ductile iron. Gaskets for flanged joints shall be 1/8-inch thick, cloth-inserted rubber, conforming to applicable parts of ANSI B16.21 and AWWA C207. Gasket material shall be free from corrosive alkali or acid ingredients and suitable for use in potable water lines. Gaskets shall be one-piece, full-face with holes to pass bolts.

Mechanical joint long-pattern solid-sleeve cast iron fittings shall conform to ANSI A21.10 or AWWA C110. Solid sleeve minimum length shall be twelve (12) inches. Restrained joints shall conform to Section 9-30.2(6) of the Standard Specifications. For special water main connections

where blocking is not viable as determined by the Engineer, the Contractor may use mechanical joint restraints such as Romac Romagrip or approved equal. Coat all bolts and parts with coal tar epoxy.

Tapping sleeves for wet tapping new fire hydrants shall be Romac Industries SST III stainless steel tapping sleeve with stainless steel flange and stainless-steel nuts and bolts, or an approved equal.

Hydrants

Unless otherwise indicated on the plans, all hydrants shall be new. Hydrants shall conform to AWWA C502. Hydrants shall be break-flange or safety-top type. The inlet connection shall be mechanical joint. Nominal 5¼-inch compression type main valve opening with 6-inch bottom connections. Equip with two 2½-inch hose nozzles with American National Standard threads and one 4 ½ -inch pumper port, Storz Seattle style thread, model number HPHA 40-40-004/CAP, size 4.875-inch by 6-inch. Operating nut shall be 1½-inch National Standard Pentagon nut. The main valve shall be equipped with O-ring seals and shall open when turned counterclockwise. Acceptable hydrant models are Mueller Superior Centurion or approved equal.

Hydrant paint shall be Farwest #250 High Gloss White paint or approved equal.

7-14.3 Construction Requirements

7-14.3(1) Setting Hydrants

(Special Provision)

Supplement

Installation of hydrants shall conform to the provisions of AWWA C600. Locate hydrants to provide complete accessibility and to minimize the possibility of damage from vehicles or injury to pedestrians. A minimum three (3) foot radius unobstructed working area shall be provided around all hydrants.

Set hydrants plumb and nozzles parallel with, or at right angles, to the curb or roadway, with the pumper nozzle facing the curb or roadway. Set hydrant so that the safety flange is two (2) inches above finished grade and bolts can be removed.

If the hydrant lead is longer than one full length of pipe Field Lok gaskets shall be used.

Place concrete block on firm, level sub-base to assure uniform support. Carefully place hydrant on base block to prevent the base block from breaking. Jointing procedures shall conform to AWWA C600. Strapping lugs shall not be used. After hydrant is in place and connected to the pipeline, place temporary blocks to maintain the hydrant in a plumb position during subsequent work.

Place 1-1/2" washed rock and filter fabric around base block and hydrant bottom after hydrant has been blocked in place. Top of the washed rock shall not be less than six (6) inches above hydrant drain opening.

After all installation and testing is complete, the exposed portion of the hydrant shall be thoroughly cleaned and be painted two coats of paint.

7-14.3(7) Removing Existing Hydrants

(Special Provision)

New Section

Existing hydrants to be removed on existing water mains that will remain active shall be removed to the hydrant tee at the existing main. A water main shutdown will be required for this work. The hydrant tee shall be capped or plugged and completed with a permanent blocking. If the hydrant valve is not flanged to the existing tee connection, then the tee shall be cut out and the contractor shall install spools and sleeves in place of the removed pipe and fittings.

The Contractor shall provide three (3) weeks’ notice to the City when the water main shutdown is scheduled. The Contractor is to have both four (4) inch and six (6) inch flanged and mechanical joint caps and plugs onsite prior to shutting down the water system.

The City will notify affected residents in advance, conduct the shutdown and recharge the water main.

7-14.4 Measurement

“Fire Hydrant Assembly” will be measured per each fire hydrant assembly installed.

7-14.5 Payment

“Fire Hydrant Assembly”, per each.

The unit price per each for “Fire Hydrant Assembly” shall be full compensation for furnishing all labor, materials, tools, and equipment to remove the existing fire hydrant assembly and install the new fire hydrant assembly. This price includes but is not limited to clearing and grubbing, sawcutting, excavating, disposing of displaced material, main line tapping sleeve, 6-inch valve, valve box, pipe, vertical bends as required, thrust restraints, fire hydrant, pipe sterilization, dechlorination, pipe flushing, concrete bearing block, washed rock and filter fabric, miscellaneous parts and materials, testing, painting, temporary pavement patching, adjustment of valve box to finished grade, and clean up. The cost of the disassembly and removal of the existing fire hydrant, capping or plugging of old tee location, and concrete blocking shall be included in this bid item. Pavement removal, backfill material, permanent pavement restoration, and blue type 2 RPMs shall be paid separately. Supporting existing utilities to remove or install a fire hydrant shall be **incidental** to the fire hydrant bid item. Removal of existing storm pipe for hydrant removal and/or installation shall be **incidental** to the bid items “Removal of Structures & Obstructions”. Repair of storm pipe shall be paid using the appropriate storm pipe bid items.

7-15 SERVICE CONNECTIONS

7-15.1 General

(Special Provision)

Supplement

This work consists of exposing existing service connections prior to relocation, relocating water services and meters, installing meter resetters, and replacing water meter boxes with new water meter boxes furnished by the City and adjusting to finished grade.

7-15.2 Materials

(Special Provision)

Supplement

Repair bands shall be Romac SS1 or an approved equal.

7-15.3 Construction Requirements

(Special Provision)

Supplement

Backfill for relocated service connections and abandoned services shall be Crushed Surfacing Top Course.

Designated Service Replacements

The Contractor shall first hydro excavate and expose the service line on the City side of the meter so the Engineer may verify service line material and the Contractor may verify parts necessary for replacement.

The Contractor shall then hydro excavate and expose the existing direct tap or service saddle at the main to verify location and condition.

Install new service saddles at the water main with a tapping machine operated by experienced workers using tools with proper adapters for the size of the main being tapped. The Contractor shall thoroughly clean the area on the water main covered by the new saddle before installation. Do not place any service tap within two (2) feet of a pipe joint, bell, spigot, or another service tap. All services saddles tapped on an existing water main shall use a Romac double strap stainless steel saddle or approved equal.

Services with Unknown Material Types and Not Designated for Replacement

The Contractor shall first hydro excavate and expose the service line for the first three feet on the City side of the meter so the Engineer may verify service line material. Copper services in good condition will not be replaced.

If a galvanized iron or plastic service is discovered, the Contractor shall then excavate and expose the water main, direct tap or service saddle, and service line for three feet from the main. Galvanized iron services will be replaced. Full length plastic services in good condition will not be replaced. Services repaired with a section of plastic pipe will be replaced. Service taps and service saddles in poor condition will be removed and abandoned.

General Service Replacements

Each one (1) inch service shall have a new one (1) inch setter and a new water meter (meter to be provided by the City). For existing three-fourths ($\frac{3}{4}$) inch and five-eighths ($\frac{5}{8}$) inch services, the Contractor shall use a meter adapter to maintain the one (1) inch meter laying length.

Maintain existing services until the new service connections (completed up to the curb stop) are tested, disinfected, and flushed. Upon satisfactory waterline testing, disinfection, and flushing, complete the water meter installation and connection to the existing private service line.

In cases where the existing water service is located across an adjacent property, the new service will be installed in front of the served property. The Contractor shall pothole and locate the customer side of the service within the served property. After locating, the Contractor shall

install a new customer side service line from this point to the back of the new location of the meter such that no part of the water service is located on an adjacent property.

If PRVs are required, Contractor shall be responsible for adjusting individual PRVs after service connection has been completed. Pressures at the property shall be set after installation and calibration of PRVs on the main.

The preferred method for abandoning existing taps is to install a Romac SS1 repair band. The Contractor shall thoroughly clean the area on the water main covered by the abandonment sleeve before installation.

Water main shutdowns to the same group of residents shall be minimized. Due to limited staffing within the water department: no more than thirty-five (35) homes may be on a single shutdown, no more than two (2) shutdowns are allowed per week, shutdowns are not allowed on Mondays and Fridays, and shutdowns require two to three (2-3) weeks' notice. The Contractor may have multiple service taps exposed for replacement and abandonment on a single water main shutdown for more than 24 hours (but not more than one (1) night). A service covered by a steel sheet is considered "exposed".

Steel sheets shall not be allowed to be placed within an arterial lane for more than one (1) night, shall be pinned, and have temporary asphalt placed around the edges to create a smooth transition onto the sheet. Steel sheets shall not be left in any location over weekends and holidays. The Contractor shall provide a sufficient number of steel plates, traffic control, and warning signs to ensure the openings are covered and public safety is well addressed. Steel plates shall be orange, have a non-skid surface, be planar, match the roadway surface, edges must be perpendicular to the direction of travel, and be rammed with asphalt all the way around the edges to ensure no movement or rocking occurs when driven over by vehicles and to provide a smooth transition from the road to the sheet.

While trench details for water services show open cuts, the City will allow long services to be bored if the Contractor chooses to do so. If the Contractor elects to bore long services, the Contractor will be required to pothole prior to boring. The Contractor is responsible for verifying underground utilities, avoiding conflicts or other concerns, and repairing any damaged utilities at the Contractor's expense. The City is not responsible for any damage caused by the Contractor's boring operations. All other provisions of the specifications shall apply.

The minimum depth of cover to the installed water service connection shall be thirty (30) inches from the finished grade.

In landscaped areas set new water meter boxes on firm, compacted gravel backfill and adjust to finished grade. In traffic areas set new meter boxes on concrete blocks that bear on compacted gravel. The meter dial must be centered under the reading lid. Boxes must be perpendicular to the street.

7-15.4 Measurement

(Special Provision)

Supplement

"Adjust Water Meter Box" will be measured per each.

“Install New Water Meter Box” will be measured per each installation that is not part of a water service relocation.

“Installation/Relocation of 1 In. Water Service and Meter” will be measured per each water service installed.

7-15.5 Payment

(Special Provision)

Supplement

Excavation, bricks for adjustment, backfill, and installation of a meter resetter furnished by the City shall be considered **incidental** to Bid items for water meter boxes.

Excavation and raising or lowering of an existing water service to avoid a conflict with a new utility shall be **incidental** to related Bid items. If an existing service cannot be adjusted, it shall be replaced and paid for separately. Backfilling and permanent asphalt restoration shall be paid separately.

Payment will be made for the following bid item(s):

“Adjust Water Meter Box”, per each.

“Install New Water Meter Box”, per each.

The unit price for “Adjust Water Meter Box” and “Install New Water Meter Box” shall be full compensation for all Work to adjust an existing water meter box or install and adjust a new water meter box to finished grade and to install a meter resetter.

“Installation/Relocation of 1 In. Water Service and Meter”, per each.

The unit Contract price for “Installation/Relocation of 1 In. Water Service and Meter” shall be full pay for all Work to replace the service connection complete and operational, including but not limited to clearing and grubbing, excavating and/or boring, disposing of displaced material, providing a temporary water service if necessary, removing the existing water service pipe, placing and removing temporary asphalt and steel plating, assessing the condition of the existing service, tapping the main, installing the new City-supplied water meter and water meter box out of the paved shoulder in a location directed by the Engineer, furnishing and installing all pipe, fittings, setters and adapters, saddles, repair bands, temporary and permanent valves, appurtenances, miscellaneous parts and materials, testing, flushing, and disinfecting the service connection, connecting to the existing customer service line, and adjustment of individual PRVs if required. Pavement removal, backfilling, and permanent asphalt restoration shall be paid separately. Removal and/or abandonment of existing services is considered **incidental** to this Bid item. Removal of existing water meters and meter boxes is considered **incidental** to this Bid item. No additional payment shall be made for services which are bored at the Contractor’s option.

**DIVISION 8
MISCELLANEOUS CONSTRUCTION**

8-01 EROSION CONTROL AND WATER POLLUTION CONTROL

8-01.1 Description

(Special Provision)

Supplement

The Contractor shall install and maintain all temporary and permanent erosion control measures and Best Management Practices (BMP's) in accordance with the Plans, Standard Specifications, Special Provisions, permit conditions, or as directed by the Engineer prior to clearing, grubbing, or grading or as necessary as clearing and grading progress. Such measures shall include, but are not necessarily limited to:

- Erosion and water pollution control for stockpiled materials
- Straw bale check dams
- Straw mulch, netting, and tackifier
- Temporary construction entrance/exit
- Inlet protection on existing and proposed drainage structures
- Reinforced silt fencing
- Plastic covering
- Temporary HMA curb
- Disposal of sediments and materials
- Maintenance of BMPs including in the event of emergencies and as weather and field conditions dictate; and also including installation of additional BMPs which may become required as field and weather conditions evolve.
- Street sweeping and cleaning
- All materials, tools, and equipment necessary to meet these requirements

All disturbed areas shall be hydroseeded except as are designated for edge restoration or roadside restoration. The seeding may be accomplished by approved hand methods when impractical to perform by hydroseeding. The Contractor shall submit the proposed plan for hand seeding to the Engineer for approval five days prior to any seeding.

Water

The Contractor shall make, at the Contractor's expense, whatever arrangements may be necessary to ensure an adequate supply of water required for erosion control. The Contractor shall also furnish all necessary hose, equipment, attachments, and accessories for the adequate irrigation of planted areas as may be required to complete the Work as specified.

8-01.3 Construction Requirements

8-01.3(8) Street Cleaning

(Special Provision)

Supplement

The Contractor shall be responsible for controlling dust and mud within the project. All streets used by the Contractor during the execution of the Work under this contract shall be maintained

in a clean condition. Any damage caused by dust and/or mud shall be the sole responsibility of the Contractor. In no case shall sediment-laden water be allowed to enter drainage facilities without prior filtration or sedimentation.

The roadway shall be swept daily and as needed. Flushing will not be permitted.

8-01.3(9)D Inlet Protection

(Special Provision)

Supplement

Inlet protection can be in the form of internal devices and shall be installed prior to clearing, grubbing or earthwork activities. Catch Basin Inserts shall be installed on all existing and new catch basins that are located within the project.

Catch Basin Inserts

Catch basin inserts shall be installed at all catch basins within project limits and those immediately downstream of the project site that could possibly receive sediment laden runoff from the site. They shall be installed and meet the requirements of the detail in the Plans. Simply placing a piece of geotextile under the catch basin grate is not acceptable.

Catch basin inserts shall be installed, maintained, inspected, and removed per the Standard Specifications and as recommended by the manufacturer. Pre-approved manufactured products include:

8-01.3(16) Removal

(Special Provision)

Supplement

Removing Erosion / Water Pollution Control BMPs

The Contractor shall removal all Temporary Erosion / Water Pollution Control BMPs within twenty (20) days after final slope stabilization, landscape restoration, or after the BMPs are no longer needed. Trapped sediment shall be removed or stabilized on site.

8-01.3(17) Suspension of Work

(Special Provision)

New Section

If at any time during the life of this Contract it becomes necessary, or the Contractor elects to suspend work due to weather conditions, material delivery schedules, or other constraints, it shall be the Contractor's obligation to meet the following requirements:

- The Contractor shall remain obligated to meet the Temporary Water Pollution / Erosion Control requirements of the Plans during any suspension of work.
- The Contractor shall remain obligated to meet the Temporary Traffic Control (both vehicular and pedestrian) requirements of the Plans during any suspension of work.

- The Contractor shall maintain vigilance and maintain a safe project area free of hazards to public safety and shall remedy all hazardous situations immediately.

8-01.4 Measurement

(Special Provision)

Supplement

“Erosion / Water Pollution Control” shall be by force account.

“Inlet Protection” will be measured per each for each initial installation at a drainage structure.

Relocation and/or replacement of damaged protection devices will not be measured.

8-01.5 Payment

(Special Provision)

Supplement

All costs for supplying water shall be **incidental** to other Bid items.

Roadway sweeping and cleaning shall be considered **incidental** to other Bid items.

Payment will be made for the following bid item(s):

“Inlet Protection”, per each.

No additional compensation shall be awarded for reuse or relocation of “Inlet Protection”.

Sediment removal from and maintenance of erosion control devices will be paid by force account under the item “Erosion / Water Pollution Control”. Measurement by force account shall be full compensation for all labor, material, tools, and equipment necessary to satisfactorily complete the Work as defined in the Standard Specifications and these Special Provisions. To provide a common proposal for all bidders, the Contracting Agency has entered an amount in the proposal to become part of the Contractor’s total bid.

8-02 ROADSIDE RESTORATION

8-02.1 Description

(Special Provision)

Supplement

The Work shall consist of placing Crushed Surfacing Top Course, Topsoil Type C, and Bark or Wood Chip Mulch, hereinafter referred to as “restoration materials”, along finished edges of paved areas.

8-02.2 Materials

(Special Provision)

Supplement

Crushed Surfacing

9-03.9(3)

8-02.3 Construction Requirements

(Special Provision)

Supplement

Remove all construction debris prior to placing restoration materials.

Place restoration materials according to the Plans or as directed by the Engineer.

Crushed Surfacing Top Course shall be compacted in accordance with Section 4-04.3(11).

8-02.3(17) Property Restoration

(Special Provision)

New Section

Roadside planting for Property Restoration shall consist of fine grading adjacent landscaped areas, extra seeding, or sod installation, new plant material, slope restorations, and other landscape restoration work not currently identified on the Plans, as directed by the Engineer.

The Contractor is specifically reminded that unnecessary damage caused beyond the limits of clearing or construction shall be repaired in like or better condition at the Contractor's sole expense.

8-02.4 Measurement

(Special Provision)

Supplement

"Property Restoration" shall be by force account.

8-02.5 Payment

(Special Provision)

Supplement

"Crushed Surfacing Top Course (or Base Course)", per ton.

Topsoil Type C and Bark or Wood Chip Mulch shall be paid for under the "Property Restoration" bid item.

"Property Restoration", by force account, shall be full compensation for all labor, material, tools, and equipment necessary to satisfactorily complete the Work as identified in the Standard Specifications and these Special Provisions. To provide a common proposal for all bidders, the Contracting Agency has entered an amount in the proposal to become part of the Contractor's total bid.

8-09 RAISED PAVEMENT MARKERS

8-09.3 Construction Requirements

8-09.3(8) Removing Raised Pavement Markers

(Special Provision)

New Section

Existing raised pavement markers shall be removed at all locations to receive asphalt overlay or as indicated in the Plans.

Removal of raised pavement markers shall be conducted using such methods to prevent damage to the remaining pavement.

Damaged pavement shall be replaced at the Contractor's expense.

8-09.4 Measurement

(Special Provision)

Supplement

Markers shall be measured per each for each type of marker furnished and set in place.

8-09.5 Payment

(Special Provision)

Supplement

All costs for removing raised pavement markers including removing, loading, hauling, and disposing of the removed markers shall be considered **incidental** to related Bid items and no additional payments will be made.

Payment will be made for the following Bid items:

“Raised Pavement Marker Type 1”, per each.

“Raised Pavement Marker Type 2”, per each.

8-21 PERMANENT SIGNING

8-21.2 Materials

(Special Provision)

Supplement

Crushed Surfacing

9-03.9(3)

8-21.3 Construction Requirements

(Special Provision)

Supplement

The Contractor shall coordinate sign locations with the Engineer for field adjustments or location direction verification.

8-22 PAVEMENT MARKINGS

8-22.3 Construction Requirements

8-22.3(6) Removal of Pavement Markings

(Special Provision)

Supplement

Delete this section and replace it with the following:

Existing pavement markings including paint lines, plastic stop bars, traffic letters, and traffic arrows shall be removed at all locations to receive asphalt overlay or as indicated in the Plans.

Removal of existing pavement markings shall be conducted using such methods to prevent damage to the remaining pavement. Painted and thermoplastic pavement markings shall be removed by sandblasting, grinding, or other method approved by the Engineer. The use of chemicals that may be harmful to the pavement will not be allowed.

Damaged pavement shall be replaced at the Contractor's expense.

8-22.4 Measurement

(Special Provision)

Supplement

“Paint Line, 4 In. White” will be measured by the linear foot of two coats of applied paint.

“Plastic Line, 12 In. White” will be measured by the linear foot.

8-22.5 Payment

(Special Provision)

Supplement

All costs for removing pavement markings including removing, loading, hauling, and disposing of the removed material shall be considered **incidental** to related Bid items.

Payment will be made for the following Bid items:

“Paint Line, 4 In. White”, per linear foot.

“Plastic Line, 12 In. White”, per linear foot.

8-23 TEMPORARY PAVEMENT MARKINGS

8-23.3 Construction Requirements

(Special Provision)

Supplement

Temporary pavement markings shall be installed wherever existing markings are removed or obliterated by Contractor’s construction activities and shall remain in place until new permanent pavement markings are installed. Temporary pavement markings shall include centerline, stop bars, crosswalks, and turn arrows.

8-23.5 Payment

(Special Provision)

Supplement

All costs associated with furnishing, installing and removing Temporary Pavement Markings shall be considered **incidental** to related Bid items. Flagging operations required during installation and removal of the temporary markings will be paid under the bid item “Traffic Control Labor”.

8-26 EDGE RESTORATION

8-26.1 Description

The Work shall consist of placing Crushed Surfacing Top Course, Topsoil, or Bark Mulch along the finished edges of paved areas.

8-26.2 Materials

Crushed Surfacing Top Course shall meet the requirements of Section 9-03.9(3) Crushed Surfacing of the Standard Specifications.

Bark Mulch shall meet the requirements of Section 9-14.4(3) Bark or Wood Chips of the Standard Specifications.

Topsoil shall meet the requirements of Section 9-14.1(3).

8-26.3 Construction Requirements

Edge restoration shall be completed in accordance with the details shown on the Plans. Crushed Surfacing Top Course shall be compacted in accordance with Section 4-04.3(11) Shoulder Ballast of the Standard Specifications.

8-26.5 Payment

Payment will be made for the following bid item(s):

Crushed Surfacing Top Course shall be paid for under the bid item "Crushed Surfacing Top Course (or Base Course)".

Bark Mulch and Topsoil shall be paid for under the force account bid item "Property Restoration".

Washington State Department of Labor and Industries
Policy Statement
(Regarding the Production of "Standard" or "Non-standard" Items)

Below is the department's (State L&I's) list of criteria to be used in determining whether a prefabricated item is "standard" or "non-standard". For items not appearing on WSDOT's predetermined list, these criteria shall be used by the Contractor (and the Contractor's subcontractors, agents to subcontractors, suppliers, manufacturers, and fabricators) to determine coverage under RCW 39.12. The production, in the State of Washington, of non-standard items is covered by RCW 39.12, and the production of standard items is not. The production of any item outside the State of Washington is not covered by RCW 39.12.

1. Is the item fabricated for a public works project? If not, it is not subject to RCW 39.12. If it is, go to question 2.
2. Is the item fabricated on the public works jobsite? If it is, the work is covered under RCW 39.12. If not, go to question 3.
3. Is the item fabricated in an assembly/fabrication plant set up for, and dedicated primarily to, the public works project? If it is, the work is covered by RCW 39.12. If not, go to question 4.
4. Does the item require any assembly, cutting, modification or other fabrication by the supplier? If not, the work is not covered by RCW 39.12. If yes, go to question 5.
5. Is the prefabricated item intended for the public works project typically an inventory item which could reasonably be sold on the general market? If not, the work is covered by RCW 39.12. If yes, go to question 6.
6. Does the specific prefabricated item, generally defined as standard, have any unusual characteristics such as shape, type of material, strength requirements, finish, etc? If yes, the work is covered under RCW 39.12.

Any firm with questions regarding the policy, WSDOT's Predetermined List, or for determinations of covered and non-covered workers shall be directed to State L&I at (360) 902-5330.

It is the manufacturer of the prefabricated product to verify that the correct county wage rates are applied to work they perform.

(The definition of "locality" in RCW [39.12.010](#)(2) contains the phrase "wherein the physical work is being performed." The department interprets this phrase to mean the actual work site.

(Regarding Production and Delivery of Gravel, Concrete, Asphalt, etc.)

WAC 296-127-018 Agency filings affecting this section

Coverage and exemptions of workers involved in the production and delivery of gravel, concrete, asphalt, or similar materials.

(1) The materials covered under this section include but are not limited to: Sand, gravel, crushed rock, concrete, asphalt, or other similar materials.

(2) All workers, regardless of by whom employed, are subject to the provisions of chapter 39.12 RCW when they perform any or all of the following functions:

(a) They deliver or discharge any of the above-listed materials to a public works project site:

(i) At one or more point(s) directly upon the location where the material will be incorporated into the project; or

(ii) At multiple points at the project; or

(iii) Adjacent to the location and coordinated with the incorporation of those materials.

(b) They wait at or near a public works project site to perform any tasks subject to this section of the rule.

(c) They remove any materials from a public works construction site pursuant to contract requirements or specifications (e.g., excavated materials, materials from demolished structures, clean-up materials, etc.).

(d) They work in a materials production facility (e.g., batch plant, borrow pit, rock quarry, etc.) which is established for a public works project for the specific, but not necessarily exclusive, purpose of supplying materials for the project.

(e) They deliver concrete to a public works site regardless of the method of incorporation.

(f) They assist or participate in the incorporation of any materials into the public works project.

(3) All travel time that relates to the work covered under subsection (2) of this section requires the payment of prevailing wages. Travel time includes time spent waiting to load, loading, transporting, waiting to unload, and delivering materials. Travel time would include all time spent in travel in support of a public works project whether the vehicle is empty or full. For example, travel time spent returning to a supply source to obtain another load of material for use on a public works site or returning to the public works site to obtain another load of excavated material is time spent in travel that is subject to prevailing wage. Travel to a supply source, including travel from a public works site, to obtain materials for use on a private project would not be travel subject to the prevailing wage.

(4) Workers are not subject to the provisions of chapter 39.12 RCW when they deliver materials to a stockpile.

(a) A "stockpile" is defined as materials delivered to a pile located away from the site of incorporation such that the stockpiled materials must be physically moved from the stockpile and transported to another location on the project site in order to be incorporated into the project.

(b) A stockpile does not include any of the functions described in subsection (2)(a) through (f) of this section; nor does a stockpile include materials delivered or distributed to multiple locations upon the project site; nor does a stockpile include materials dumped at the place of incorporation, or adjacent to the location and coordinated with the incorporation.

(5) The applicable prevailing wage rate shall be determined by the locality in which the work is performed. Workers subject to subsection (2)(d) of this section, who produce such materials at an off-site facility shall be paid the applicable prevailing wage rates for the county in which the off-site facility is located. Workers subject to subsection (2) of this section, who deliver such materials to a public works project site shall be paid the applicable prevailing wage rates for the county in which the public works project is located.

Overtime Codes

Overtime calculations are based on the hourly rate actually paid to the worker. On public works projects, the hourly rate must be not less than the prevailing rate of wage minus the hourly rate of the cost of fringe benefits actually provided for the worker.

1. ALL HOURS WORKED IN EXCESS OF EIGHT (8) HOURS PER DAY OR FORTY (40) HOURS PER WEEK SHALL BE PAID AT ONE AND ONE-HALF TIMES THE HOURLY RATE OF WAGE.

All other overtime hours and all hours worked on Sundays and holidays shall be paid at double the hourly rate of wage.

I. The First eight (8) hours worked on Saturdays shall be paid at one and one-half times the hourly rate of wage. All hours worked in excess of eight (8) per day on Saturdays shall be paid at double the hourly rate of wage. All hours worked on Sundays and holidays shall be paid at double the hourly rate of wage.

4. J. The first eight (8) hours worked on a Saturday shall be paid at one and one-half times the hourly rate of wage.
