This addendum delays the submittal deadline by one (1) week. The revised submittal deadline is June 14<sup>th</sup>, 2023. All bidders must acknowledge their receipt of this Addendum on the Bid Form, Page A-5 of the Bidding Requirements.

## **QUESTIONS & ANSWERS**

Log	Question	Answer
1	Will the City allow NTP to happen very late this year or very early next year? CIPP contractors are very busy and we have seen a decline of how many bidders are on jobs. The City may see better numbers with a more fluid schedule?	In an effort to provide additional contractor flexibility, modifications to the notice to proceed issue timeline have been made. The City does not intend to delay construction further than provided in the revised project timeline. Please see modifications to contract documents 1.02 below. Working days will not begin until commencement of construction activities, or date indicated on the Full NTP, whichever is earliest.
2	The specs state we need to have an active business license by bid submittal. Would the City be able to extend needing to have an active license until the Award date?	No. Bidders must have a current certificate of registration in the state of Washington per 18.27 RCW at the time of bid submittal to be eligible bidders. An additional week has been provided to meet this eligibility as a result of this addendum.

Limited Notice to Proceed allowing submittals, RFI's, and permit applications will be provided within 30 calendar days after contract award. Working days will not commence at this time.  3. A Pre-Construction meeting will be scheduled after bid award.  4. Full Notice to Proceed will be issued within 90 calendar days after contract award. Construction shall start within 10 calendar days of the Full Notice to Proceed.  5. Provide 2 weeks advance notice prior to accessing or working within private properties.  6. Work requiring traffic control or MH access within 200' of the entrance/exit of schools must be completed during the Mercer Island School District scheduled breaks.
