Re: 2021 Water System Improvements Project Construction Notification

Dear Island Resident:

Construction of the 2021 Water System Improvements Project is ready to start soon. The City Council, at their April 6, 2021 council meeting, awarded the project to Pacific Civil & Infrastructure (PCI), Inc. The construction is anticipated to start at the end of April and be completed by end of August 2021.

The general scope of work for this project includes the following water system improvements:

- Replace, upsize, and install approximately 2,600 linear feet of water main;
- Replace approximately 32 water services and 8 fire hydrants;
- Construct 8 water main connections; and
- Roadway restoration

The project will take place in the following areas, as shown in dark-grey shade on the map on the back:

- > 82nd Ave SE, from SE 24th to north dead end street;
- > 81st Ave SE, from SE 24th St to N Mercer Way; and
- SE 24th St, from 80th to 82nd Ave SE

Water main shutdowns will be required to install and abandon water mains and fire hydrants, and to reconnect water services. Advance notices will be provided to affected residences prior to each shutdown.

Residents west of 81st Ave SE are receiving this notice because your access via SE 24th St and 81st Ave SE may be impacted during construction. PCI will maintain one-lane traffic in their work areas. Short duration street closures may occur when trenching across roadways. Traffic control will be provided by PCI.

Like all utility construction, disruptions to neighbors within project boundaries are expected. Your cooperation and patience throughout the duration of this project will be much appreciated.

This letter also serves as a heads up to you that Puget Sound Energy (PSE) will be relocating approximately 150 feet of gas main on SE 24th St between 80th and 81st Ave SE on the week of April 19th. They are conducting this work to accommodate for our new water main alignment on SE 24th St.
